

**Section 19 of the LTA Subs 2, 3 & 4 relating to the licences of compulsory in patients**

A person who has possession of the driver licence of a person referred to in subsection (1) must, on the request of the person in charge of the hospital at which the holder is an inpatient, deliver the licence to the person in charge of the hospital; and the person in charge must forward the licence to the Director of Area Mental Health Services.... etc

**Section 28 of the LTA which requires a PDL to be in a prescribed form and must include a signature of the holder.**

Should be in a form described in the Rules and if in a physical format then as with CI 62 of the DL Rule must have physical characteristics that comply with International Standards Organisation 7810: Identification Cards—Physical Characteristics: 1995, and if in a digital format must conform with guidelines for the design format and data content of the International Standard for mobile driver licences (ISO 18013-5).

**Section 30 Driver licences are property of Agency and are to be surrendered in certain circumstances**

Section 9(2)(g)(i)

**Section 31 (d) where it is an offence where a person fails to surrender or return his or her driver licence to the Agency or a person appointed by the Agency etc.,**

**Section 89 (1) and (3) concerns sending a demerit warning notice in writing.**

Section 9(2)(g)(i)

**Section 90 (2) concerns the serving of a suspension notice, but does not specifically provide for digital notification, including by way of an app. (See section 91B (1) (e) for precedent.**

**Section 91G(5) concerns the Agency replacing a photographic driver licence and sending it to by ordinary post to the defendant's address recorded on the national register maintained under s199.**

Section 9(2)(g)(i)

**Section 91(H) (4) similarly concerns the photographic driver licence being sent by ordinary post to the defendant's address recorded on the national register maintained under section 199, Section 9(2)(g)(i)**

**Section 95(2) concerns 28 day licence suspensions and the requirement for individuals to surrender their licence to an officer at the roadside.**

Section 9(2)(g)(i)

**Section 105(8) and (8)(A) again concerns the surrender of a driver licence. Section 9(2)(g)(i)**

**Section 199 concerns the Agency's responsibility to maintain the DL Register, including the data to be held in it.**

Section 9(2)(g)(i)

**Section 237 of the LTA concerns the need for an individual to 'make application' and pay a fee in order to access information held about themselves.**

Section 9(2)(g)(i)

Clause 12 of the DL Rule concerns images on licences and the requirement for an Agent to capture a DL image and signature.

Clauses 62 and 63 of the DL Rule concerns the physical format of a driver licence.
