Please refer to the attached Appendix for the information you have requested. Some information has been withheld under the following sections of the Act:

• 6(c) as making available that information would be likely to prejudice the maintenance of the law including the prevention, investigation, and detection of offences, and the right to a fair trial;

- 9(2)(a) to protect the privacy of natural persons;
- 9(2)(g)(ii) maintain the effective conduct of public affairs through the protection of such Ministers, members of organisations, officers, and employees from improper pressure or harassment.

Please note that some parts of the release have been blacked out and not withheld under any sections of the Act, as it contains personal information that has been removed from the training materials.

We have considered whether withholding private information is outweighed by other considerations which render it desirable, in the public interest, to make that information available, in accordance with section 9(1) of the Act, however, it is our opinion that such grounds do not exist.
