Official Information Act Request – Projects employing regulated gene bio technologies

Further to my letter of 3 June 2022, I advise that AgResearch is able to release the list of projects which we have identified were conducted during August 2019 to August 2021 utilising approvals under sections 38 to 42 of the Hazardous Substances and New Organisms Act, and which were in the biotechnology field. As we have needed to make some enquiry of staff in order to generate the list, please be aware that this list represents our understanding of the projects utilising those approvals during that time period, but may have unintended errors or omissions. - 2. Genetically modified organisms already held in AgResearch's containment facilities are used;
- 3. There is genetic modification of organisms, such as E. coli, for use as research tools during the projects; and
- 4. There is genetic modification of organisms where the modified organism is the goal of the projects.
