In a letter dated 8 August 2019, the Cabinet Office withheld the information that you requested under section 9(2)(f)(ii) of the OIA to maintain the constitutional conventions for the time being which protect collective ministerial and individual ministerial responsibility.

Following an investigation by the Ombudsman, I have reconsidered our original decision.

Please find **enclosed** copies of the agendas for the Cabinet meetings from the first 100 Days of the current Government, with some information withheld under section 9(2)(f)(ii) of the Act.

You have the right to ask the Ombudsman to investigate and review my decision under section 28(3) of the Act.
