Dear Ms Morse

I refer to your request of 10 June 2020, under the Official Information Act 1982 (OIA), for the following:

Please provide any information about the NZ Navy's training exercise at Kauri Point from 12-15 June 2020 including information relating to scenarios involving "a crowd of protesters".

Enclosed are a Royal New Zealand Navy Office of Fleet Operational Readiness Minute, and a message sent out to all Navy personnel by the Maritime Component Commander (MCC), Commodore Mathew Williams, on 15 June 2020. The enclosed Minute instructs the execution of an exercise as part of a 'Work Up' for HMNZS *Otago*, testing the reactions of the Ship and her crew in several challenging scenarios. Please note the following Defence Force acronyms used in the Minute: Defence Munitions Management Group (DMMG); Fleet Warfare Officer (FWO); Maritime Operational Evaluation Team (MOET); in accordance with (IAW); Team Leader (TL); Operational Risk Management (ORM); Commanding Officer (CO); HMNZS Matataua (MAT); In Charge (IC); Recruit Training School (RTS); Basic Common Training (BCT); Damage Control (DC); Fleet Warfare Assistant (FWA); in coordination with (ICW); Financial Services Executive Officer (FSXO).

Where indicated, information relating to operational capabilities is withheld in accordance with section 6(a) of the OIA, where its release would likely prejudice the security or defence of New Zealand. Some names and contact details are withheld in accordance with sections 9(2)(a) and 9(2)(k) of the OIA, to protect individual privacy and avoid malicious or inappropriate use of staff information, such as phishing, scams or unsolicited advertising. Some financial cost-centre details are also withheld in accordance with section 9(2)(k), to prevent the disclosure or use of official information for improper gain or improper advantage.

You have the right, under section 28(3) of the OIA, to ask an Ombudsman to review this response to your request.
