## Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) on 23 August 2020 for:

"Concerning the following article

It further states, "I said to the agent, place the order, and you have got my word I will pay for them, if the Government doesn't," Secondly the article also states 7 plane loads of PPE gear was coming.

Would you please clarify:

- 1. Did the Government pay for the 50 ventilators?
- 2. Did the Government purchase all or a portion of the PPE gear shipped in by the philanthropists mentioned in the article?
- 3. If the answer is "yes" to questions (1) or (2), then please provide details as to the amounts paid and other information that can be disclosed about these transactions."

I will respond to each part of your request in turn.

1. Did the Government pay for the 50 ventilators?

The Ministry of Health (the Ministry) did not purchase any ventilators from the group mentioned in the article.

2. Did the Government purchase all or a portion of the PPE gear shipped in by the philanthropists mentioned in the article?

The Ministry purchased the personal protective equipment (PPE) mentioned in the article from Zuru and the Warehouse Group. The group undertook their purchases of PPE in late March/early April, with the first planes landing on 5 April 2020. The products were secured by these groups and sold back to the Ministry at cost.

3. If the answer is "yes" to questions (1) or (2), then please provide details as to the amounts paid and other information that can be disclosed about these transactions.

The total unit cost to the Ministry, excluding freight was approximately \$34 million (excluding GST). As requested, the breakdown of these items is listed in the table below.
