Official Information Act 1982 Request - DOIA 2021- 1546

We refer to your request under the Official Information Act 1982 ("Act") dated 18 February 2021.

You have requested all information provided to the Registrar of Incorporated Societies which was considered to determine that The Society for the Prevention of Cruelty to Animals Auckland Incorporated (222889) should be dissolved.

We **enclose** a copy of the information you have requested with redactions on one of the documents, withholding such information in order to protect the privacy of an individual pursuant to section 9(2)(a) of the Act.

We have withheld the below information on the following grounds:

(a) All internal memoranda, documents and emails between the Registrar, Compliance, and processing teams and the solicitors from the Companies Office regarding legal advice provided to the Registrar in dissolving the above mentioned society as withholding this information is necessary to maintain legal professional privilege pursuant to section 9(2)(h) of the Act.

In accordance with section 19(b) of the Act, you have the right, by way of complaint under section 28(3) of the Act to the Ombudsman to seek investigation and review of the refusal.

STATUTORY DECLARATION IN SUPPORT OF REGISTRATION

I, Andrea Leigh Midgen, of Auckland, Chief Executive Officer, do solemnly and sincerely declare that:

- I am the Chief Executive Officer at the Royal Society for the Prevention of Cruelty to Animals
 Incorporated (RNZSPCA). I have held the position of Chief Executive Officer since 2017. I am
 duly authorised to make this statutory declaration on behalf of RNZSPCA.
- RNZSPCA is an incorporated society pursuant to the Incorporated Societies Act 1908
 (incorporation number 218546) and a registered charity under the Charities Act 2005 (CC22705).
- 3. The facts set out in this Statutory Declaration are known to me personally or have been provided based on diligent enquiry. To the best of my knowledge and belief, these are true and correct.

- On 17 June 2017, the Member Societies and Branches of the RNZSPCA adopted a new constitution for the RNZSPCA. Under the new constitution, each Member Society and Branch was required to decide by 31 July 2017 whether or not it intended to transfer into the RNZSPCA.
- 6. At a special general meeting of each Centre, the members of the relevant Centre approved the decision to transfer the Centre into the RNZSPCA. In particular, the members of the Centres resolved to transfer, by way of gift, all of the assets and liabilities of the Centre to the RNZSPCA.
- 7. Following transfer of the various assets and liabilities, it was intended that the various Centres were dissolved, and removed from the Incorporated Societies Register.

- 8. To give effect to this, in October 2020 I requested to the Registrar of Incorporated Societies that the Centres noted as 'dissolved' in the table at paragraph 4 be dissolved. I made this request, acting in good faith on the basis that the Centres no longer had assets and/or liabilities and that the objects and purposes of the Centres were now being performed by RNZSPCA. This request was actioned by the Registrar of Incorporated Societies.
- 9. To deal with the remaining Centres which had not been dissolved, in November 2020 I requested to the Registrar of Incorporated Societies that the other Centres noted in the table at paragraph 4 (Remaining Centres), together with Wellington Society for the Prevention of Cruelty to Animals Incorporated (registration number 215312) (Wellington SPCA) also be dissolved.
- 10. To support the request for dissolution and to provide comfort to the Registrar in exercising the relevant discretion under the Incorporated Societies Act 1908, I confirm that as at the date of this Statutory Declaration and having made due enquiry, I am not aware of any current challenge, concern or dispute that has been made by any member of a Remaining Centre. Further, I confirm that I am unaware of any historical challenge, concern or dispute that has been made by any member of a Remaining Centre and which remains unresolved or outstanding.
- 11. Finally, I confirm that in relation to the Wellington SPCA, the Companies Office (Incorporated Societies)has made us aware of correspondence relating to RNZSPCA which it has received. I confirm that I am willing to engage with the complainant in good faith to discuss and hopefully resolve or deal with the concerns, in accordance with the Rules and Constitution of RNZSPCA and Wellington SPCA (to the extent relevant).

AND I MAKE THIS SOLEMN DECLARATION conscientiously believing the same to be true and by virtue of the Oaths and Declarations Act 1957.
