- [If asked about the China mission report] We are pleased that the report has now been released. Our technical experts are currently analysing the report.
- [If asked about the US joint statement or a possible New Zealand statement] This is a scientific report and we want to make sure we understand the science before making any comment. We will wait until our experts have finished analysing the report -s9(2)(g)(i)

#### Update on joining the US statement

We now have more clarity on the position of the US regarding timing for delivery of the statement following the release of the report. They are planning a very short timeframe –s6(b)(i)

This means it will not be possible for New Zealand experts to sufficiently analyse the report (even at a high level) and for us to feed back any textual changes before the statement is delivered. For this reason we propose to inform the US directly (in Geneva, and following up in Wellington) that <a href="New Zealand cannot join the statement">New Zealand cannot join the statement</a>. Further, even if the US were to offer a short extension on timing, MoH has confirmed there would still not be enough time to sufficiently analyse the report. s6(a)

Below are key points we propose to deliver to the US:

- New Zealand recognises the critical importance of the WHO-led COVID-19 origins study. It is vital the world understands the exact source of the current coronavirus disease virus and its introduction to the human population, so that we can learn from this in order to improve the global health system and reduce the risk of a future pandemic.
- We welcome the efforts from the US to engage with the World Health Organization and global health security. The US plays a pivotal leading role in this space and we appreciate the US's engagement on such an important issue, s6(a)
- As we have mentioned, it is important to New Zealand that we are able to sufficiently analyse the mission's report before joining or delivering any statement on the WHO-led COVID-19 origins study. The US's proposed timeline from the release of the report to the delivery of the statement means that we will be unable to join the statement. Our technical experts are under a heavy work load with our COVID-19 response, and we do not have the capacity to analyse the report in such a short time.
- Once we have analysed the report we will be happy to share our views on the report and continue to work closely with the US on any further phases of the COVID-19 origins study.
- [If we are asked if we will deliver a national statement] Once New Zealand has analysed the report, we
  will decide on the appropriate way to comment on the mission.

## Update on timeline for NZ agencies to review the report and provide advice to Ministers

We are working to agree a timeline for MFAT, MoH and MPI review of the report and provide advice to Ministers. The below is yet to be agreed by agencies but is what we are currently looking at: Working days following release of the report:

- Days 1-6 from release of report: MoH, MPI and MFAT undertake parallel reviews of the report and determine individual agency positions.
- Day 7-8 from release of report: agencies meet and work together to agree joint NZ Inc position on the report and advice to Ministers.
- Day 9 from release of report: advice provided to relevant Ministers including the PM on:
  - o New Zealand's assessment of the report
  - o s6(a)
  - How NZ should respond to the report and in what format, including whether NZ should release a national statement or participate in any joint statements
  - Provision of media points.

  - We welcome the efforts from the US to engage with the World Health Organiza ion and global health security. The US plays a pivotal leading role in this space and we appreciate the US's engagement on such an important issue s6()
  - As we have mentioned, it is important to New Zealand that we are able to sufficiently analyse
    the mission's report before joining or delivering any statement on the WHO-led COVID-19

    under a heavy work load with our COVID-19 response, and e do not have the capacity to
