I am writing to you in response to your email sent to New Zealand Police on 10 September 2021, which was made pursuant to the Official Information Act 1982 (OIA). I have responded to each of your questions below.

It has been reported that "the NZSA hosted a 23 February meeting attended by Police and a small group of industry representatives to talk crowded places and the potential for industry involvement."

1. *I request a copy of whatever documents Police hold that summarise this meeting and its outcomes*

Police was invited to attend a meeting hosted by the New Zealand Security Association (NZSA) who scheduled and managed the event. Police holds no documents summarising that information, therefore this part of your request is refused under s 18(e) of the OIA as the document alleged to contain the information requested does not exist.

It has also been reported that "Police has since greenlighted the idea of a new [NZSA] advisory group under the Strategy," despite earlier expressing the view that security industry involvement in the Crowded Places Strategy would be inappropriate "due to conflict of interest." I request:

2. *Copies of all documents, including meeting minutes and internal communications, that deal with the decision to allow security industry involvement in the Crowded Places Strategy.*

The security industry was not involved in the development of the Crowded Places Strategy. Once the strategy was launched, organisers proactively set up a Crowded Places subgroup which they have called the Crowded Places Security Advisory Group (CPSAG). This group is not part of the structure outlined in the Crowded Places Strategy.

- 3. I request copies of all email communications between Police and the NZSA on the topic of the Crowded Places Strategy, dated since the beginning of this year.*

I have attached copies of email communication in 2021 between Police and the NZSA on the topic of the Crowded Places strategy. Please note some information has been withheld under s 9(2)(a) of the OIA to protect the privacy of natural persons.

- 4. I request copies of all email communications between Police and security consultant and CPSAG chair Sir Kenneth McKenzie, dated since the beginning of this year.*

There has been no direct email communication between Police and Sir Kenneth McKenzie on the Crowded Places Strategy. I have attached copies of email communication in 2021 between Police and the NZSA on the topic of the Crowded Places strategy of which Sir Kenneth McKenzie has also been a recipient. Some information has been withheld under s 9(2)(a) of the OIA to protect the privacy of natural persons.

You have the right, under s 28(3) of the OIA to ask the Ombudsman to review my decision if you are not satisfied with the way I have responded to your request.

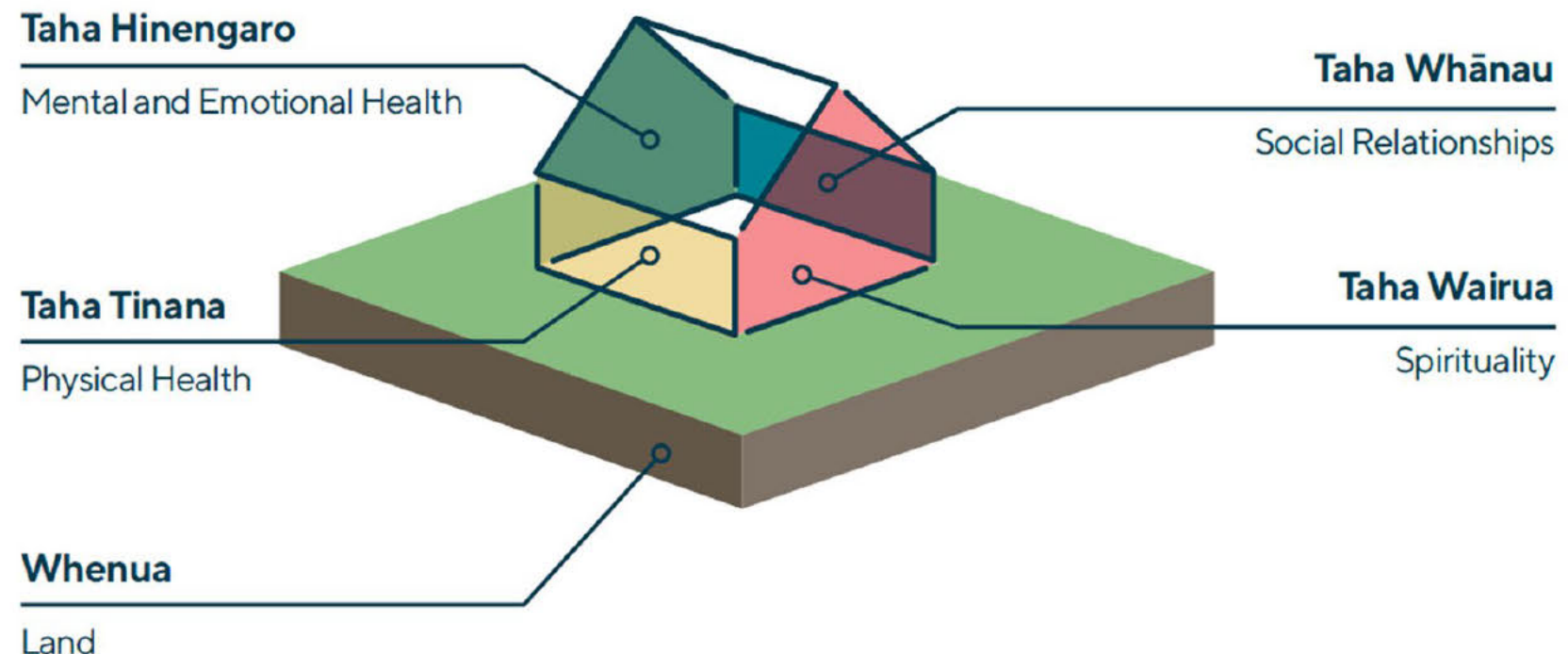

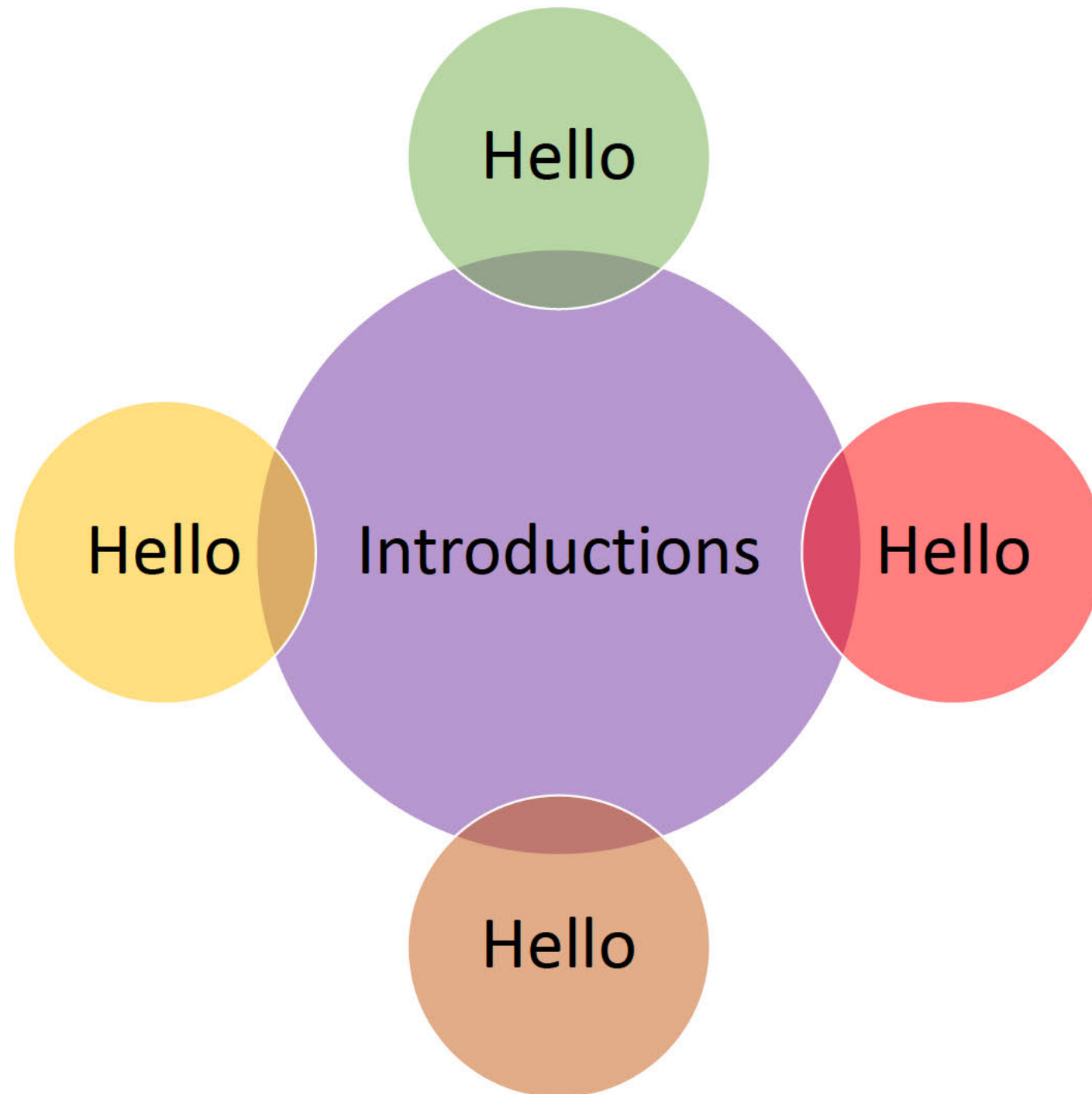

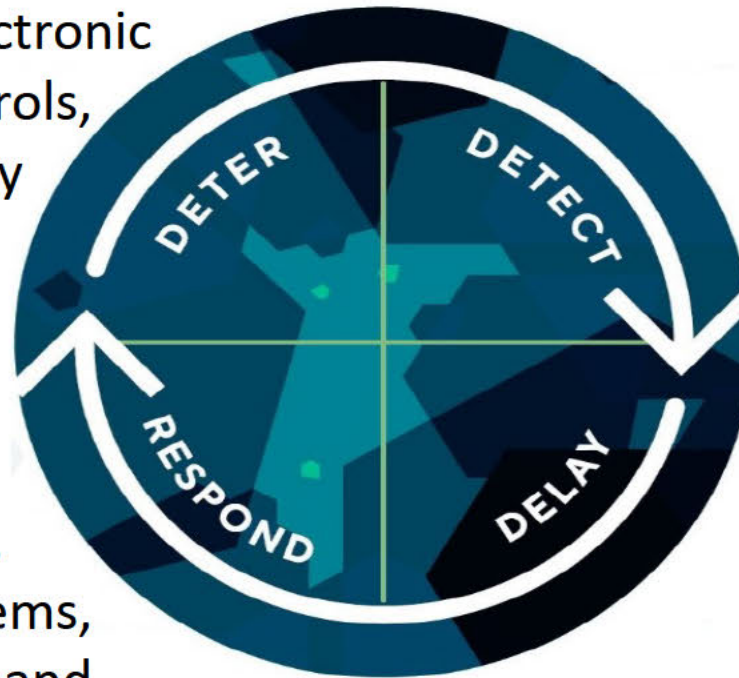

The four aspects of protective security (or “Layers”)

DETER with obvious physical and electronic target hardening measures e.g. fences, security lighting, electronic access control, high visibility patrols, vehicle barriers. Can also just say “kia ora” or “hello”, etc

RESPOND by timely and coordinated reaction e.g. by trained staff and security, emergency communication systems, security plans that are practiced and compatible with local emergency services’ plans



DETECT with visual detection and alert systems e.g. CCTV cameras, reports of suspicious behaviour (by security, staff or public), vehicle screening, screening equipment, etc

DELAY using physical counter measures and processes e.g. security fences, vehicle security barriers, pedestrian and vehicle access control points, trained staff interventions, rapid response by security officers, etc

Building stronger partnerships

Three working groups will be established.

- Crowded Places Advisory Group New Zealand (CPAGNZ)
- Business Advisory Group New Zealand (BAGNZ)
- Community Advisory Group New Zealand (CAGNZ)

Enabling better sharing of information and guidance

The Combined Threat Assessment Group (CTAG) produces terrorism threat assessments. New Zealand Police translates this intelligence into information and guidance that is relevant locally. A series of guidelines and tools for owners and operators of crowded places is available on the Police website.

Implementing effective protective security

Owners and operators must assess risks and vulnerabilities in a proportionate way. Owners and operators need to consider how to deter, detect, delay and respond to an attack. These four aspects of protective security are known as layers. The actual mitigations that owners and operators of crowded places can use, to deter, detect, delay and respond to an attack, will differ from location to location.

Increasing resilience

Well-considered and well-tested protective security will reduce the likelihood of an attack occurring and may lessen its consequences. Protecting a crowded place relies on building and sustaining a culture of trust and security among managers and frontline staff.



Intent behind the Advisory Groups

- To raise awareness of the national threat level and increase engagement, communication and active prevention planning within New Zealand.
 - promote and where necessary, tailor prevention focused activities appropriate to your sector and level of threat.
 - share new information and ideas on protecting crowded places and suggest opportunities to improve public information on government Websites.
 - provide advice and oversight to businesses and the community
