Community Cases

There are 704 active cases that have been identified in the community. Today, 20 new cases were confirmed, all in Auckland.

Contact Tracing

1,127 close plus contacts have been identified.

1,125 (99%) have been contacted and advised to isolate. Of these, 339 have returned a positive result, while 572 have tested negative.

33,607 close contacts have been identified. 30,384 (90%) have been contacted and advised to isolate. Of these, 141 have returned a positive result. 24,374 have returned a negative test result.

There are 3,324 casual plus contacts.

There is ventilator and ICU capacity at each DHB except Wairarapa and the West Coast which have no ICU beds available. Available capacity at Auckland DHB is over 25 ICU beds and over 60 ventilators.

There are 40 hospitalised cases, all of which are associated with the current outbreak. 6 cases are in ICU and 4 of those require ventilation. There was one death from COVID-19 on 3 September.

Non-Compliance

5 people were prosecuted for COVID-19 related offences, 2 fewer than the previous day. 13 people were warned yesterday, 5 more than the previous day. There were 189 infringements issued yesterday for COVID-19 related breaches, 67 more than the previous day. The increase was driven by non-essential travel occurring in AL4 areas.

From midnight on 7 September, everyone age 12 and over will be required to sign into most locations they attend. Mandatory record-keeping is part of an effort to strengthen contact tracing. Media reporting has already highlighted concerns around how this data will be used and/or stored.

Online Breach Notifications

There were 611 compliance breaches reported to Police online yesterday. This is an increase of 85 breach notifications compared to the previous day.

Of the breaches, 79% (480) related to gatherings, 15% (92) related to businesses, and 6% (39) related to individuals.

Travel Compliance

Approximately 21,474 vehicles were recorded going through checkpoints in the 24 hours to 1530hrs 5 September 2021. 835 vehicles (3.8%) were turned around for not having an exemption/permitted travel.

Public Sentiment

Analysis of public social media commentary indicates that people are divided following MIQ system changes: some are happy, others discouraged by a lack of booking prioritisation.

Thursday's MIQ incidents are driving discussion about the training MIQ staff receive and whether purpose-built managed isolation facilities are required.

People are also discussing the impacts of lockdown on small/independent business and on industries with scarcity of materials/labour. People are concerned about pressures on essential workers. Overall, 54% of COVID-related online sentiment is negative, and 34% is neutral.

Healthline and Testing Hesitancy

Themes have emerged over the past 3-4 days of higher testing hesitancy amongst callers to Healthline. Reasons for the increase in hesitancy are concerns around having to go into MIQ, positive case shaming, and essential worker wage pressure, despite the "COVID-19 Short-Term Absence" payment available. Concerns around entering MIQ have been exacerbated by negative news and social media reports.

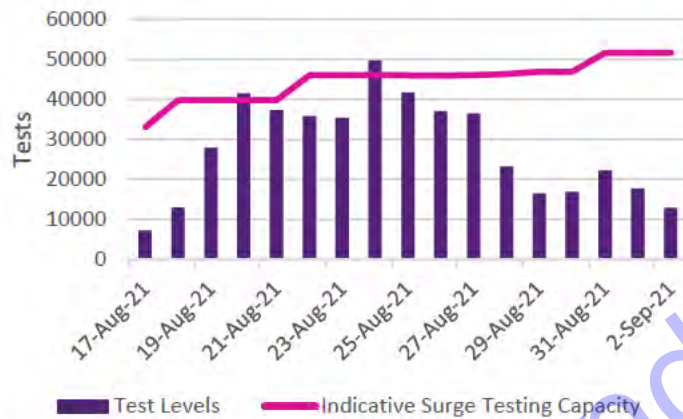

MIQ Security and Staffing Measures

The number of First Security and NZDF staff has been increased at the Novotel Ibis Eilerslie and Holiday Inn in response to a review of security, health, and hotel workforce measures at those sites. MIQ staff continue to review whether changes to health workforce staffing levels or operating procedures could further improve conditions and mitigate escape risk. MIQ staff have been warned of risks of poor behaviour among recent arrivals following a report from Air New Zealand of poor behaviour on yesterday's emergency allocation flight from Australia.

Social Support in Northland

Northland Indian Business Association and Whangarei District Council have raised concerns regarding the accessibility of MSD support services among elderly, disabled, and migrant populations. This could be due to social stigma and confidentiality issues around providing personal information to Government.

Foodbanks and community providers are receiving an unprecedented demand for food, with many organisations reporting a high risk of running out of food.

Increasing numbers of Pacific families are continuing to go without essentials, with reports suggesting families are not comfortable requesting support.

Auckland Regional Church leaders are collaborating with service providers and agencies to facilitate the push of aid packages to families in need.

The Ministry for Pacific Peoples is connecting church and community leaders to service providers to deliver these services safely.

Welfare Triage Centre

Auckland Emergency Management, and MSD have established a Welfare Triage Centre, with 36 staff providing outbound calling to people testing positive and/or self-isolating to match them with appropriate agencies.

Housing

The Ministry of Housing and Urban Development have secured approximately 60 additional motel units, in Auckland, Whangārei, Wellington, Nelson and Christchurch in response to requests from Housing First providers for additional capacity to enable people experiencing homelessness/rough sleepers to be housed.

The Ministry is working with a range of community and government agencies in regional locations to address location-specific needs, for example women seeking refuge and support services for rangatahi.

Ethnically-Centred Vaccination Sites

On September 3, Asian Family Services requested a group vaccination site for ethnic communities. This is being progressed by Auckland DHB.

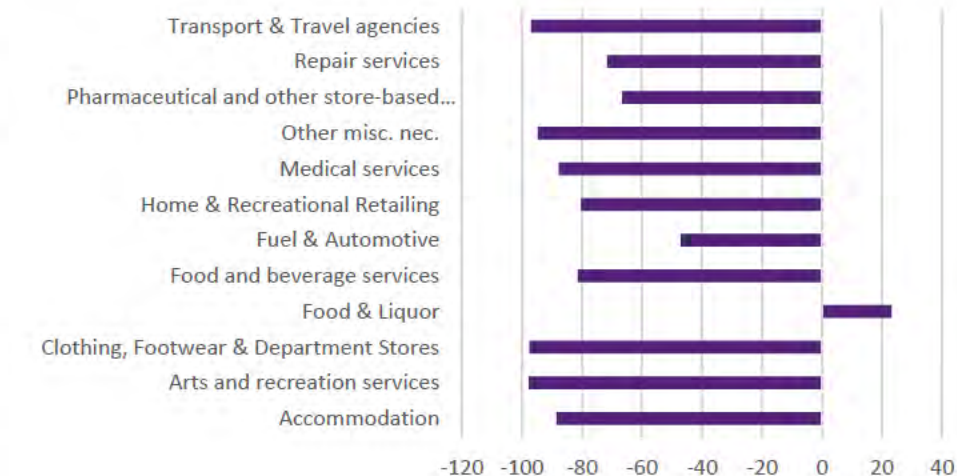
Economic Indicator – Consumer Spending

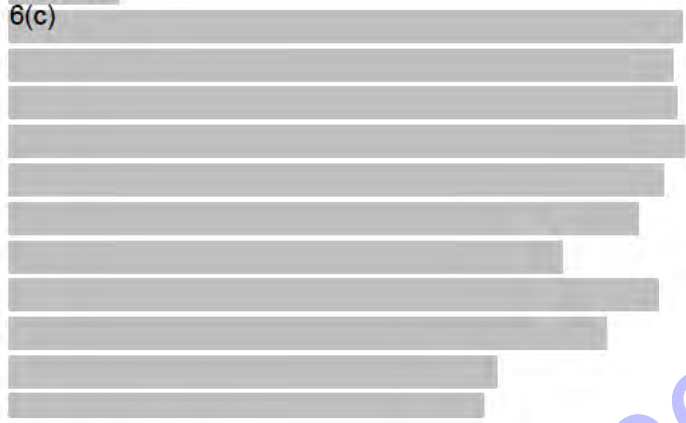
There are several protest, false-information, and non-compliance activities occurring during the current response. Some of the most high-profile ones are highlighted below.

False Information

Misinformation continues. This includes the suggestion that Ivermectin (typically used as a horse de-wormer) can be ingested orally as a Covid cure. Misinformation is likely to hinder the COVID-19 response. There may also be health issues arising from people using Ivermectin.

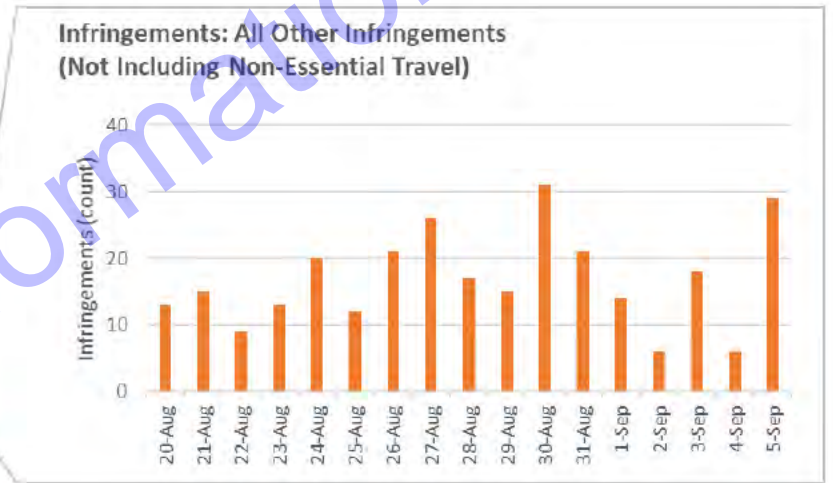

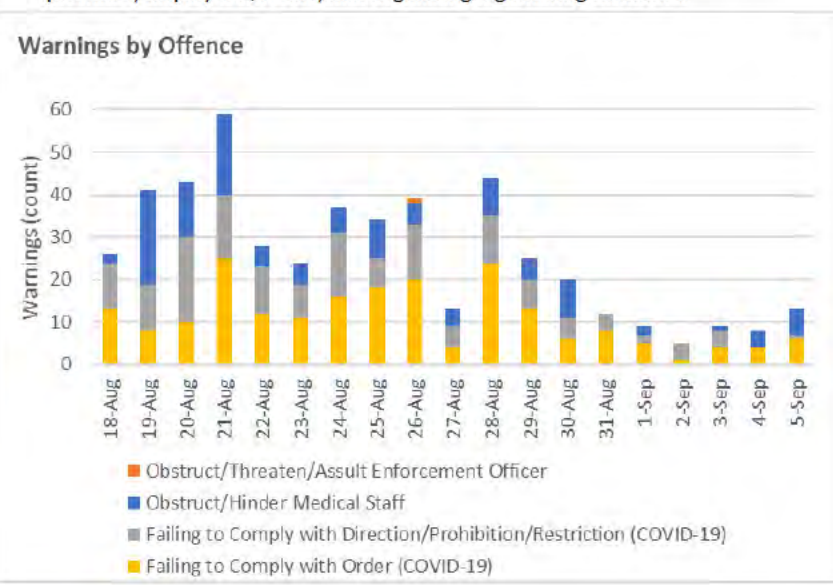
Infringements, Prosecutions, and Warnings

Since the change to Alert Level 3 in areas south of Auckland, infringements, prosecutions, and warnings related to COVID-19 have decreased. Decreases in infringements appear to be driven by decreases outside Auckland. In Auckland, there does not appear to be any change to infringement rates, and infringements remain particularly high in the Counties/Manukau policing district. There does not appear to be any regional trend in prosecutions or warnings.

Public Sentiment

Conversation around AL4 timeframes, contact tracing and testing, and the vaccine rollout peaked on Monday following the post-Cabinet briefing, following high levels of conversation about the vaccine rollout over the weekend.

Sentiment about the vaccine rollout is 50% negative and 37% neutral. Conversation on the vaccine rollout was driven by news articles regarding border workers challenging the government's mandate to be vaccinated and a Picton backpacking accommodation's decision that all guests must be vaccinated. Discussion included the topics of freedom of choice, human rights and herd immunity.

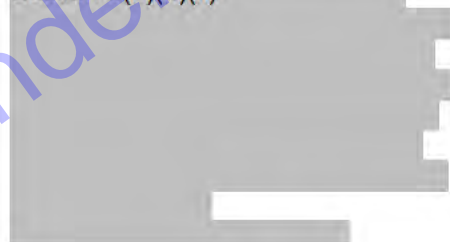

Traffic

Traffic in all major cities except Auckland increased between 75% and 180% after the change to AL3 but remains below baseline levels from the same time in 2019. In Auckland, traffic is around 31% of baseline levels but light and heavy vehicle traffic is increasing at a rate of 1-3% per day, indicating increasing amounts of movement as AL4 continues.

Transport

Bus usage increased 71% in Wellington and 79% in Christchurch relative to AL4. No issues were reported on the first day of the "no standing rule" on public transport and Waka Kotahi anticipates most services will not be affected under AL2. Updated transport operator guidance has been drafted reflecting AL changes.

Waka Kotahi and MoT are working with operators who have expressed concern about the capacity constraints this will create. The Transport COVID-19 Response Team remains active; Ministry and agencies meet daily. DPMC has approved draft guidance which MoT has shared with operators.

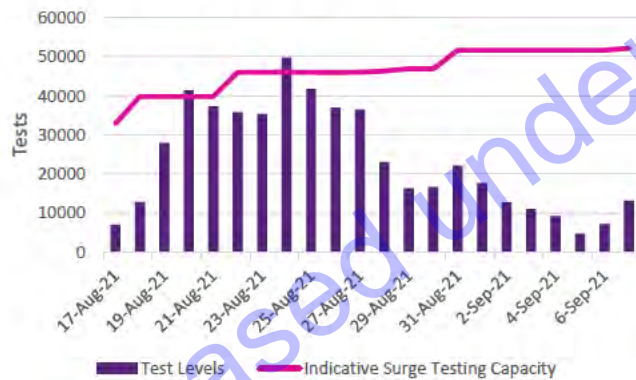

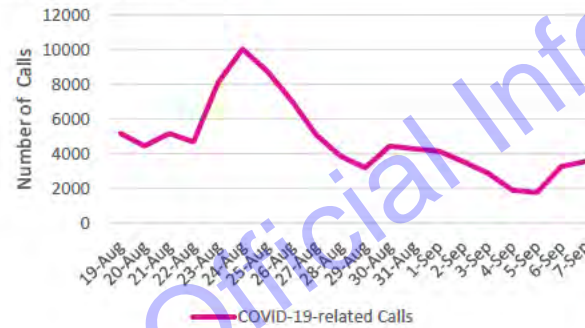
Testing Capacity vs Tests Administered

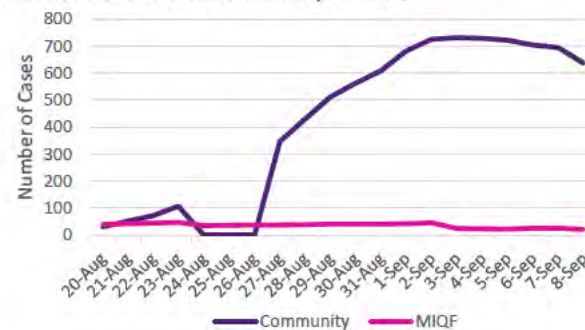
Number of People currently in Managed Isolation Facilities (Capacity: 4500)

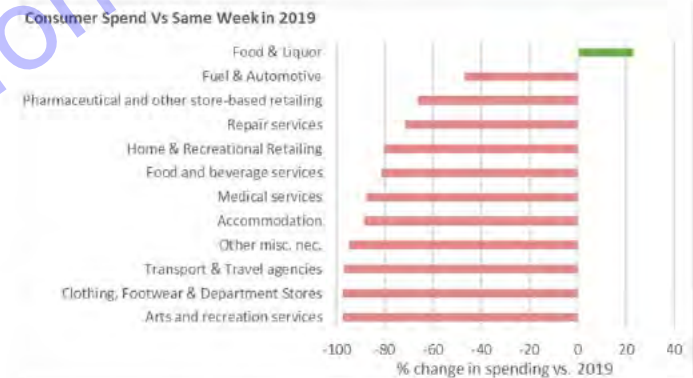

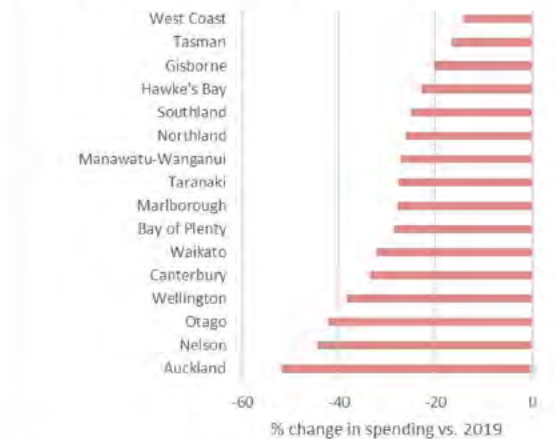

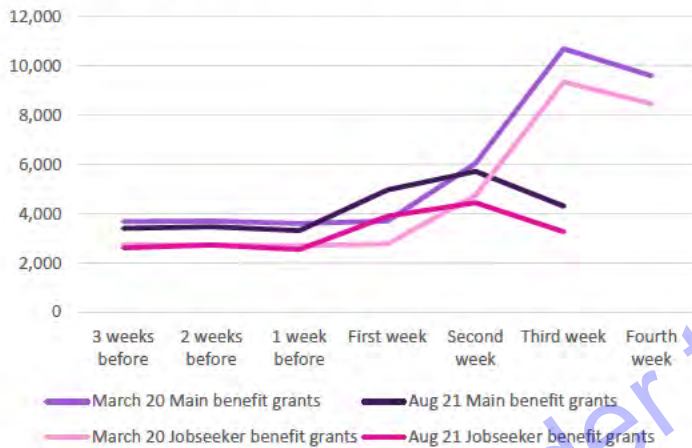

March 2020 and August 2021 wage subsidies: food grants by week



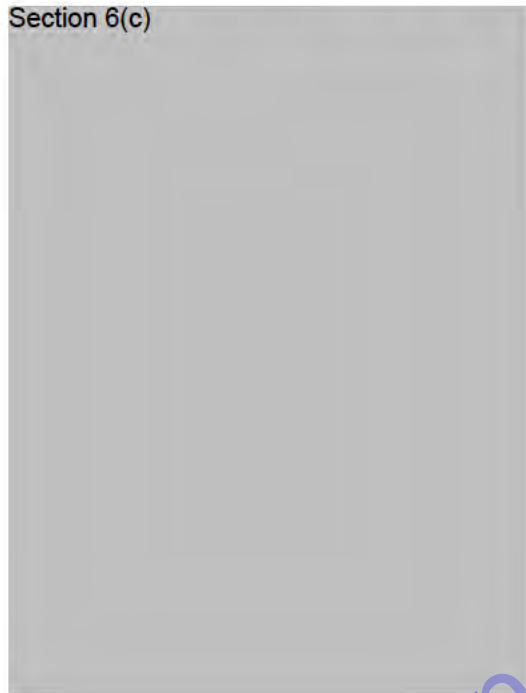

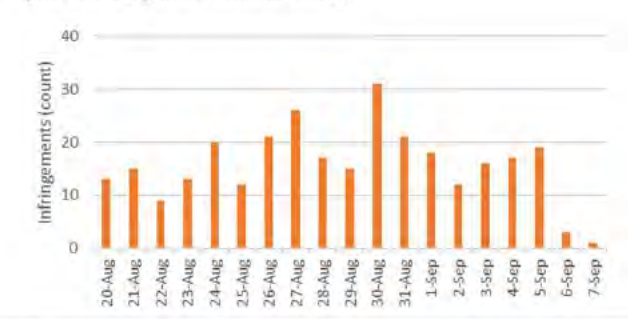

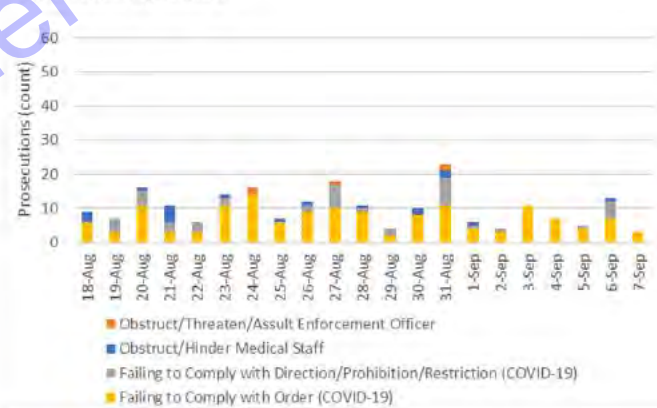

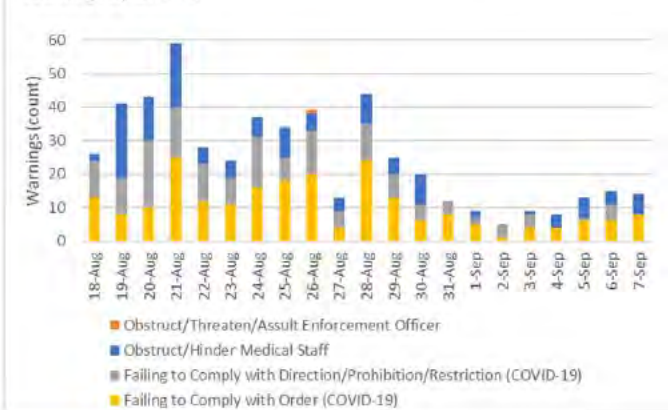

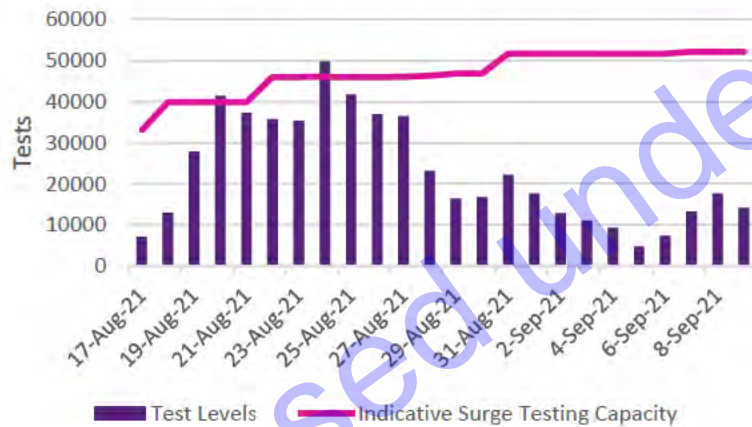

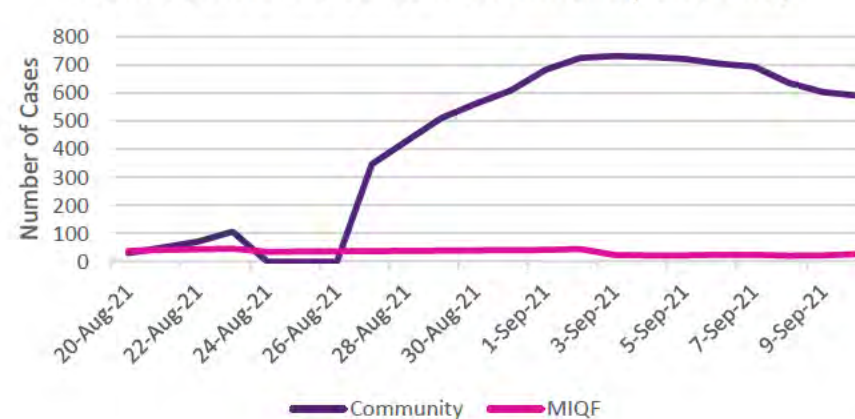

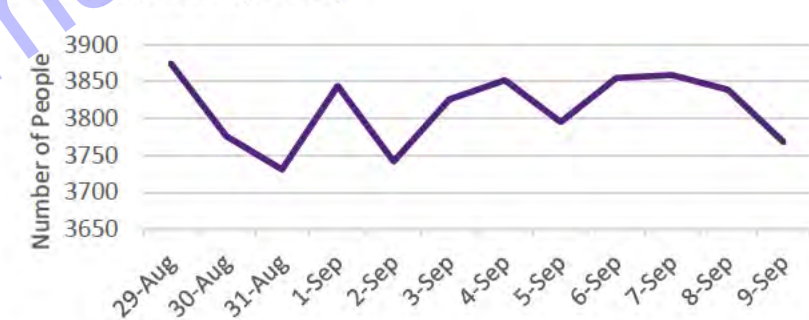

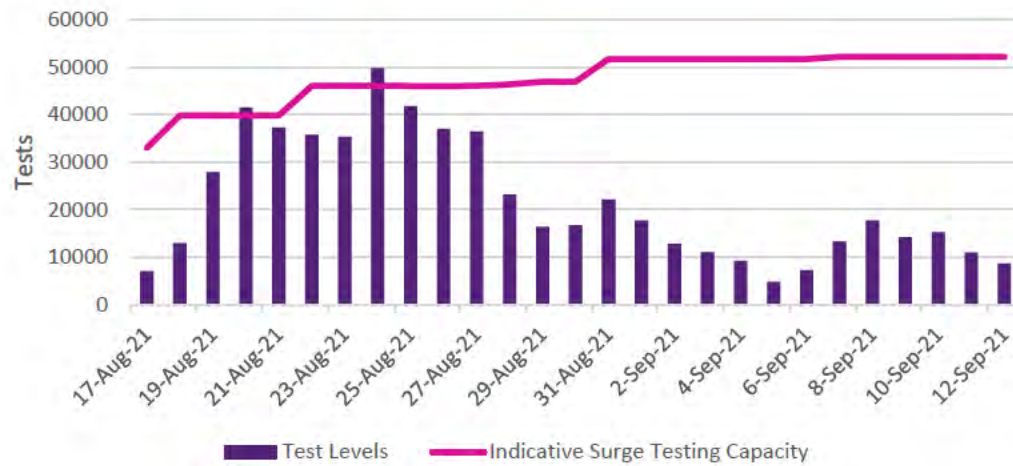

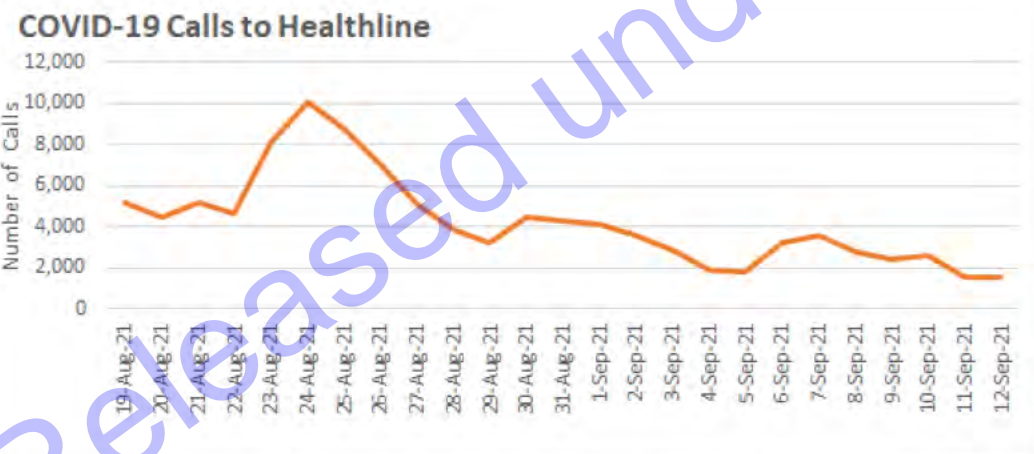
Testing Capacity vs Tests Administered

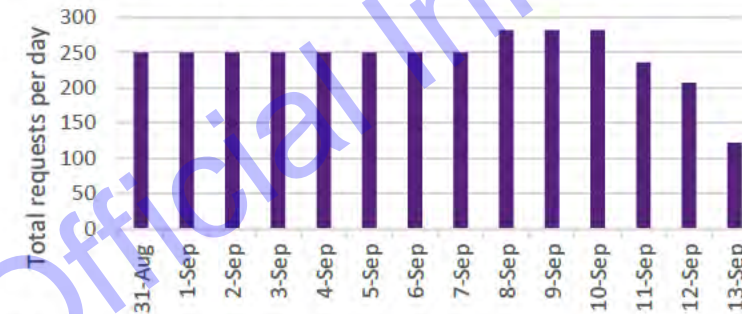

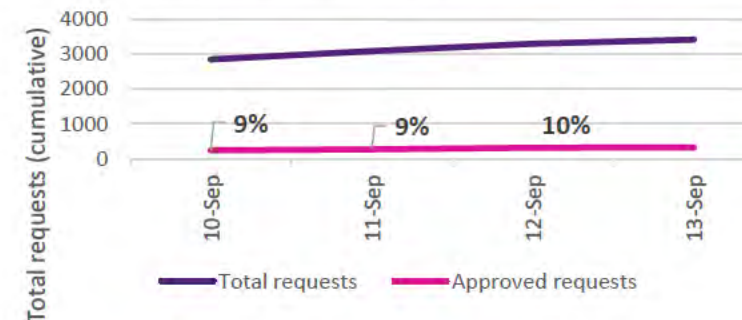

Checkpoint Breaches

At checkpoints less than 1% of vehicles stopped between 1 to 9 September were turned back. There has been one incident of an individual failing to stop.

A range of reporting indicates that a small amount of people may be seeking to evade checkpoints by using farm or private roads, foot tracks, train tracks, small trucks (which are not stopped), abusing official paperwork at crossing points, and attempting to cross at different checkpoints after being turned away from one. Complaints About Mask Wearing

Some people who are exempt from wearing a mask, such as those with a disability or health condition, are feeling embarrassed and/or discriminated against after being turned away from supermarkets, even with proof of exemption.

There are also reports of "anti-maskers" abusing exemption accreditations, making it more difficult to identify those who are genuinely exempt. An interagency working group monitoring face mask discrimination and exemption issues has identified the need to support those who qualify for exemptions by updating messaging, providing resources, and having ongoing discussions with supermarkets to ensure frontline staff have the right information.

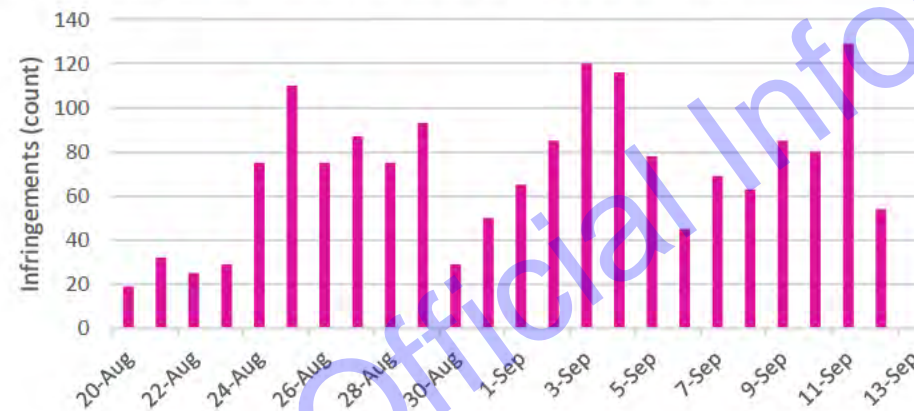

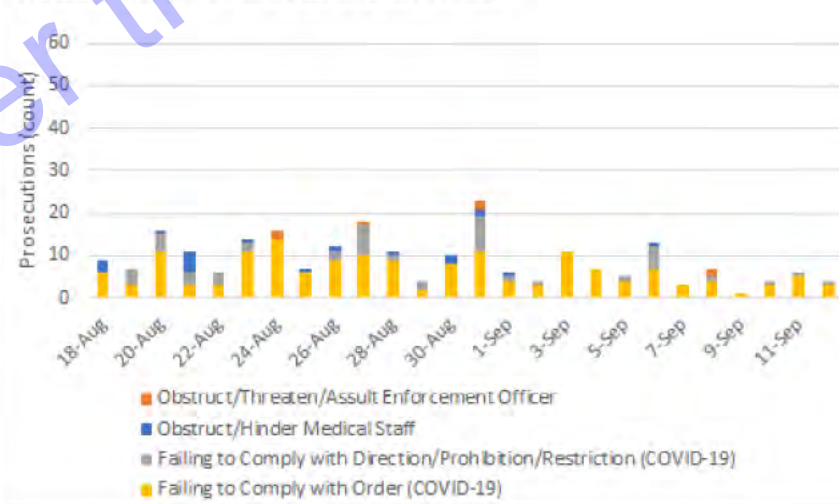

Total Infringements under AL3 and AL4 - Auckland Only

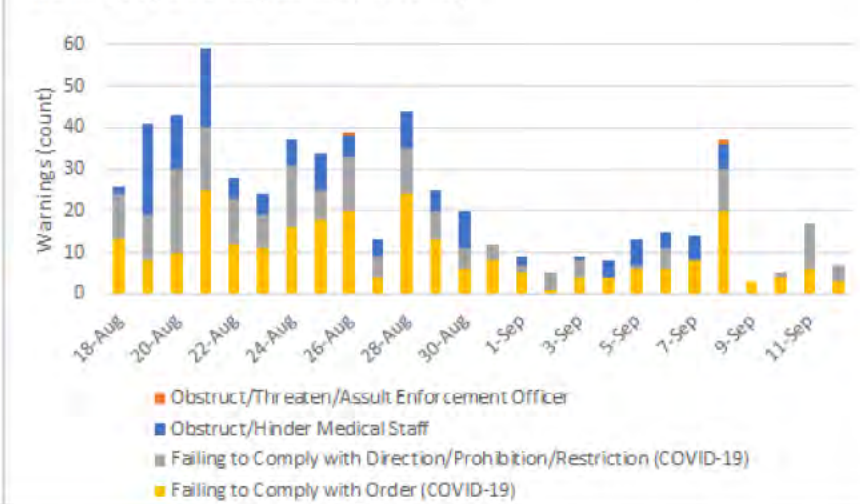

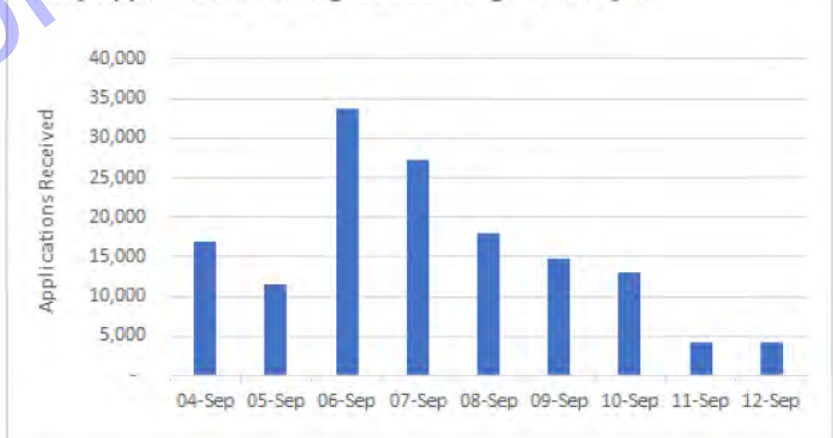

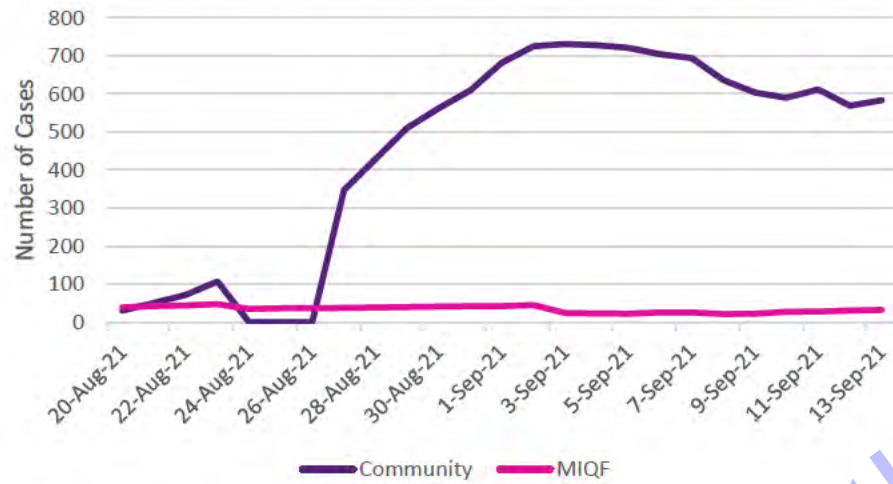

Active COVID-19 Cases in Community and MIQF

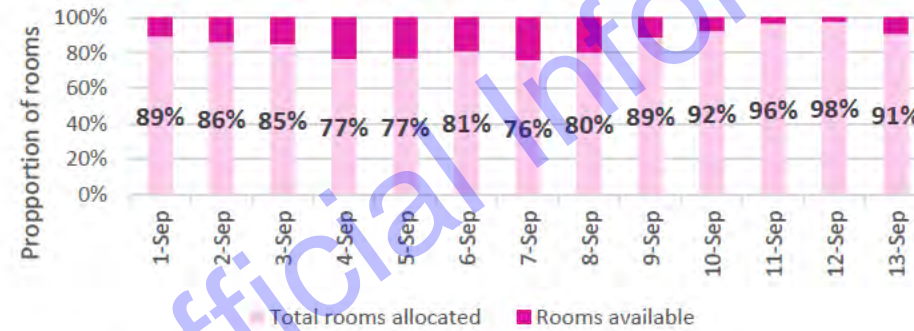

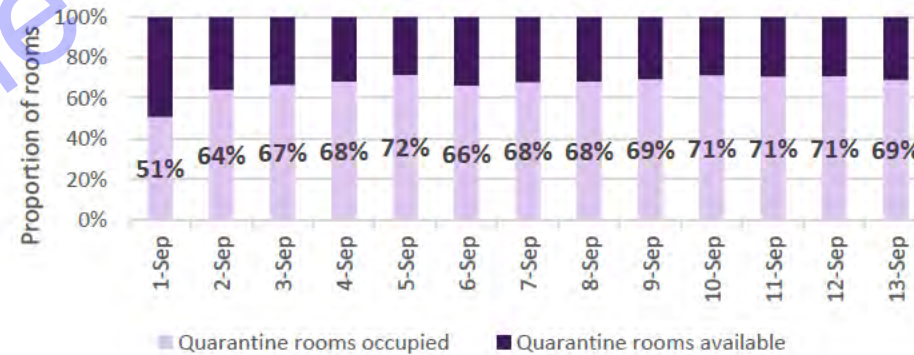

Public Sentiment

Analysis of social media sentiment on Monday showed conversation in the 'Team of 5 Million' category increased by 73%, and positive sentiment around this topic increased by 6%. With the announcement that Auckland would remain in AL4, people are encouraging Aucklanders to continue their good work at AL4, thanking them for their efforts to keep the country safe, and expressing frustration towards those not keeping to the rules. Most online conversation continues to focus on the virus (47% negative and 44% neutral sentiment), #NZPOL (45% negative and 42% neutral), the vaccine rollout (49% negative and 37% positive), and alert level timeframes (34% negative and 49% neutral). 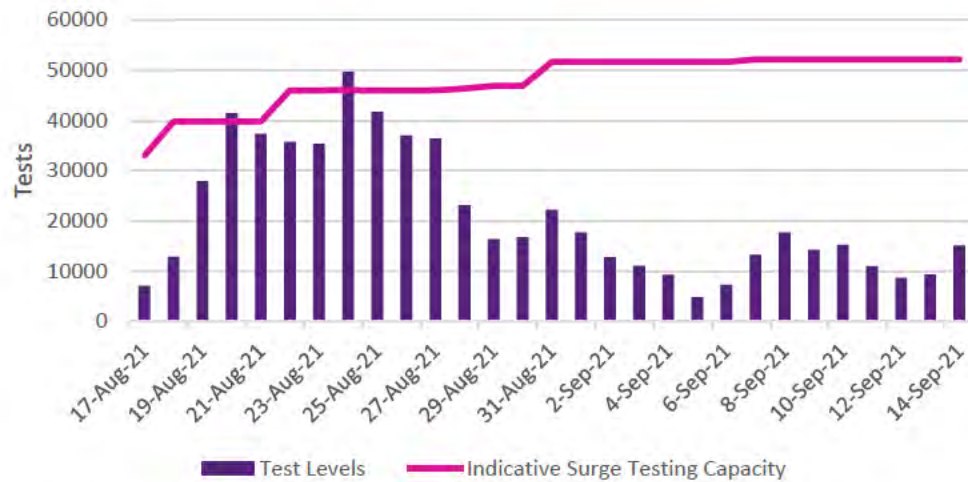
Indications of Public Sentiment

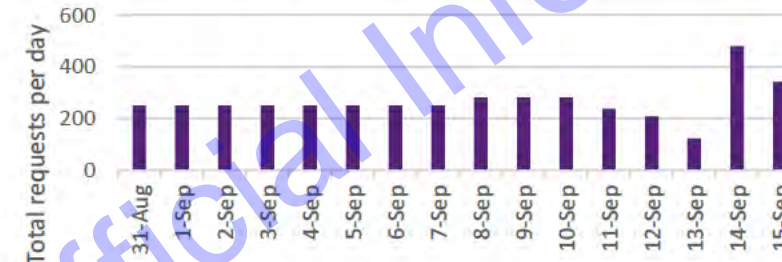

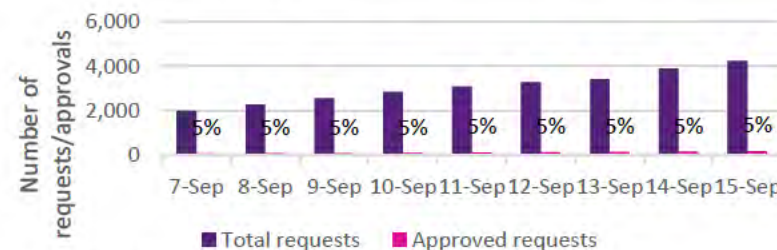

Approximate Daily Volume of Requests to MOH for Boundary Travel Exemptions to Leave AL4 Areas

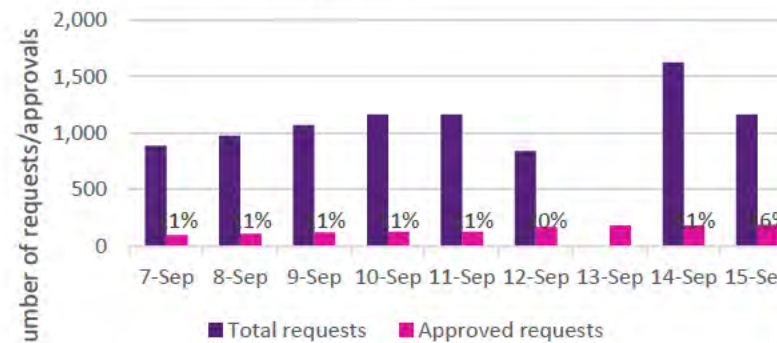

Cumulative Travel Exemption Requests and Approvals - MoH



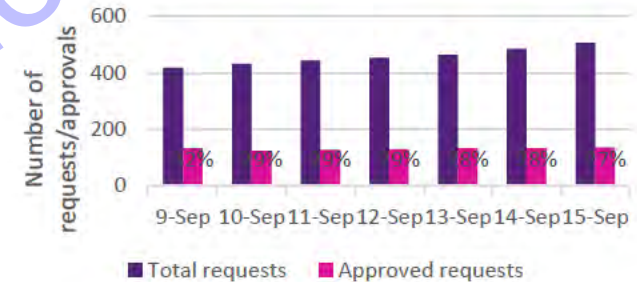
Cumulative Travel Exemption Requests and Approvals - MBIE, others

Checkpoint Breaches

At checkpoints, 0.78% of vehicles were turned back on September 14. This is the lowest proportion compared with the past week, and less than a third of that over the weekend. This is despite significantly higher volumes of vehicles.

Police have been stopping more vehicles on average travelling into and out of Auckland since the rest of the country moved from AL3 to AL2. The misuse of essential worker status to cross the borders continues to be an issue, with generic letters that do not explicitly state that the holder is permitted to cross the borders being received at the checkpoints. Old exemption letters from the April 2020 lockdown have also been received. Police staff are remaining vigilant when inspecting documents.

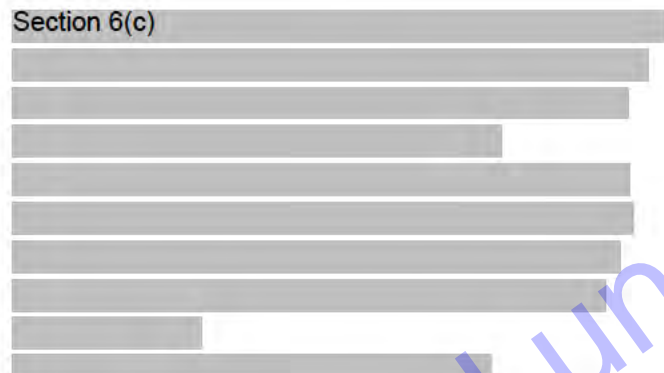
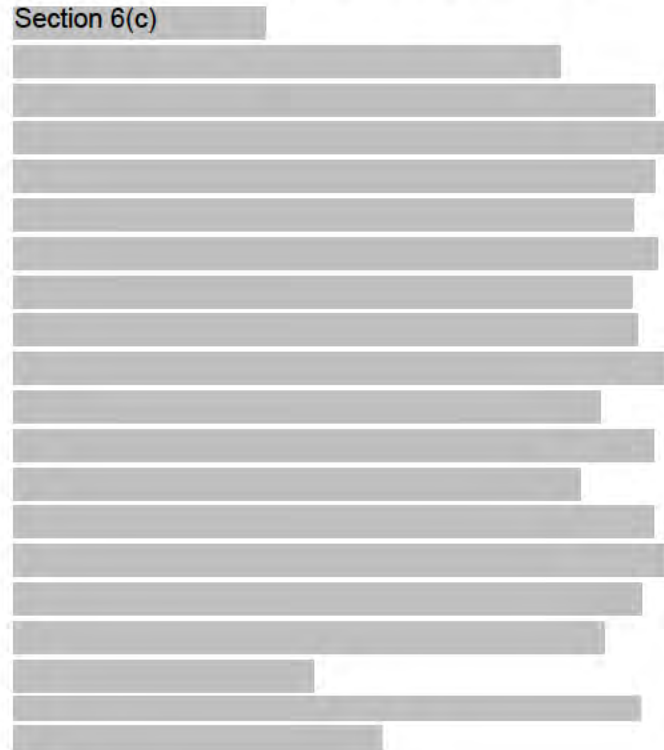

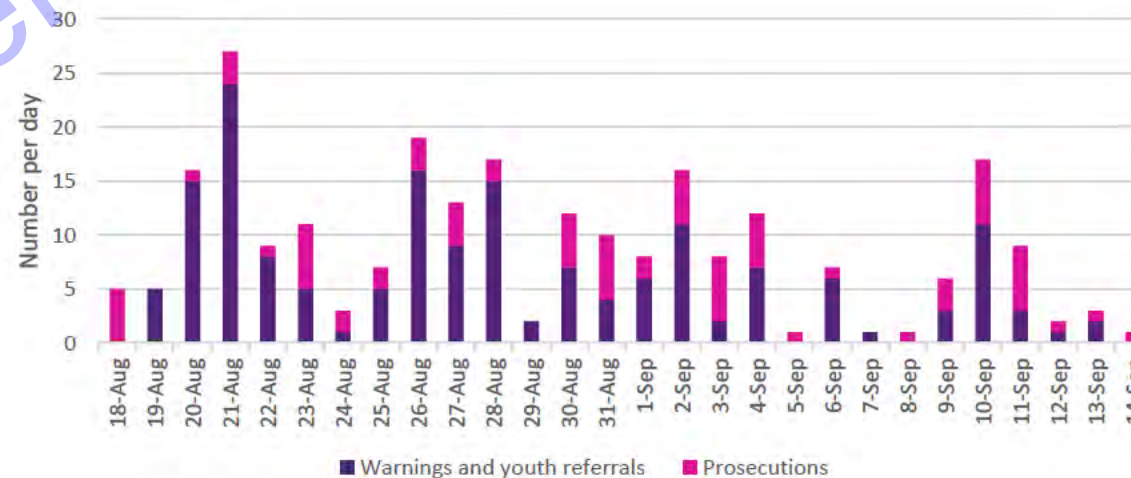

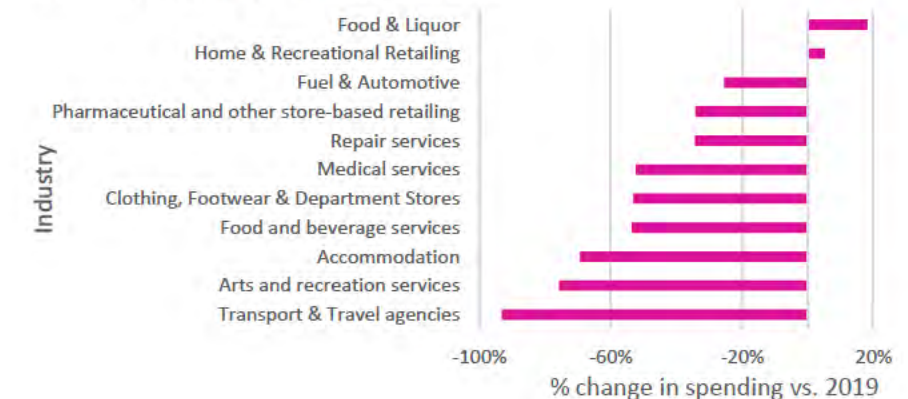

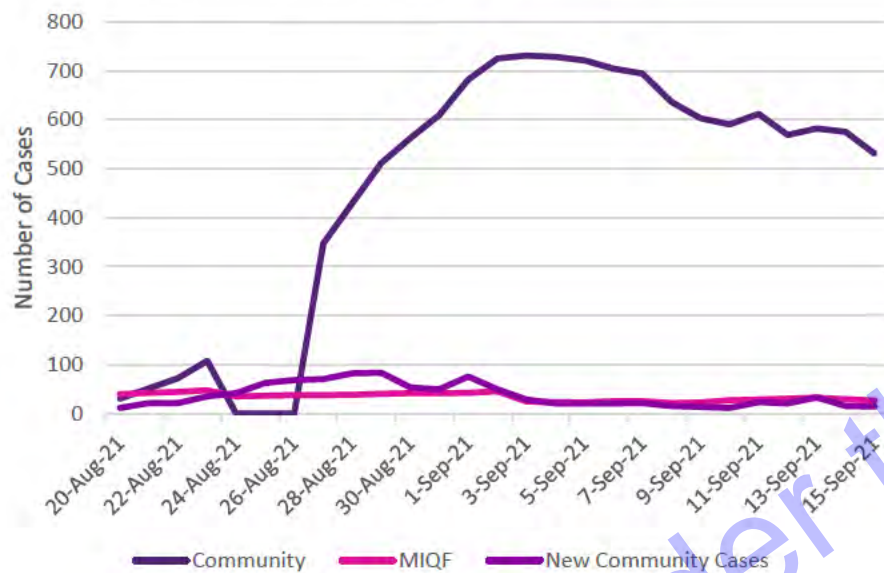

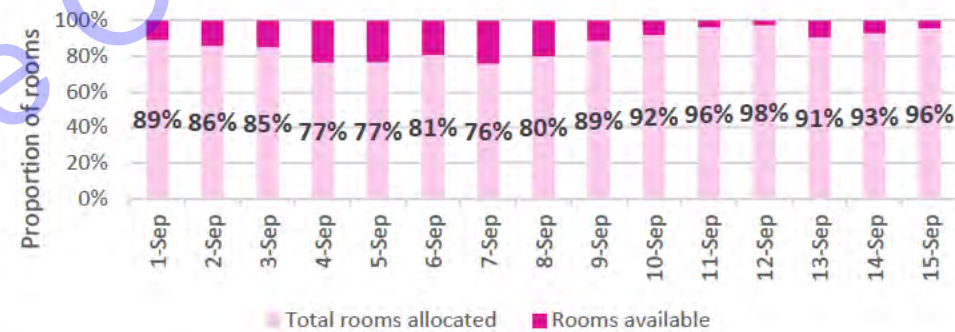

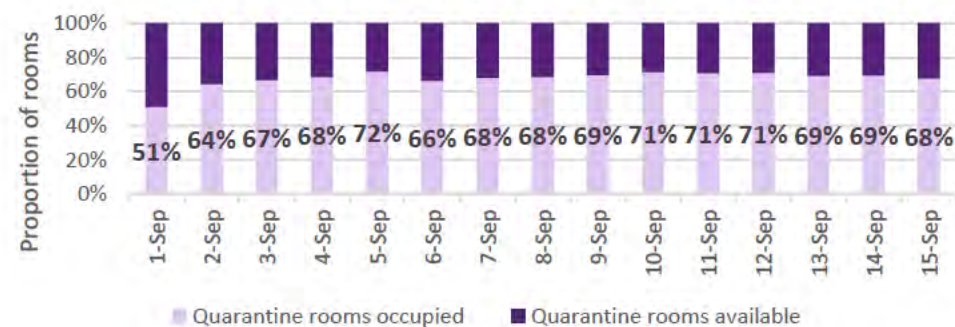

Vaccination Rates by Ethnicity

Ministry of Health data illustrates vaccination rates among Māori (22.7%) and Pacifica (31.2%) are behind those of Asian (40.5%) and European (37%) populations. However, this may be more reflective of access and age demographics than differences in vaccine sentiment. The median ages for Māori and Pacifica are 25 and 23 respectively, significantly lower than those among Asian (31) and European (41) groups.

The Latin American community has requested a targeted vaccine clinic. MOH and MEC are working with Capital and Coast DHB to establish this clinic in Porirua. ChangeMakers Resettlement Forum (CRF) and community leaders are requesting walk-in clinics for refugees who are unable to book vaccinations online or by phone. Muslim communities in Auckland are also requesting access to faith-based vaccination facilities, citing fears of racial abuse after the New Lynn mall terrorist incident. Heavy vehicle traffic increased by 1% to 5%, except for Wellington and Hamilton, which decreased by 2.3% and 0.9% respectively.

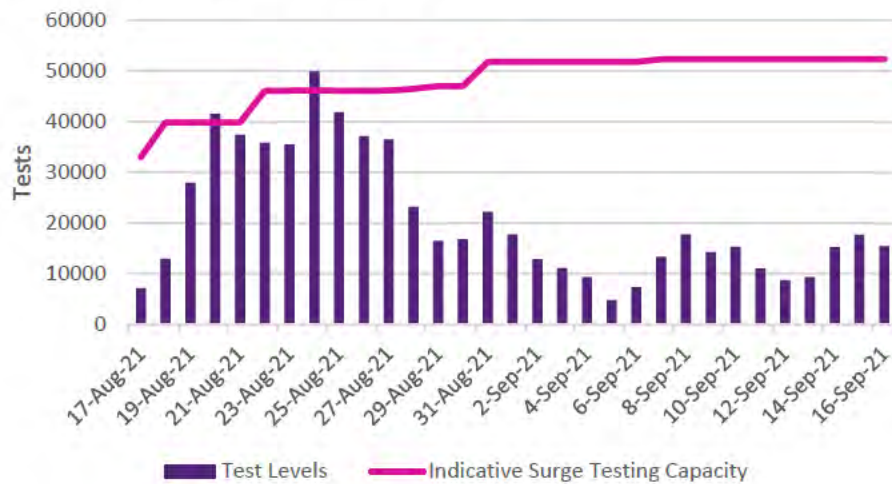

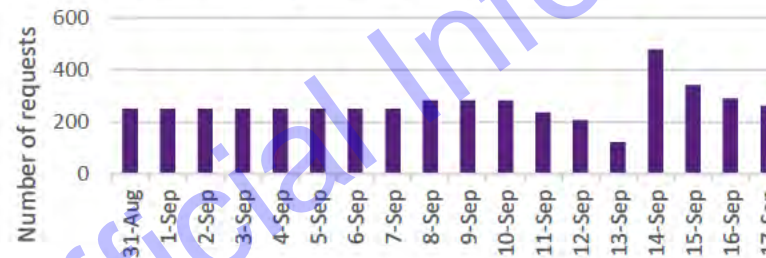

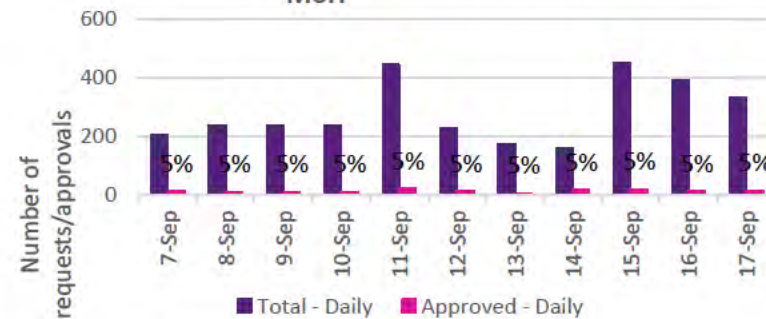

Approximate Daily Volume of Requests to MOH for Boundary Travel Exemptions to Leave AL4 Areas

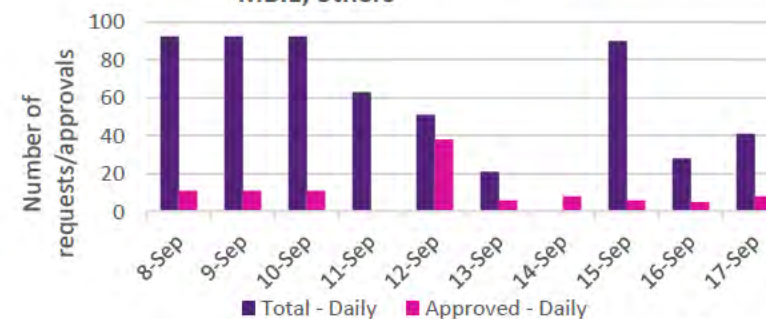

Daily Travel Exemption Requests and Approvals - MoH



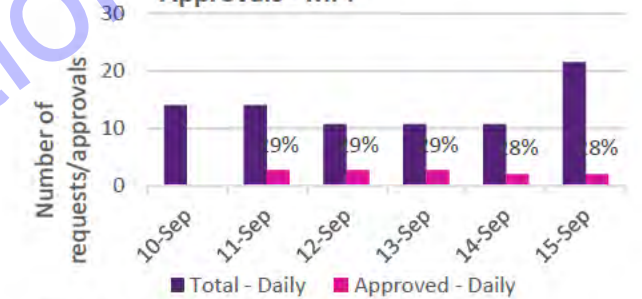
Daily Travel Exemption Requests and Approvals - MBIE, others

Checkpoint Breaches

At checkpoints, 0.75% of vehicles were turned back on September 16. This is the lowest proportion since September 8, and less than a third of that over the weekend. This is despite significantly higher volumes of vehicles.

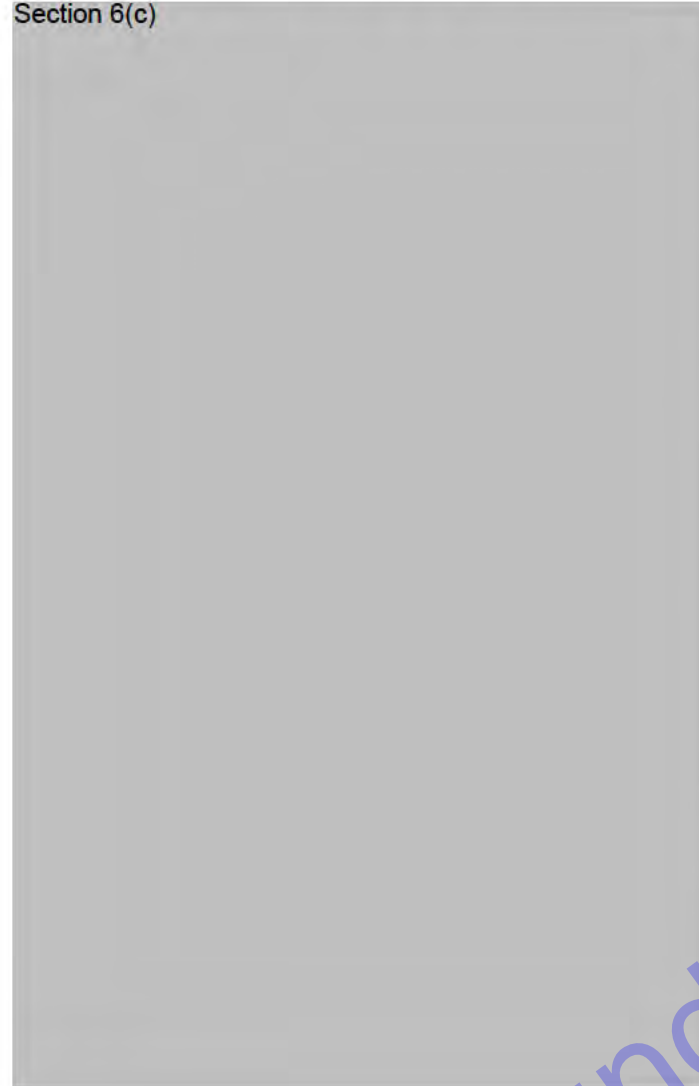

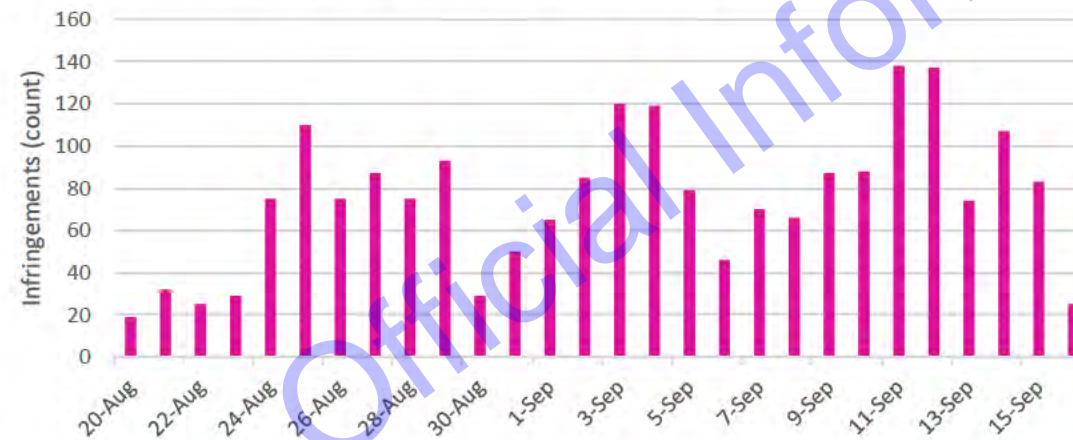

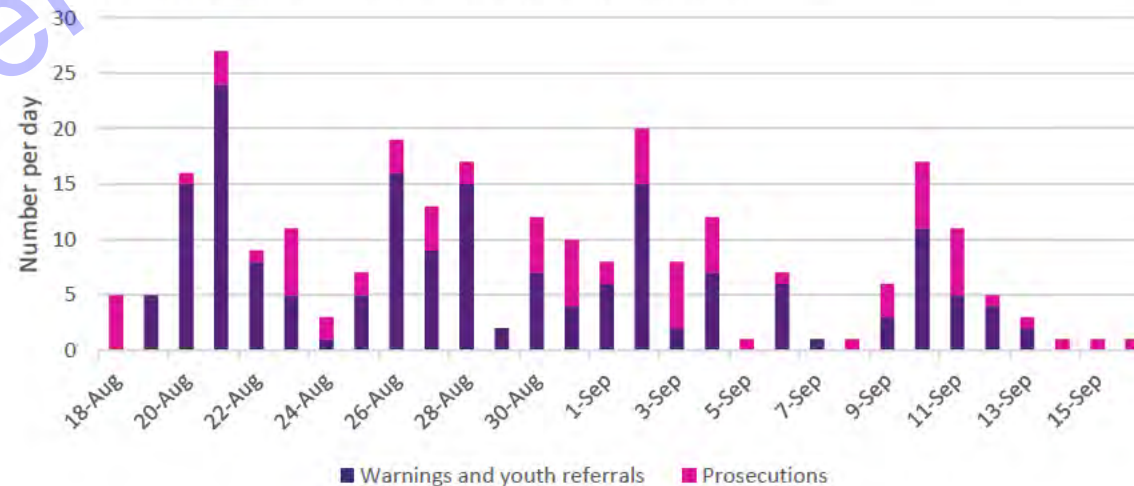

Confusion re Differing Isolation and Quarantine Requirements

Some members of the public are expressing that it is confusing that the time required for people to spend in MIQ after testing positive for COVID-19 differs from the time a person is required to be in MIQ on return to New Zealand. This followed media reports of the release of a person who had tested positive for COVID-19 after 10 days in MIQ. The duration of MIQ upon return to NZ is 14 days and isolation after testing positive is 10 days after symptom onset if there have been no symptoms for the past 72 hours.

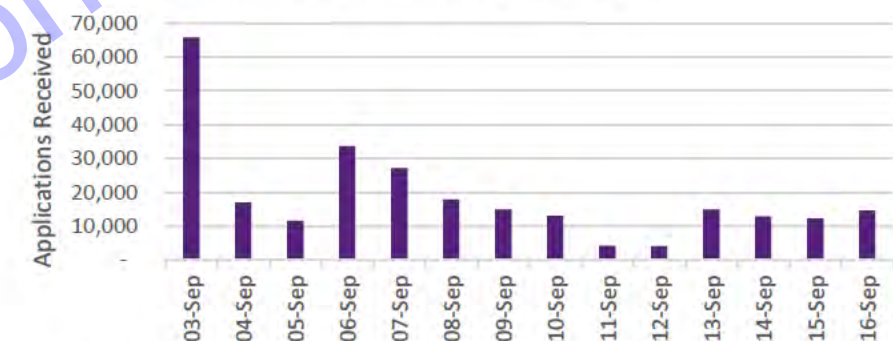

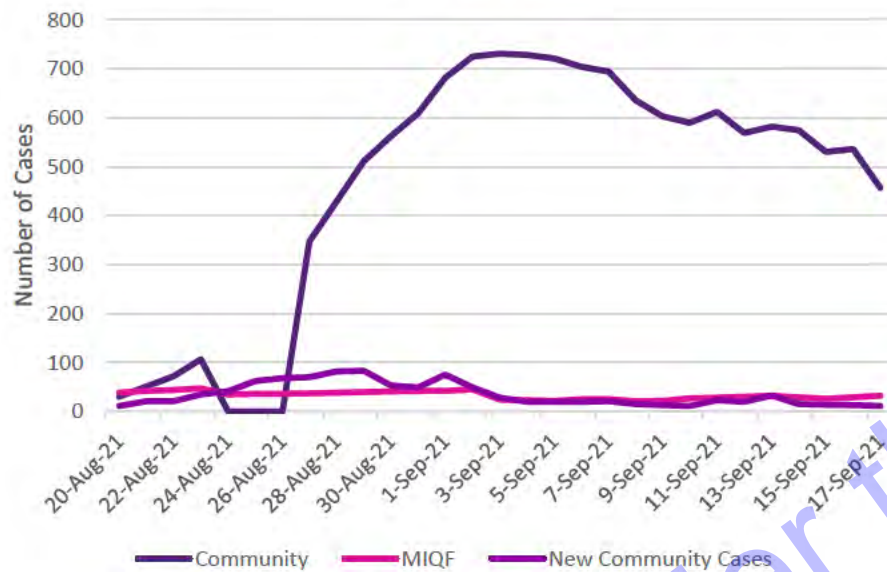

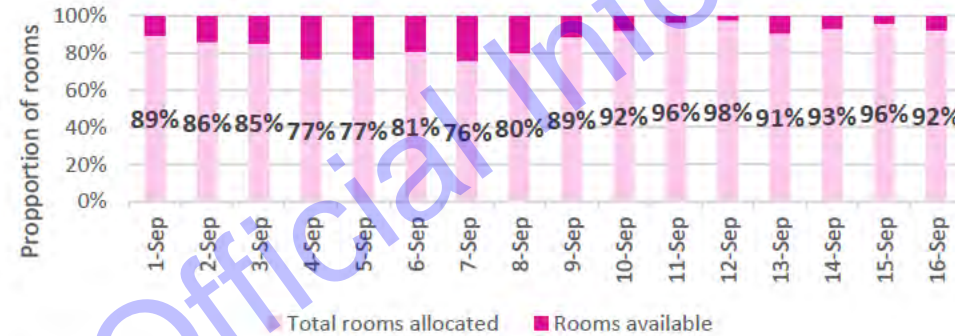

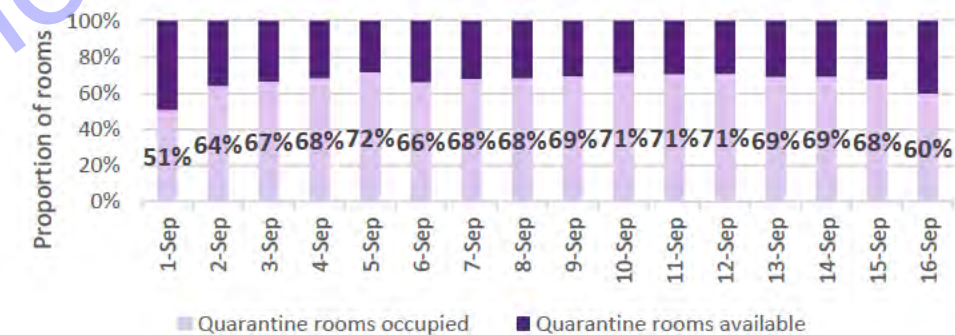

Vaccination Rates by Ethnicity

Vaccination rates among Māori (23.8%) and Pacifica (32.7%) are behind those of Asian (42.6%) and European (38.7%) populations, although these have increased by 1-2% across all ethnicities. This may be more reflective of access and age demographics than differences in vaccine sentiment. The median ages for Māori and Pacifica are 25 and 23 respectively, significantly lower than those among Asian (31) and European (41) groups.

Despite scattered protests and isolated incidents of non-compliance, the vast majority of New Zealanders are supportive of the vaccination drive. The latest vaccine hesitancy research highlights that 79% of Kiwis are actively in favour of being vaccinated, 7% are hesitant and could be convinced, 14% say they're unlikely to get vaccinated, and only 7.4% completely opposed.

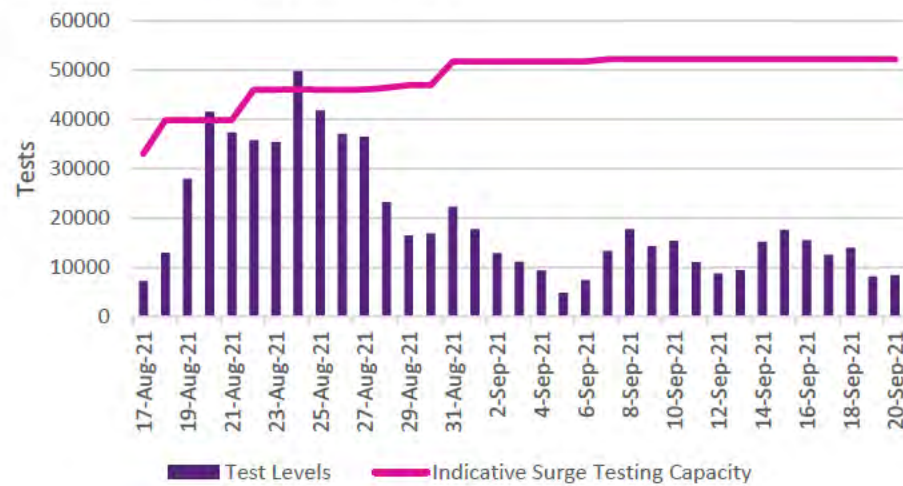

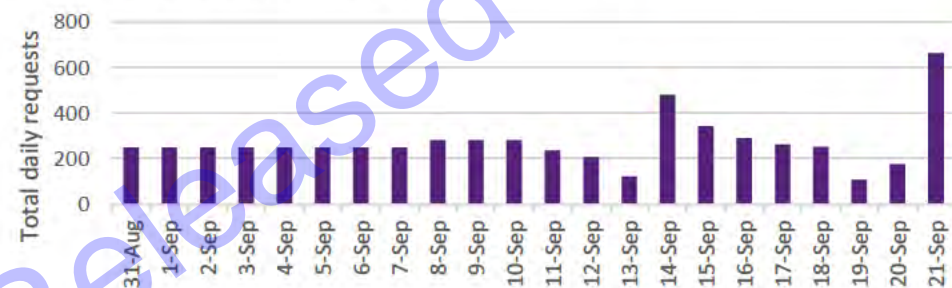

After steadily declining, these requested spiked to 664 today. Health are approving 3.28% of these requests directly on average, and receives advice on some requests from MBIE and MPI. MBIE recommends for approval to the Ministry of Health roughly 15% of requests, while MPI has recommends for approval to the Ministry of Health approximately 20-25%.

Themes of Calls to Healthline and 1737 Need to Talk?

In the 4 days leading up to Sunday 19 September, there were an estimated 1,500 – 2000 calls from people wanting to travel into the Auckland regional boundary to provide support for Aucklanders when level 3 comes into effect. Examples of support include nursing sick relatives, visiting terminally ill friends or family and providing family support. Many indicated they are prepared to make a one way crossing until Auckland moves to alert level 2. There was also an increase in calls on Sunday following the announcement of cases in Waikato. Calls relating to essential worker testing were also noted. Calls spiked again on Monday after the alert level announcement. Residents of the Upper Hauraki area reported being unable to access food and medical supplies. People asked whether Auckland will be brought down to alert level 2 if 90% vaccination levels are reached. The fact that Auckland's alert level wont be reviewed until the Tuesday after the start of school holidays was the biggest theme and cause of distress.

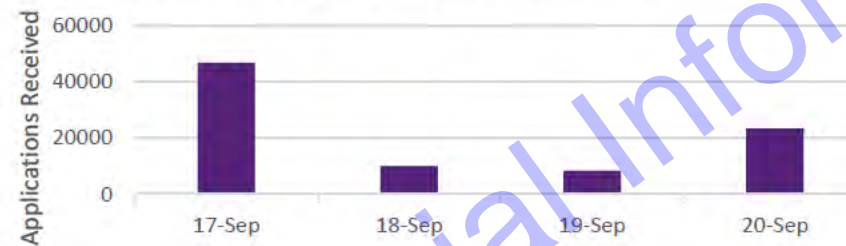

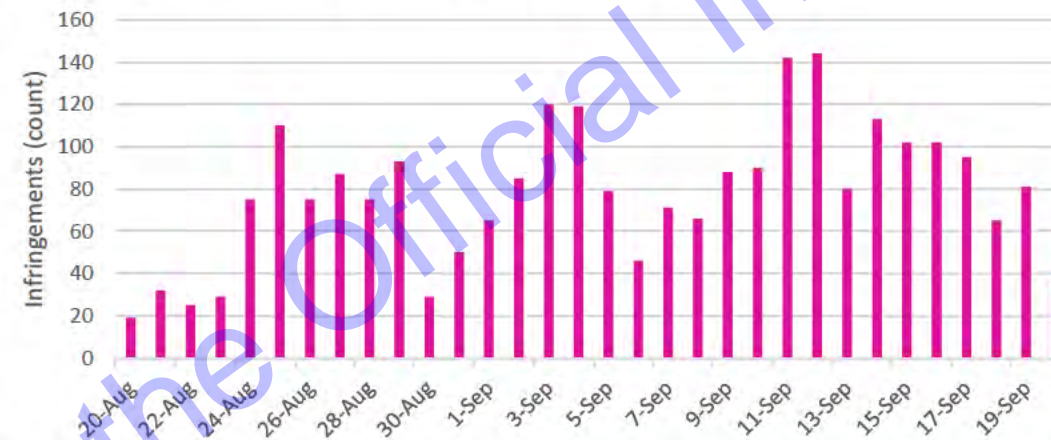

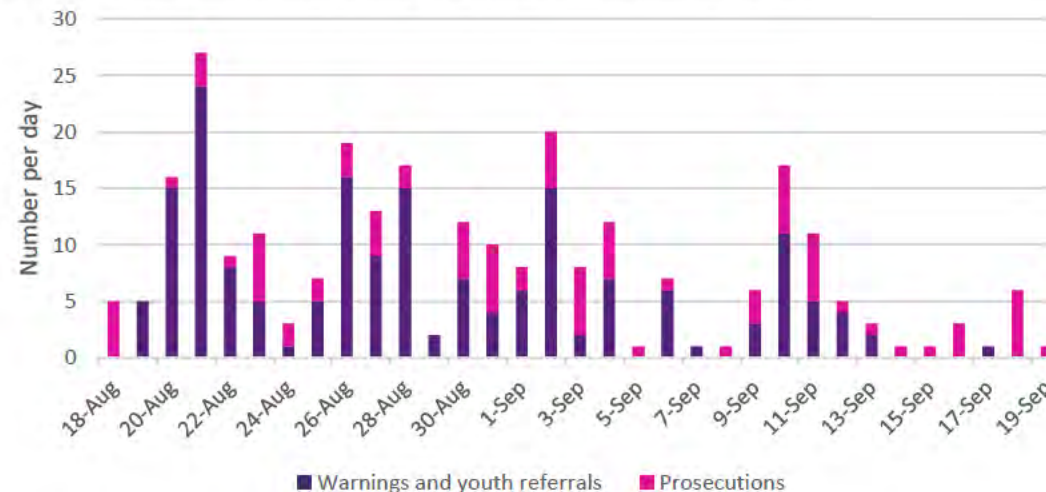

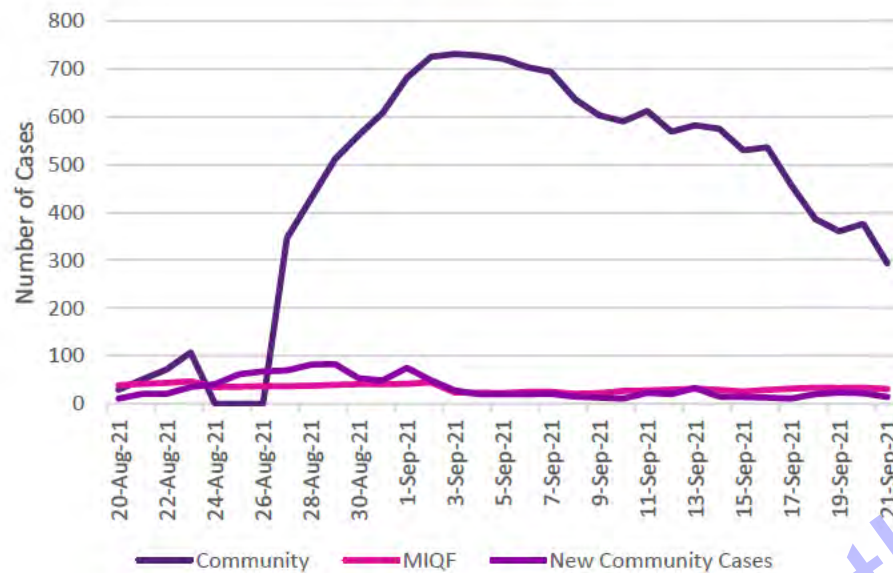

Vaccines and Ethnicity

Vaccination rates amongst Māori and Pacific Peoples remain significantly below rates for other ethnicities. The number of first doses administered to eligible Māori and Pacific Peoples are 515 per 1000 people and 665 per 1000 people, respectively. This compares to an average of 741 first doses per 1000 eligible people in the total population. This disparity in vaccination rates amongst different ethnicities is particularly large in the under 30 age group. The lower average age of the Māori and Pacifica populations compared to other ethnicities, may also explain some of these disparities as younger age groups have had less time to get vaccinated.

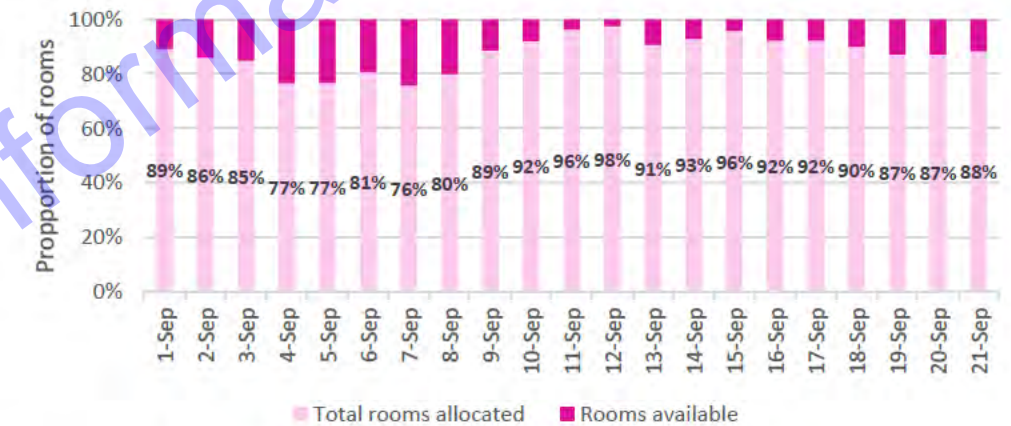

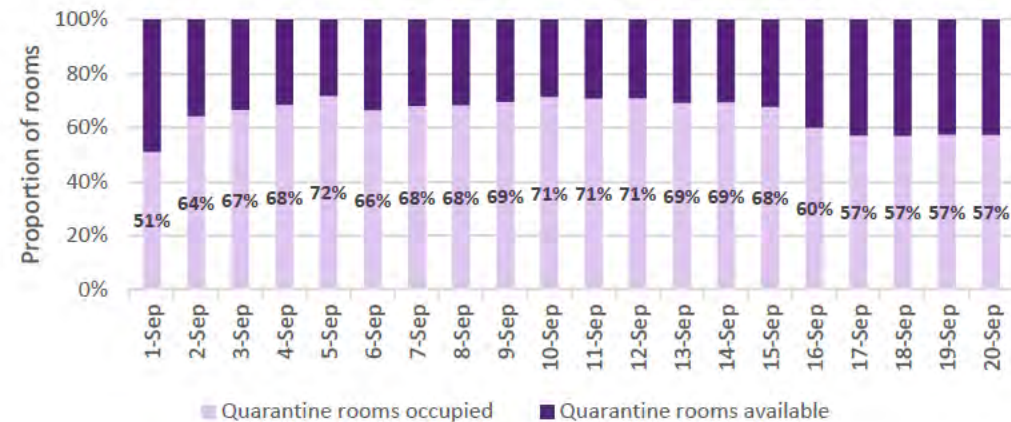

Public Sentiment

Analysis of public social media sentiment over the weekend highlighted conversation around case numbers and vaccinations, with some in Auckland feeling hopeful about an alert level change on Monday and others unsure due to case numbers rising. There was also discussion around vaccine passports, including privacy/data concerns and wondering how these would be enforced.

Most online conversation continues to focus on the virus (50% negative and 41% neutral sentiment), NZ's COVID response (47% negative and 41% neutral), the vaccine rollout (53% negative and 33% neutral), and alert level timeframes (40% negative and 44% neutral). 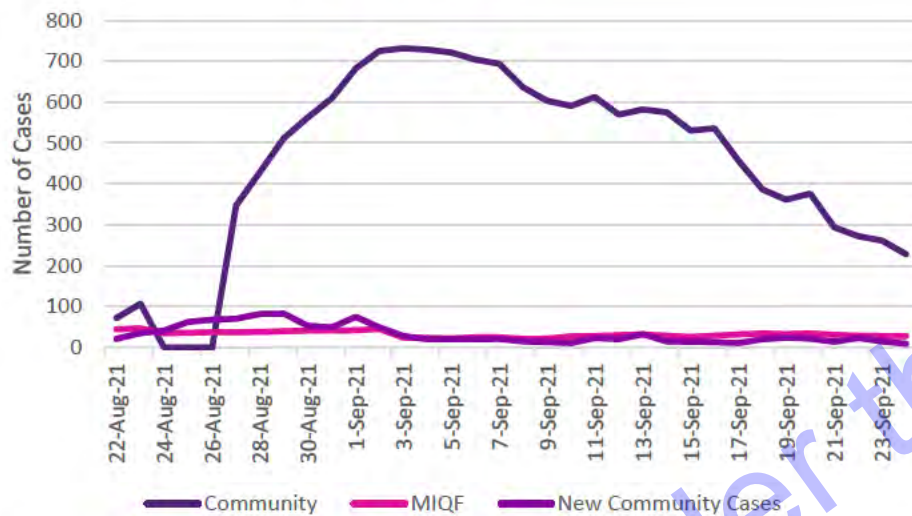

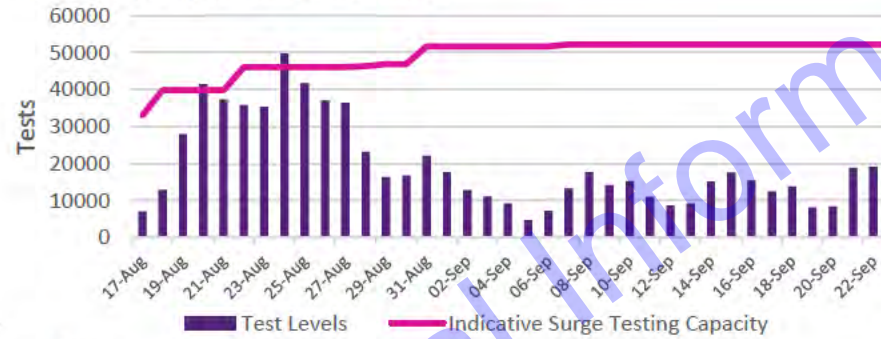

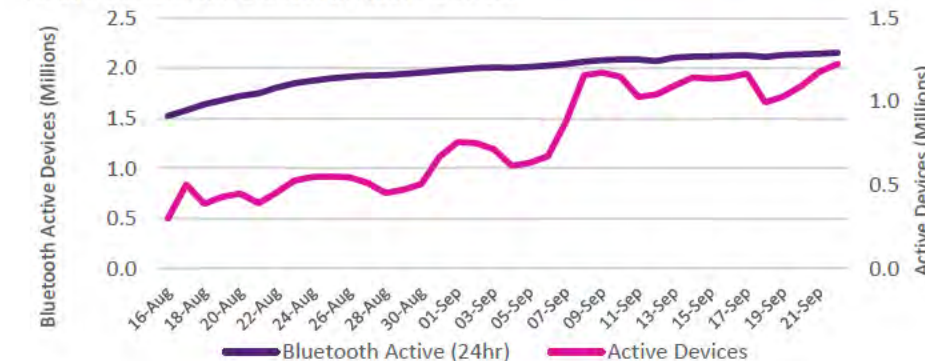

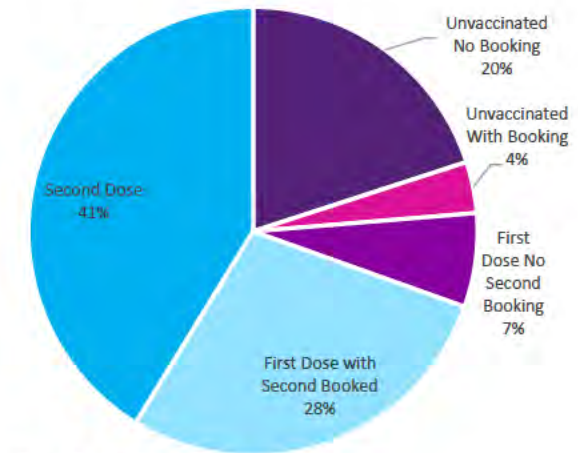
Active Devices and Bluetooth Active Devices

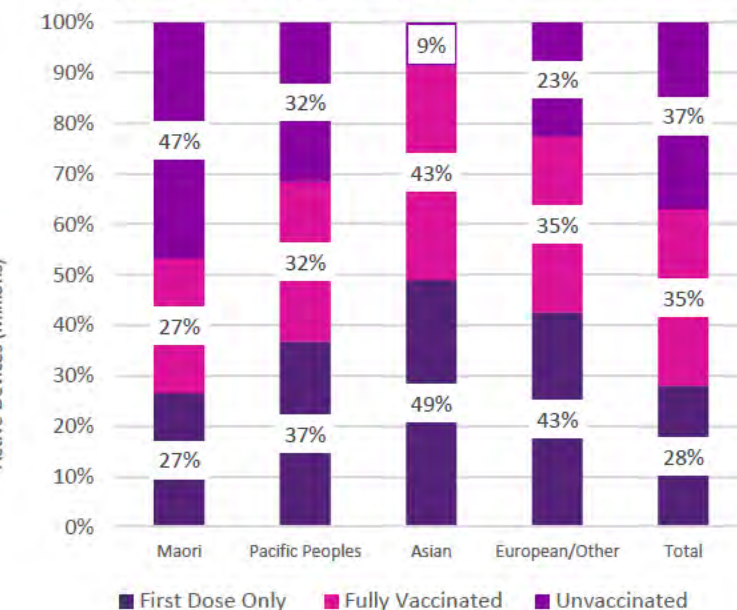

Themes of Calls to Healthline and '1737 Need to Talk?'

Recent call volumes to Healthline have reached their highest level since 1 September. The primary themes present in calls to Healthline relate to travel restrictions, boundary measures, and exemptions. Healthline is also registering growing public frustration and anxiety around entering and leaving Auckland, and regarding the persistence of AL3 restrictions for longer than expected. The new restrictions introduced in Waikato also formed the subject of a significant proportion of calls.

There are also increasing requests for information on the procedures for returning to work in AL3, while observing appropriate health and safety requirements. An emerging and growing sentiment concerns a perceived loss of 'empathy' and 'care' in the response, particularly in relation to the implementation of restrictions, fines for non-compliance, and messaging.

Public Sentiment

Analysis of public social media sentiment this week highlighted conversation around the vaccine rollout, with some New Zealanders sharing positive experiences of receiving the vaccine on social media to encourage others, prompted by the Prime Minister's 'I'm getting vaccinated too...' post. A few people were discussing misinformation, including some asking for advice on how to talk to people who believe misinformation about the vaccine, and others actively attempting to disprove misinformation online.

On Wednesday, following Auckland's move to AL3, some people were expressing frustration at businesses and customers not following mask wearing or social distancing rules, and debating the possibility of businesses adopting a vaccine mandate for customers and employees.

Most online conversation continues to focus on NZ's COVID response (42% negative and 48% neutral sentiment), the virus (45% negative and 47% neutral), the vaccine rollout (48% negative and 39% neutral), and enforcement (39% negative and 52% neutral). All categories decreased in negative sentiment on Wednesday, with the majority increasing in neutral sentiment.

Food Security and Distribution in Pacific Communities

Food security and distribution continues to be a concern for Pacific communities in the Auckland region. While MPP reports there is positive feedback coming from some groups, families and smaller community groups in Auckland report long waiting times or not receiving support. This is because the Ministry of Social Development in conjunction with the New Zealand Food Network does not fund all foodbanks and so smaller entities may not have stock to meet demand. MPP have escalated 76 requests for food through the process with MSD. However, recent developments are geared to adjust the distribution system by improving coordination between provider and supplier.

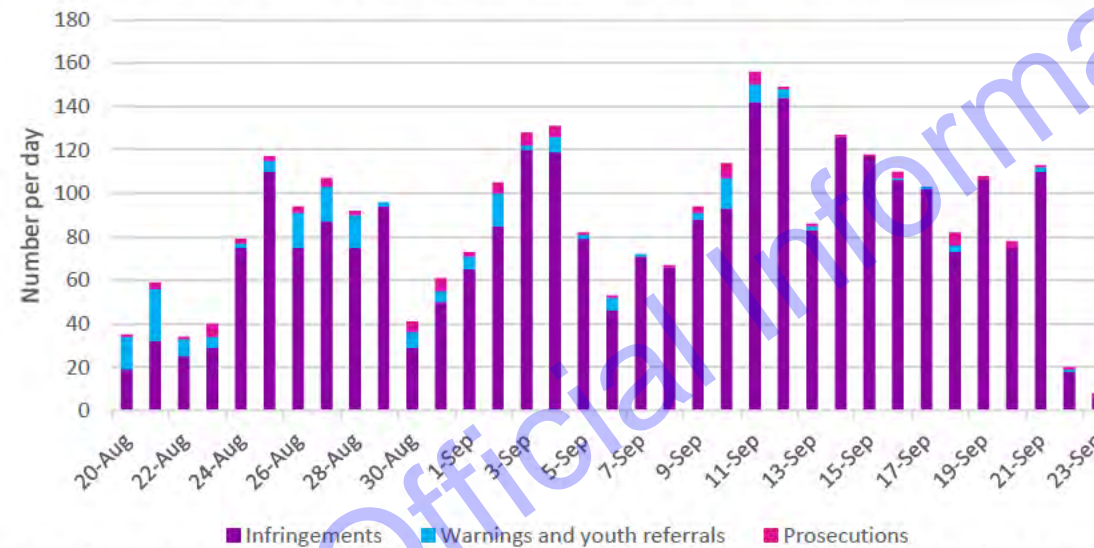
Infringements, Prosecutions, and Warnings – Low and Falling

Infringements, Warnings and Prosecutions under AL3 and AL4 – Auckland



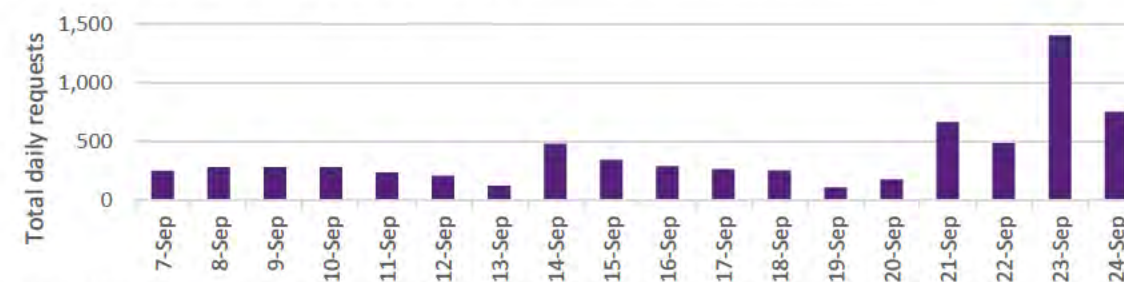

Boundary Exemptions

Over the past week, the Ministry of Health has received an average of 548 daily requests for exemptions to cross the AL4/AL3 boundary. These requests have increased markedly following the transition to AL3, from a prior average of 299. Average approvals have also risen sharply from 3.28% previously to 12-19% over the past two days. Key Issues and Risks

Vaccination Hesitancy – Vaccination Bookings Declining

The number of bookings for vaccinations have been declining since the start of September. There are 1,216,002 future bookings. A slow-down in vaccinations could have an impact on future reopening strategies, with 20% of the eligible population still to be either vaccinated or to have booked a vaccine. Vaccination levels amongst some specific communities remain below average. Vaccination levels in Māori and Pacific communities are 55% and 71% respectively for the first dose, compared to 77% across the total population. Based on the Health Service Utilisation data from the Ministry of Health, the uptake for African communities was comparatively lower than other ethnic groups. MEC has also been notified that there is particular hesitancy amongst the Congolese community due to safety concerns and misinformation, while uptake in the Rwandan community is also low.

- Next steps or mitigations if known: There are ongoing communications to encourage COVID-19 vaccination uptake. There will be an upcoming Zoom hui with the African community on the COVID-19 vaccination on Wednesday 29 September – this will provide an opportunity for MEC to hear from the African community about what further support they may need. MEC is also working with community leaders to encourage uptake amongst these communities.

Capacity to Treat Large Numbers of Severe COVID-19 Cases Constrained

Despite the relatively small number of COVID-19 cases requiring hospitalisation, there is a possibility if there are more community cases that demand will outweigh health capacity, with several regions during the current outbreak having had all ICU beds in use for non-COVID-19 cases. Recent modelling suggests if vaccinations do not exceed 90% (see '*Booking Levels for Vaccinations Declining*' section), hospitalisations could be in the tens of thousands with 7,000 deaths in one year assuming no restrictions are in place. ICU specialists have noted that hospitals would struggle to cope with the current level of beds and staff.

Anti-Vaccine and Anti-Compliance Activism Occurring

Anti-government messaging online in relation to anti-vaccination and COVID-19 compliance themes continues. Online anti-vaccination themes have included threats to public figures and officials, prominent religious figures encouraging unlawful behaviour, and anti-vaccine groups using anti-lockdown and anti-vaccine messaging to highlight their cause. Incidents of direct action related to COVID-19 have reduced in number since the beginning of the current lockdown measures, though there was a recent incident of arson directed towards a vaccination site.

COVID-19 Related Racism Occurring

This aligns with a 2021 survey by the New Zealand Human Rights Commission that shows incidents of racism towards Māori, Pacifica and Chinese have increased during the COVID-19 Pandemic.

Pacifica Food Security Issues Continue

Food supply for the Pacifica community continues to be an issue, however the level of need is gradually easing as coordination between agencies and groups takes place.

- Next steps or mitigations if known: MPP, NEMA, and MSD are working to address food security and distribution issues. MPP have completed 158 food related follow ups with most church, groups and families receiving adequate food support and 5,500 food parcels delivered to 33,000 people have been distributed by Affirming Works and Siaola.

Key Issues and Risks

Employer Vaccine Mandates Receiving Push-back

Some employers are introducing COVID-19 vaccine mandates (in addition to those already in legislation for border workers). Mandates have been enacted in some public agencies, including the Defence Force, Department for Conservation, and in the health sector for those treating COVID-19 patients. A handful of private companies are publicly considering the introduction of vaccination requirements, such as Air New Zealand, the Sudima Hotels Group, and those recruiting RSE workers. Some legislated employee vaccination requirements have already been challenged, with legal cases brought against NZ Customs and the Port of Tauranga. Responses to these mandates may escalate and cause problems for the response.

- Next steps or mitigations if known: Legal cases are ongoing. Outcomes may provide some guidance to employers going forward. PSC, Worksafe, and MBIE have advice available for employers.

Increasing Mental Health Needs

Ongoing alert level and travel restrictions can have an impact on mental health especially for people with pre-existing vulnerabilities. Ministry of Health COVID-19 Health and Wellbeing Survey showed that total population anxiety and depression levels increased to 15% in the first week of Alert level 4, which was approximately twice pre-pandemic levels and are now tracking downwards but remain elevated at around 12%. Overall, a suite of indicators of distress measured by the Health and Wellbeing Survey have been gradually trending down over the four weeks studied to date. After an initial increase in 1737 contacts, following the move to alert level 4, there has been a decrease back to prior levels. Increased attention to mental health concerns is expected in the coming days, in line with Mental Health Awareness Week.

- Next steps or mitigations if known: Ministry of Health is progressing work with the Mental Health Foundation including a wellbeing campaign for Auckland. The Mentemia app and the Wellbeing Sessions continue to be available to the public. The Suicide Prevention Office established a \$1.4 million Youth Mental Wellbeing Grants Fund, which was specifically targeted at grassroots, community level initiatives. The purpose of the fund is to help alleviate youth mental distress and ultimately lead to a reduction in suicide risk. The focus is on youth (12 – 24 years) and priority populations disproportionately impacted by the outbreak, including youth living in Auckland/Northland and Pacific youth. Funding has been distributed.

COVID-19 Infections in Gangs Occurring

Some gang members have tested positive for COVID-19. They are a high-risk cohort for contracting and spreading COVID-19. Some gang members disregard official guidelines and advice, such as self-isolation and testing. Some gangs are also disproportionately made up of Māori and Pacifica peoples who are a vulnerable group for COVID-19 transmission, with lower vaccination rates. This could have an impact on the spread of community cases.

- Next steps or mitigations if known: Government agencies, NGO's, and Police continue to engage with gang leadership to encourage vaccination and compliance within this community.

COVID-19 Infringements Ongoing

There has been a steady number of pandemic related infringements in Auckland during the lockdown period, with an average of 80 infringements a day [see the '*Infringements, Prosecutions, and Warnings*' chart later in the report]. This could have an impact on the number of community cases if people fail to follow guidelines, such as wearing a face covering or maintaining social distancing. Notably, some previously unlinked cases in the current outbreak have resulted from breaches of restrictions.

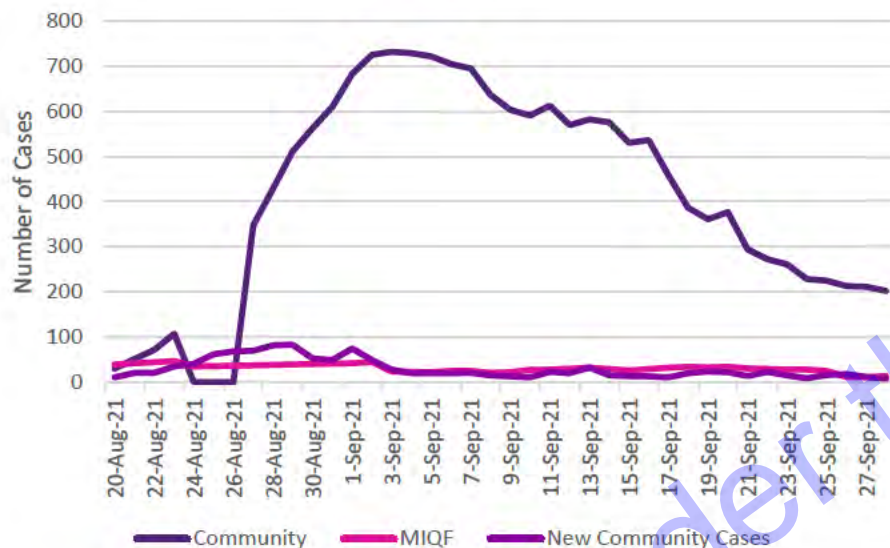

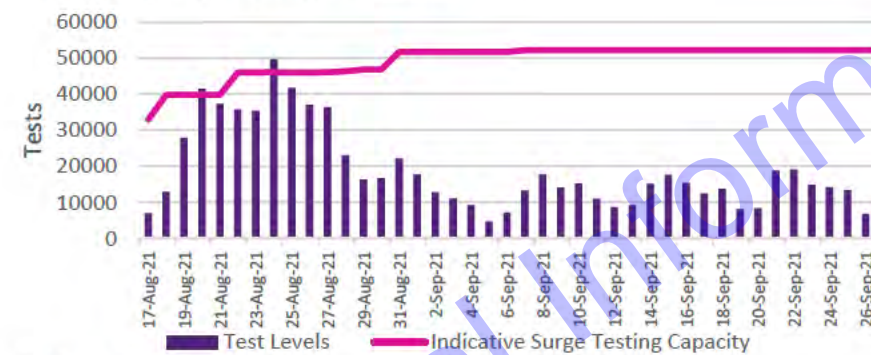

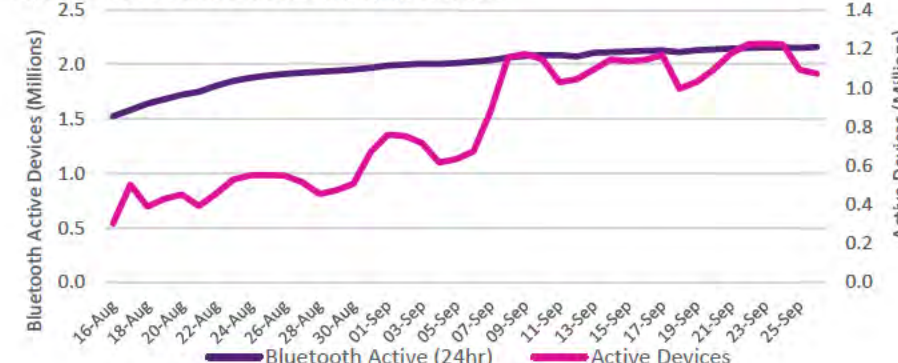

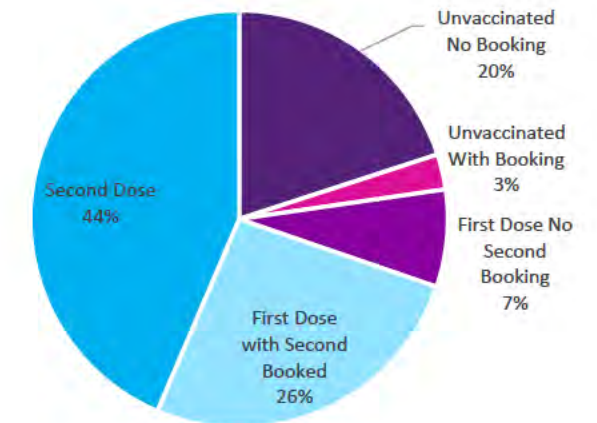
Active Devices and Bluetooth Active Devices

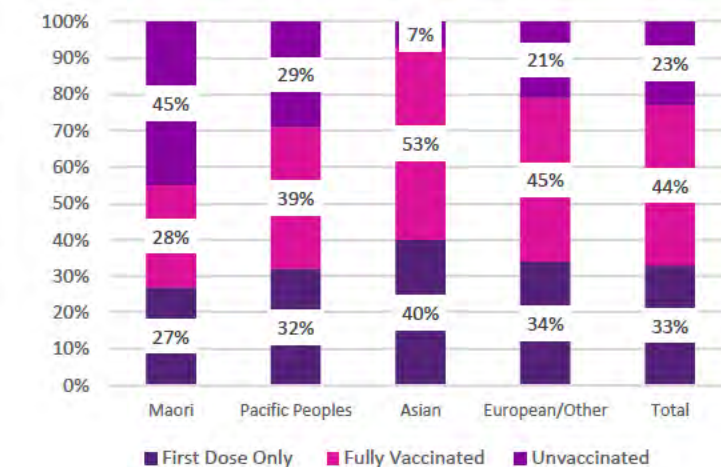


Vaccination Rate by Ethnicity

Themes of Calls to Healthline and '1737 Need to Talk?'

Calls to Healthline have now dropped to their lowest levels since the outbreak began. The proportion of calls related to COVID-19 has declined from 63-67% previously to 37-45% in recent days.

The primary themes present in calls to Healthline relate to travel restrictions, boundary measures, and exemptions, and returning to work during AL3. Healthline is also registering growing public frustration and anxiety around entering and leaving Auckland, the persistence of AL3 restrictions for longer than expected, and the differences in AL3 currently and previously. In an increasing number of instances, this translates into abuse directed towards Healthline staff.

Public Sentiment

Analysis of public social media sentiment over the weekend highlighted conversation around masks, with some people questioning the need to wear a mask after being fully vaccinated, and others asking why the South Island should need to wear masks due to having no community cases. A few people were sharing examples of good mask compliance in their communities, with some discussing the challenges of children and mask-wearing (including for autistic children) and others expressing frustration at seeing people not wearing a mask, or wearing one incorrectly. Some misinformation was noted in relation to mask-wearing not being effective.

Most online conversation continues to focus on NZ's COVID response (44% negative and 45% neutral sentiment), the virus (47% negative and 44% neutral), the vaccine rollout (50% negative and 38% neutral), and enforcement (40% negative and 49% neutral). Most categories became more neutral overall, except for 'Team of 5 Million', which increased in positive sentiment by 5%.

Transport – Vessel *Vanuatu Chief* Denied Pratique

The vessel *Vanuatu Chief*, was denied pratique on Friday after two crew signing off in a previous port returned a positive COVID-19 result. Food and Job Insecurity Ongoing

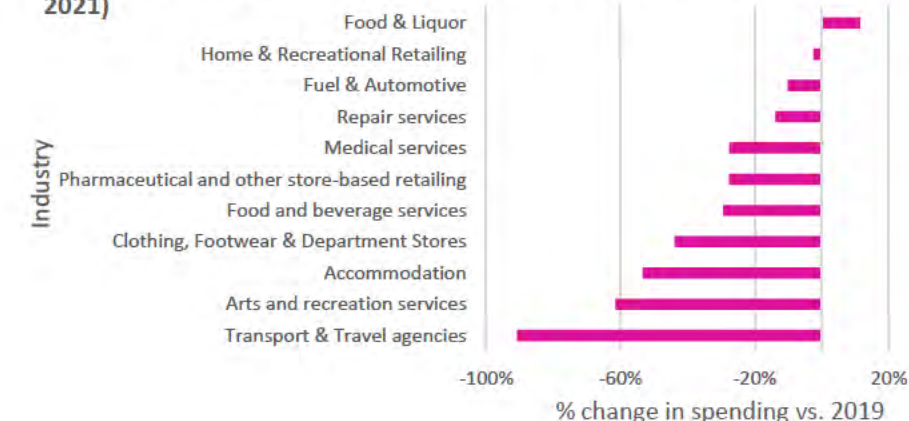

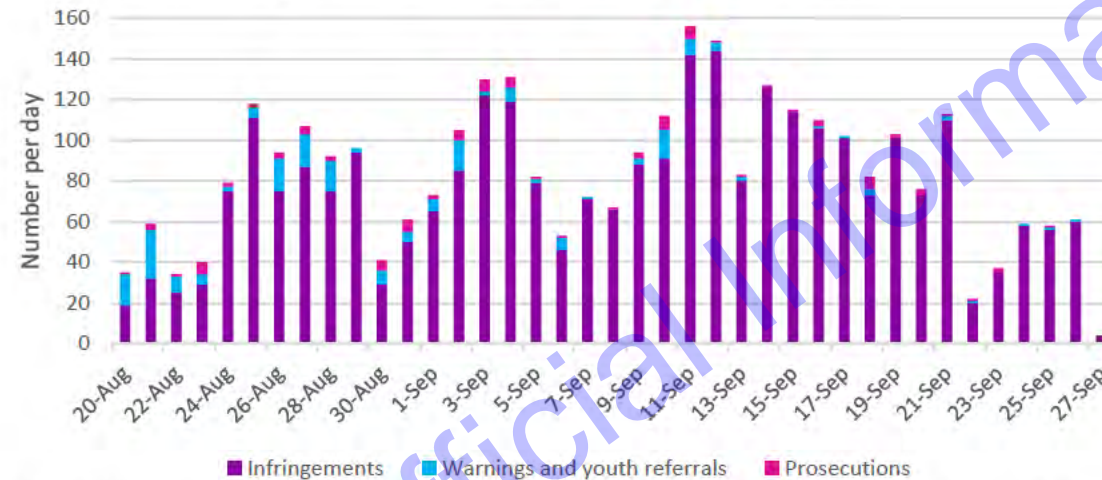

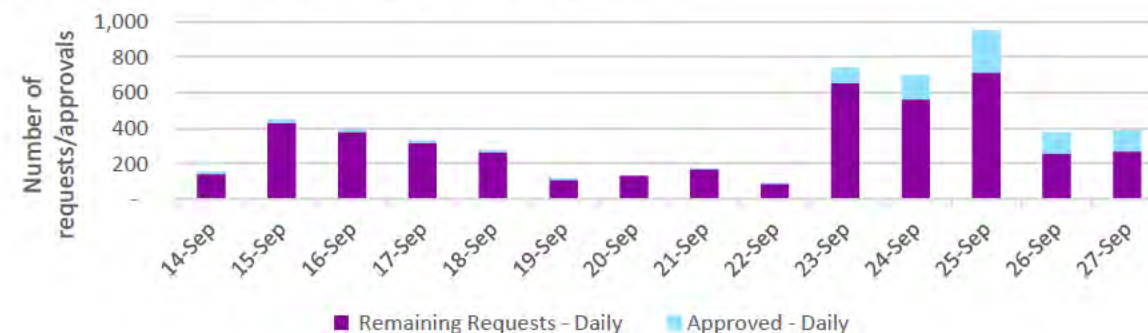
Boundary Exemptions

In the past week, the Ministry of Health has received an average of 690 daily requests for exemptions to cross the AL4/AL3 boundary. These requests have increased following the transition to AL3, from a prior daily average of 338. Average approvals have also risen from 3% in the week leading up to the alert level change to 25-32% over the past three days.

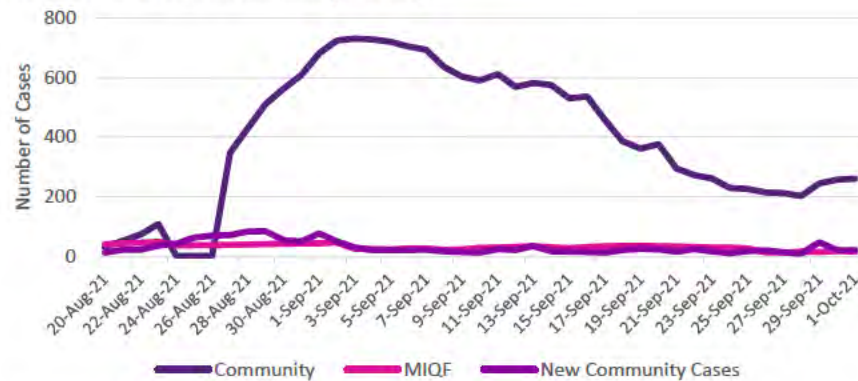

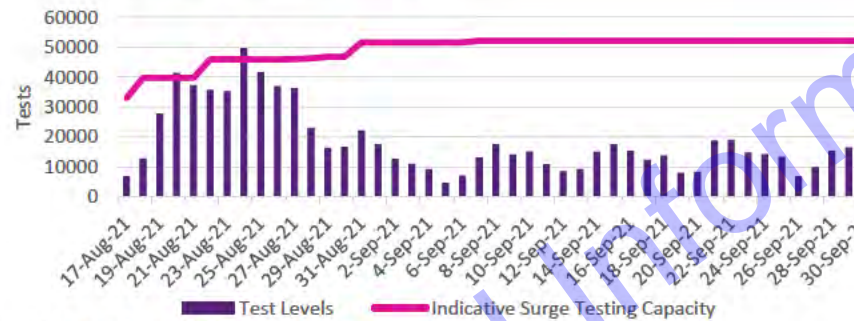

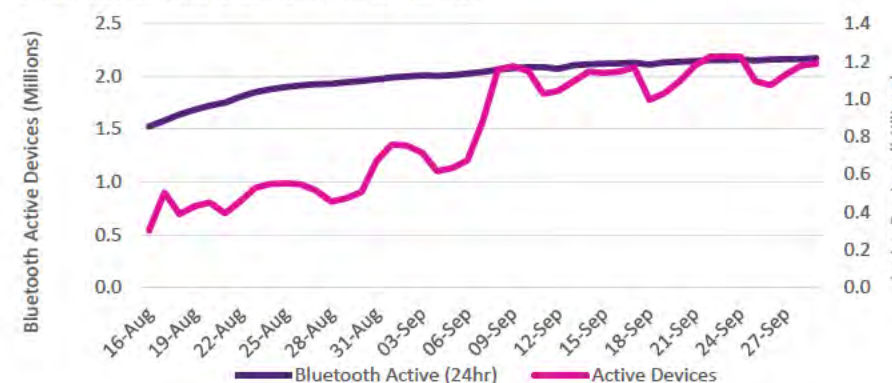

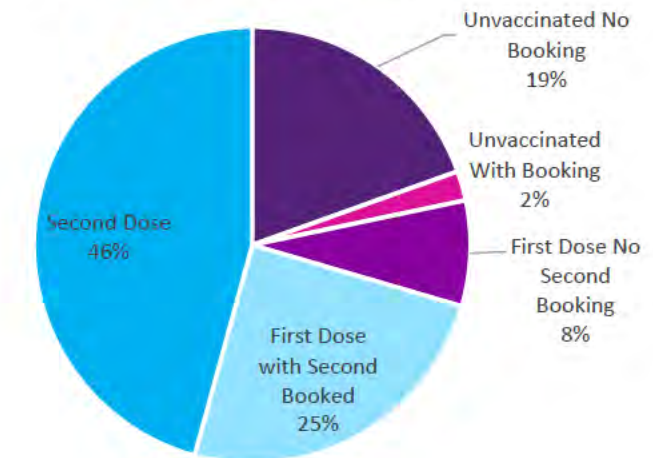
Active Devices and Bluetooth Active Devices

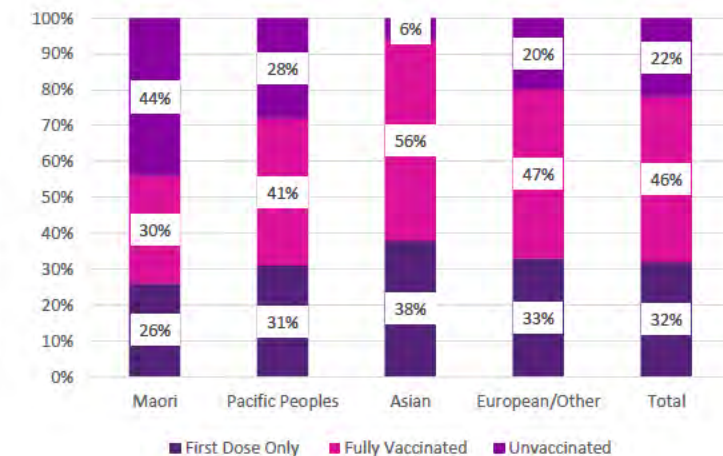

Themes of Calls to Healthline and '1737 Need to Talk?'

There were 3,723 calls to Healthline yesterday with 2,261 to the dedicated COVID-19 info line. 16% were sent for testing and 88% were seeking information.

Healthline staff are continuing to encounter abuse and frustration from the public which is impacting the workforce. The line has seen an increase in callers seeking information on COVID-19 and vaccines in recent days. There is a sense that peoples commitment to compliance is wavering. There has also been an increase in people reporting their desire to have rules around how far they can travel for exercise relaxed. There are also concerns that boundary restrictions may continue into level 2.

Public Sentiment

Analysis of public social media channels shows a 25% increase in volume in the mental health category, in particular how mental health challenges have been exacerbated by the pandemic (noting it is topical, being mental health week). Volume of conversation over the past 4 days increased by 19%, with the COVID response seeing the biggest growth in volume (up 36%).

All categories of social conversation had more negative sentiment.

Transport – Vessel *Vanuatu Chief* Denied Pratique

The vessel *Vanuatu Chief*, was denied pratique on Friday after two crew signing off in a previous port returned a positive COVID-19 result.

Testing indicates active cases on board although they continue to report as being asymptomatic. Crew are next expected to be tested on day 12 (1 October). If these tests are negative, then crew will likely remain in quarantine until after 14 days since last port of call.

An all-of-government response meeting was held on 29 September and a plan to work the vessel while under quarantine is being developed.

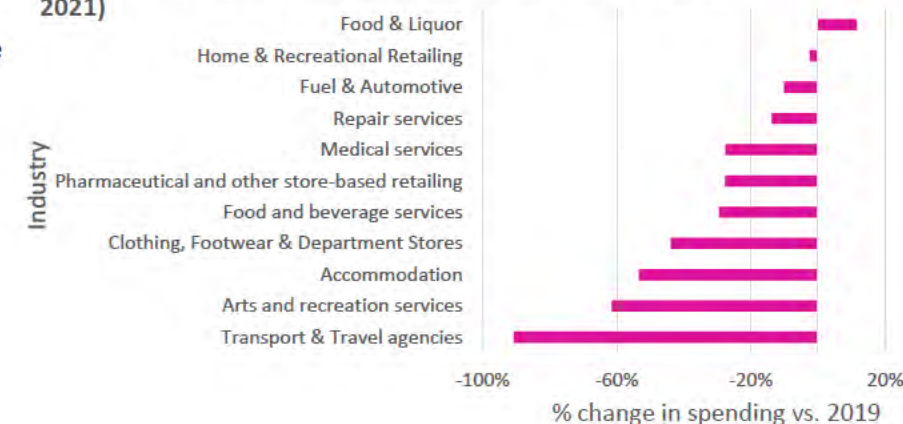

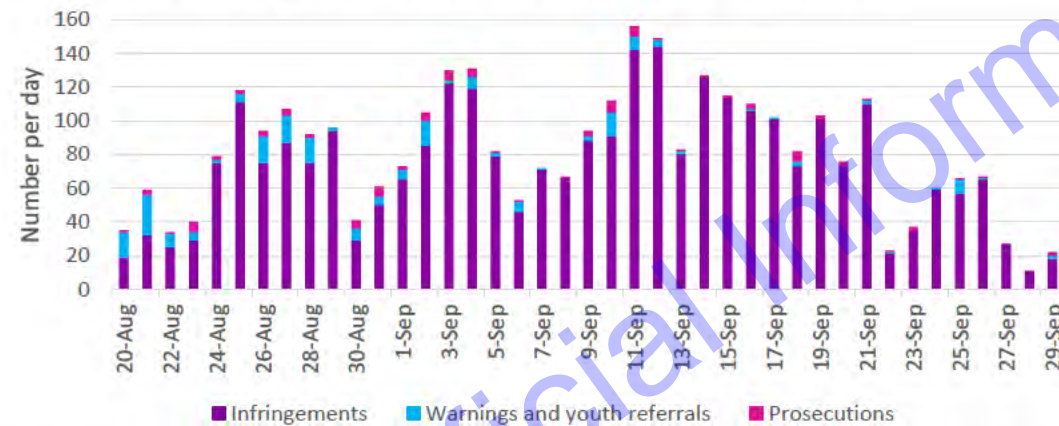

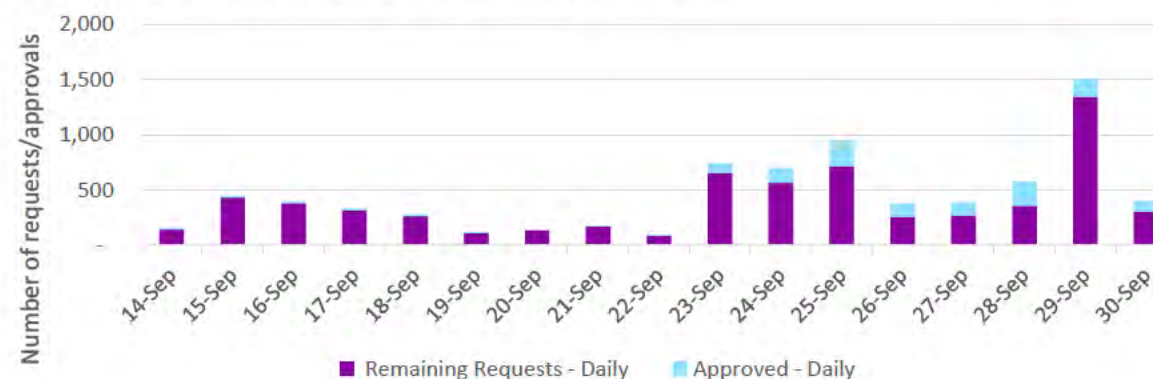

On September 29, an amendment was enacted to permit cross-boundary travel without an exemption for the purposes of relocation, to return home (from AL3 to AL2), and to provide shared care. Average approvals have risen from 3% in the week leading up to the alert level change to 26% over the past week, reflecting changes in the boundary settings.

Checkpoint Breaches

At checkpoints, 0.8% of vehicles were turned back on September 30. This is lower than the overall average of 1.59% of vehicles turned around at the border during the course of this outbreak. Exemptions for personal travel now apply, which may result in fewer breaches.

A former border worker who was previously sacked for not getting vaccinated has had her legal challenge dismissed by the high Court. She had refused the vaccine following it being made mandatory and was dismissed on May 31. Her Employment Relations Authority Case is still pending.

Key System Issues & Risks

Capacity to Treat Large Numbers of Severe COVID-19 Cases Constrained

Despite the relatively small number of COVID-19 cases requiring hospitalisation, there is a possibility if there are more community cases that demand will outweigh health capacity. Several regions during the current outbreak had all ICU beds in use for non-COVID-19 cases, and some critical medical supplies are in short supply. Medical capacity will take time to develop, and may be outpaced by cases.

•Next steps or mitigations if known: There is a full rapid review of COVID-19 medical devices and consumables within domestic supply underway with a view to centralisation under urgency.

MIQ Capacity Limited

79% of available isolation capacity is being utilised (rooms that are available fluctuate daily depending on a number of things *including* cohorting arrangements, flight schedules and rooms being repurposed for community cases). 33% of quarantine rooms in Auckland are being utilized (266 people in 139 rooms). There remain a small number of quarantine rooms available in Christchurch and Wellington maintained for usual MIQ border operations (43 and 10 rooms respectively). There are no MIQ quarantine rooms currently in the Waikato/BOP region. Work is being done to understand what could be achieved if MIQ quarantine is needed in those locations noting original concerns raised by Iwi with having quarantine in these areas.

There is growing public frustration with the capacity constraints on MIQ, both domestically and internationally. Last week, almost 23,000 people signed a petition urging the government to create a fairer managed isolation system. Recent reports suggest that the waiting list for MIQ currently exceeds 30,000. Although Government is conscious of bottlenecks and recently opened a further 3,700 MIQ rooms, the fact that approximated 25,000 overseas New Zealanders competed for these spots indicates that demand significantly outweighs supply. Some people are calling for a more tailored approach, which prioritises those returning to the country for certain reasons – e.g. to give birth or for bereavement.

•Next steps or mitigations if known: Work is underway to identify future MIQ options. If there are more community cases the system would need to flex again, noting that there are MIQ facilities in only some locations. Work is being done to understand what could be achieved if quarantine is needed in those locations noting original concerns raised by Iwi with having quarantine in these areas.

Vaccination Hesitancy – Vaccination Bookings Declining

The number of new bookings for vaccinations have been declining since the start of September. There are currently 1,009,471 future bookings, of which the vast majority (934,230) are for second doses. This implies the emerging risk of 'hard' vaccine hesitancy among the remaining population, with 19% of the eligible population yet to be either vaccinated or to have booked a vaccine.

Recent findings from Horizon Research reveals that the average anti-vaccine citizen is more likely to be younger, poorer, less educated, unemployed, rural, and Pakeha than the nationwide average. The primary concerns raised by anti-vaccine citizens include worries about unknown side effects, uncertainty about long-term side effects, and the idea that current vaccines will not be effective against new variants. Given the evidence to counter these claims, the breadth of global vaccine application, and the orientation of current vaccine bookings, these attitudes may be less flexible than may have been previously thought.

Vaccination levels among Māori and Pacific communities are 58% and 74% respectively for the first dose, compared to 80% across the total population. However, this may be less a signal of vaccine hesitancy than demographic distribution, with the average ages of Māori (25) and Pacifica (24) well below Pakeha (41).

Questions of accessibility are also being raised, particularly in relation to Māori, low-income, and elderly groups.

•Next steps or mitigations if known: There is ongoing work to encourage COVID-19 vaccination uptake, and this is increasingly linked to the lifting of COVID-19 restrictions.

Phased Approach to Reopening Receiving Mixed Response

There appears to have been a mixed response to the planned approach to reopening announced on Monday. Some people in vulnerable communities report being concerned about the changes as vaccine rates remain low in some communities and the new rules could create a high-risk situation for them. Calls to Healthline reflected unclear communications and people wanting clarification of what they could do under the new approach. Several epidemiologists also report being unhappy about the phased approach, seeking more evidence that the health system could cope with a rise in COVID-19 cases or making remarks that there needed to be a higher level of vaccination prior to loosening restrictions. Internationally, some media outlets have framed the decision as New Zealand 'giving up' on the elimination strategy.

Key System Issues & Risks

Anti-Vaccine Sentiment and Anti-Compliance Activism Occurring

Protests against COVID-19 public health measures and vaccines continues, with some 1,000 people recently gathering in Auckland for this purpose. This is underpinned by a growing weariness regarding the length and nature of restrictions as well as the differing compliance requirements across inter-regional boundaries. Police have also noted a small rise in protests at vaccination centers.

Pacifica Food Security Issues Reducing

Agency coordination regarding food supply has begun to alleviate the immediate issue of food security for the Pacifica community. However, the larger systemic issues regarding the overall need for food support remain. These issues include delays and bottlenecks related to the various levels of the multi-agency response; accessibility issues for smaller providers; and overall equity issues that Pacifica peoples face (such as lower income, higher levels of digital exclusion, etc).

•Next steps or mitigations if known: MPP, NEMA, and MSD are working to address food security and distribution issues.

Increasing Mental Health Needs

Ongoing alert level and travel restrictions are having an impact on mental health, particularly for those with pre-existing vulnerabilities. Many of the indicators of distress measured by the Ministry of Health COVID-19 Health and Wellbeing Survey have been worsening over the last five weeks. There continue to be themes in the media around increased mental health needs as a result of the COVID-19 response such as mental health needs in MIQ and the strain on business owners.

•Next steps or mitigations if known: Ministry of Health is progressing work with the Mental Health Foundation including a wellbeing campaign for Auckland. The Mentemia app and the Wellbeing Sessions continue to be available to the public. The Suicide Prevention Office established a \$1.4 million Youth Mental Wellbeing Grants Fund, which was specifically targeted at grassroots, community level initiatives. The purpose of the fund is to help alleviate youth mental distress and ultimately lead to a reduction in suicide risk. The focus is on youth (12 – 24 years) and priority populations disproportionately impacted by the outbreak, including youth living in Auckland/Northland and Pacific youth. Funding has been distributed.

Business Frustration

Some businesses are indicating that they are frustrated with the persistence of COVID-19 restrictions, particularly in the South Island. Hospitality New Zealand notes that many of its members are struggling to break even under Level 2, with limits on gatherings set at 100. While the Canterbury Employers' Chamber of Commerce acknowledges that the extension of AL2 was not unexpected, it is exerting strains on constituents. The emerging risks, in light of the lack of cases identified in the South Island in the present outbreak, include eroding understanding of the rationale for ongoing restrictions, a reduced sense of national solidarity in tackling COVID-19, and an increasing focus on the economic impact of public health measures.

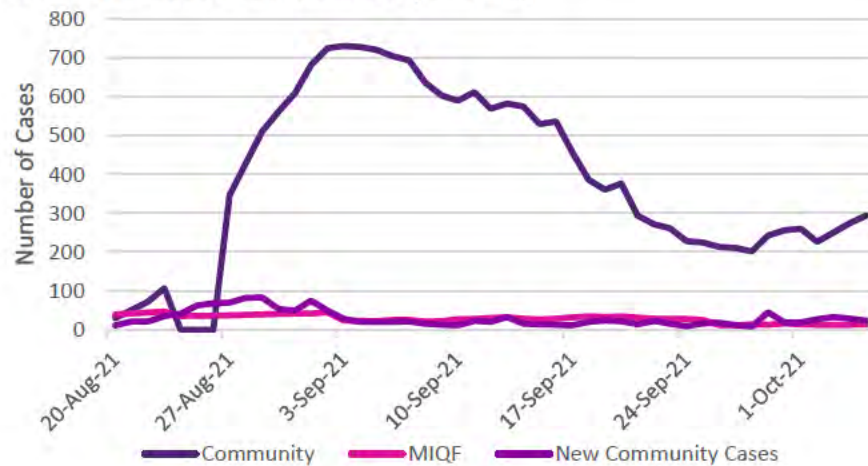

Active COVID-19 Cases Increasing

There were 24 new cases detected in the community as of 9 AM Monday, with the rolling 7-day average at 28 cases per day. By contrast, the average daily caseload in the previous week (22-28 September) was 14.

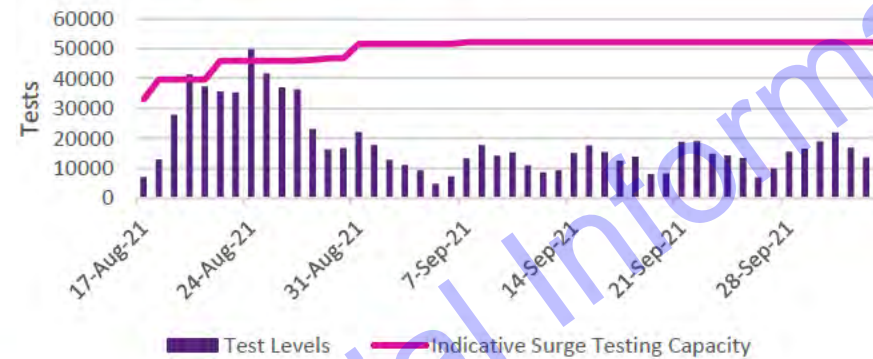

Themes of Calls to Healthline and '1737 Need to Talk?'

There were 5,416 calls to Healthline on Monday (an increase of 803 from Sunday) with 3,912 to the dedicated COVID-19 info line. 19% were sent for testing and 76% were seeking information.

Healthline staff received a number of calls expressing frustration and confusion around the changes announced on Monday for the staged reopening. Staff were unable to answer these as they had not been briefed. Themes included confusion about the rules around visitors using a household toilet, the size of the household bubble, boating and the ability to drink alcohol in public.

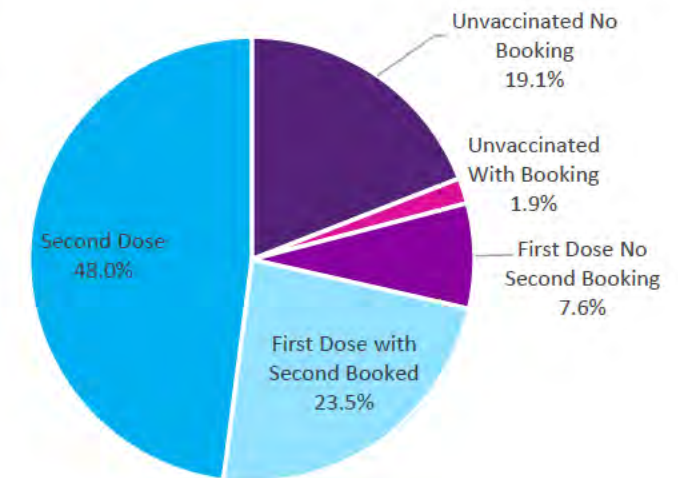
Calls also continued to be received about a perceived lack of policing of restrictions. The line has seen an increase in callers seeking information about the recent cases in the Waikato around testing and the boundary. Mental health calls were primarily related to anxiety about the alert level and travel restrictions.

Vaccinations and Bookings

There have been 3,361,425 first doses of vaccine administered and 2,105,686 people have now been fully vaccinated. There are 1,009,471 future bookings. This is approximately 81% of the eligible population that have had a vaccination or made a booking to be vaccinated. Approximately 19% of the eligible population have not received at least a first dose and do not have a booking. 934,230 future bookings are for second doses, with only 75,241 first bookings registered.

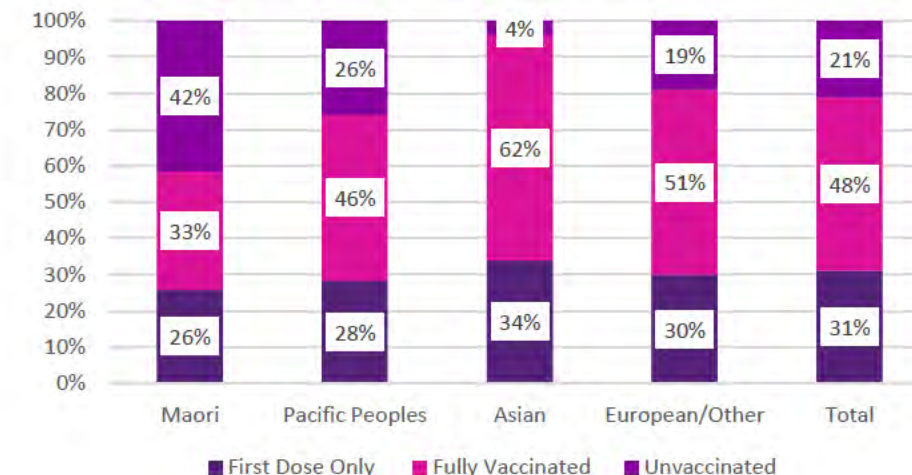

Public Sentiment

While the overall volume of COVID-19 conversation remains stable, there have been significant increases in attention to the public health restrictions over the past four days, including the timeframe (31%) and enforcement (24%). A 5% rise in negative sentiment in the Team of Five Million category implies a perceived loss of shared experience, likely as a result of the differential distribution of cases and restrictions across the country. Following mental health awareness week, mental health remains a focal point of negative sentiment (53% of recorded activity) along with domestic violence (56%) and the vaccine rollout (52%).

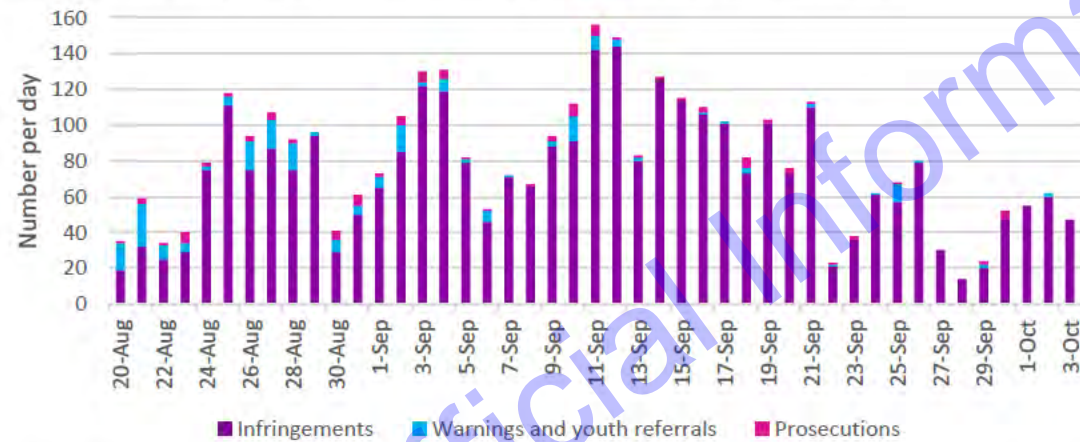
Infringements, Prosecutions, and Warnings – Low and Falling

The number of infringements has reduced significantly since Auckland shifted from AL4 to AL3, with the last week recording the lowest number since the outbreak began. Key System Issues & Risks

Capacity to Treat Large Numbers of Severe COVID-19 Cases Constrained

Active cases have reached 452, the highest level since 17 September, and with the R value at 1.2, numbers are expected to continue to rise.

Current ICU capacity is already constrained in some regions for non-COVID-19 reasons. There is no available ICU capacity in Hawkes Bay and Whanganui. There is less than 5 ICU beds available in Capital and Coast, the Bay of Plenty, the Hutt Valley, the West Coast, Lakes, Midcentral, and South Canterbury regions. There is a risk should a major COVID-19 outbreak occur in any of these regions given the ICU bed availability. There is currently eight weeks of PPE supply at high pandemic response use, and ventilators are available in all regions.

- Next steps or mitigations if known: There is a full rapid review of COVID-19 medical devices and consumables within domestic supply underway with a view to centralisation under urgency.

COVID-19 Cases Entering Hospital Emergency Wards

Some people who have COVID-19 have been arriving at hospital emergency rooms. This increases the risk of passing COVID-19 to others in the hospital. These individuals appear not to have a General Practitioner, and are likely to be using emergency or transitional housing and social services, increasing the risk of transmission of the virus.

- Next steps or mitigations if known: There is messaging asking people to call ahead before arriving at medical facilities if they suspect they have COVID-19, and to sanitise and use a mask.

MIQ Capacity Limited

There are limited spaces in quarantine, with Jet Park currently full and the 110 rooms at the Distinction Hamilton expected to be full by Wednesday.

80% of available quarantine capacity in Auckland is utilised. There are 107 MIQ quarantine rooms available in the Waikato region. There remain a small number of quarantine rooms available in Christchurch and Wellington maintained for usual MIQ border operations (9 and 42 rooms respectively). The overall MIQ system is 97% utilised (rooms that are available fluctuate daily depending on a number of things including cohorting arrangements, flight schedules and rooms being repurposed for community cases). Cohorting is done on public health advice to reduce the risk of late in stay in-MIF transmission events. It means that a facility will only take people from different flights within a 4 day window. Once that window closes, no other people will be put in that facility. This means that some rooms cannot be used because the facility is "closed". Cohorting cycles are approximately 20 days in duration.

- Next steps or mitigations if known: Options are being explored as to approaches once quarantine capacity is reached. One option is to implement caring in the community for those who have COVID-19. In response to rising complaints about MIQ the Office of the Ombudsman has commenced an investigation that focuses on how MBIE has addressed, or proposes to address future planning and allocation of spaces in the MIQ system.

COVID-19 Vaccination Hesitancy – Vaccination Bookings Declining

The number of new bookings for COVID-19 vaccinations have been declining since the start of September. There are currently 773,169 future bookings, of which the vast majority (716,335) are for second doses. This implies the emerging risk of 'hard' vaccine hesitancy amongst the remaining population, with 16% of the eligible population yet to be either vaccinated or to have booked a vaccine. 84% of the eligible population have had a COVID-19 vaccine or are booked to receive it. If all current bookings are fulfilled 75% of the population will be fully vaccinated, 9% will have had one dose and 16% will remain unvaccinated.

Vaccination levels amongst Māori and Pasifika communities are 61% and 77% respectively for the first dose, compared to 82% across the total population. However, this may be less a signal of vaccine hesitancy than demographic distribution, with the average ages of Māori (25) and Pasifika (24) well below Pakeha (41).

Recent reports have pointed to these disparities in vaccination rates between ethnic groups. In Marlborough, for example, 95% of the population of Blenheim have had their first dose, compared to 62% of the local Māori population, although it should be noted that vaccination rates amongst Māori have been increasing in recent days. It is thought that causes for this disparity in Marlborough include mistrust of the health sector as well accessibility issues including difficulty getting to vaccination centers.

Increasing Mental Health Needs

Ongoing alert level and travel restrictions continue to have an impact on mental health. People Are Concerned About the Move Away from a COVID-19 Elimination Strategy

There have been reports that many New Zealanders are concerned about the move away from a COVID-19 elimination strategy. There is particular concern amongst vulnerable communities, given their relatively lower vaccination levels. One Samoan community representative and Auckland councillor reported members of his community feeling that a higher prevalence of comorbidities will put them at greater risk in any outbreak. This is counter balanced by a feeling of lockdown weariness amongst other communities in Auckland.

•Next steps or mitigations if known: Communications regarding the strategy are ongoing.

Lack of Understanding of COVID-19 Rule Changes

Some people are confused regarding the COVID-19 rules and restrictions, particularly as alert levels change, and Auckland goes through its three-step reopening strategy. Some experts including academics in the field have also reported concern that the rule changes associated with the phased reopening of Auckland region are unclear and could exacerbate the recent outbreaks. Another example comes from the hospitality sector with industry associations reporting events being cancelled after confusion around the new limits on attendee numbers of social distancing rules at indoor events. Recent calls to the Ministry of Health's Healthline number also suggest confusion around recent rule changes with many callers seeking clarification on the new Auckland alert level rules and the wider Waikato alert level rules.

COVID-19 Amongst the Prison Population

Three prisoners who entered Mt Eden prison in October have tested positive for COVID-19, with one of the cases in hospital and the other two in prison in quarantine. Two of the three prisoners were found to have COVID-19 prior to entering the prison and the third is an associate of a positive case. This comes after another prisoner who had been bailed was found to have been carrying COVID-19 when he was brought back into custody; the prisoner in question, who was gang affiliated, has now recovered.

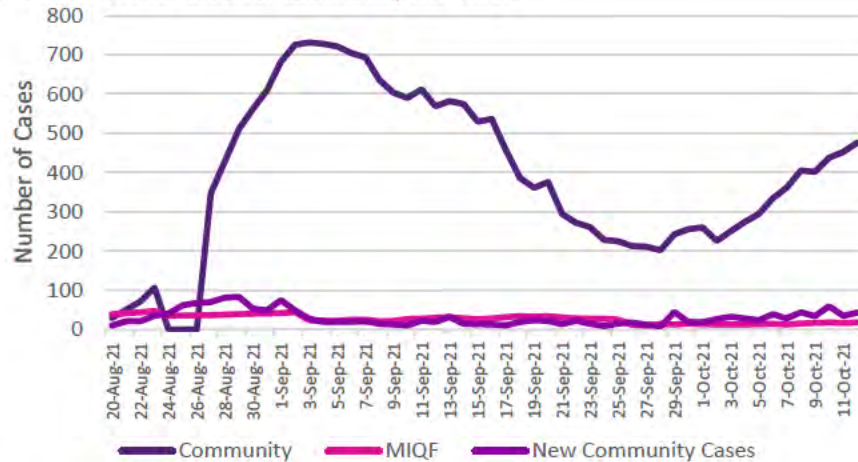

There has been an average of 29 hospitalised cases a day based on the last week, 6 cases in ICU, and 1 on ventilation. All those currently in ICU are in the Auckland area, with 1 ICU case each in Waikato Base and Palmerston North. 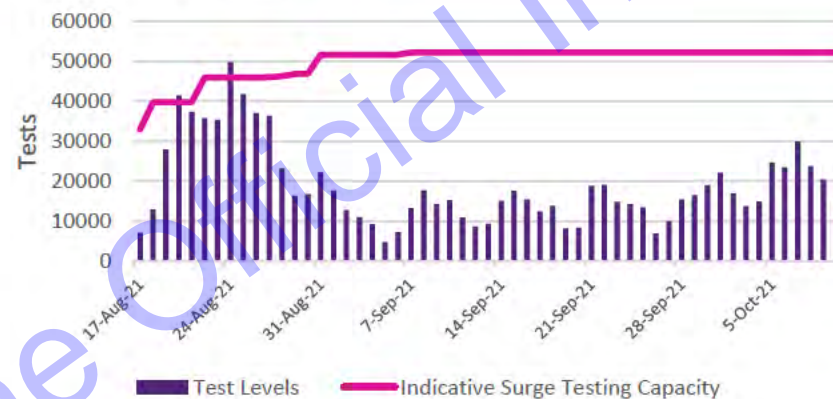

On average there were 4,579 calls to Healthline each day in the last week. 16% were sent for testing and 77% were seeking information. There is unmet demand due to the call volumes.

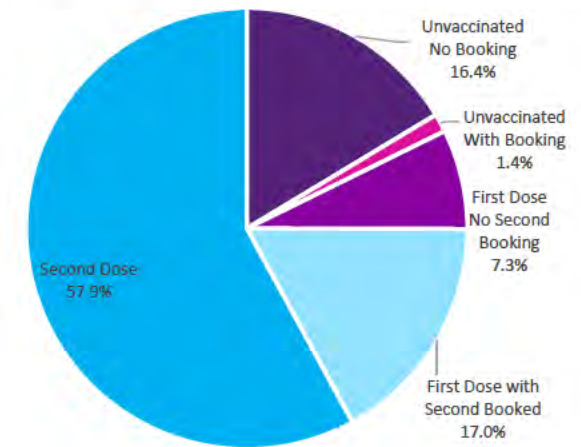

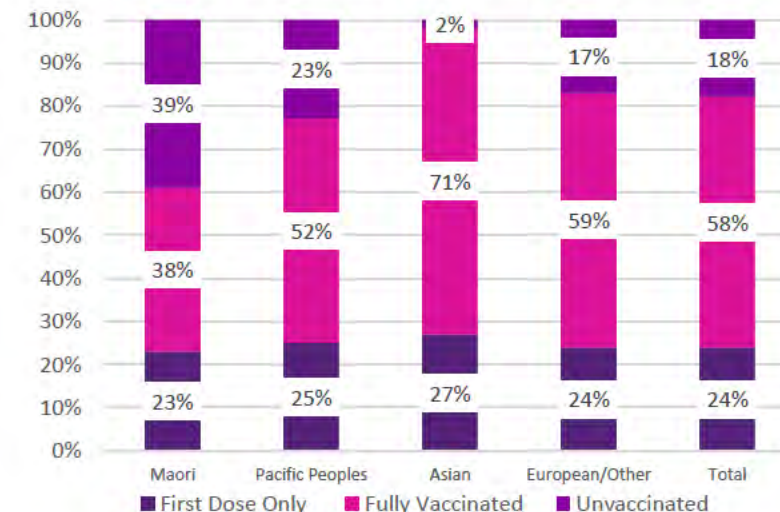

Public Sentiment

Sentiment regarding the Team of 5 Million sits at 42% negative, 39% neutral and 19% positive with only minor changes from the previous four days. Discussion around the vaccine rollout and vaccine passports has increased by 74% with overall sentiment 53% neutral, 38% negative and 9% positive.

While some are discussing the logistics of getting vaccinated, there is some acknowledgement of vaccine passports as a necessity and concerns that it will create a divide between those who are, and are not, vaccinated.

A noted theme is the connection between individuals booking a vaccination and the announcement of the introduction of a vaccine passport. This indicates that while some may be opposed, the necessity of having one (in the same vein as a passport or a drivers license) may have motivated them to get vaccinated.

Mental Health and Domestic Violence are the categories with the highest negative sentiment (58% and 54% respectively) and lowest positive sentiment (5% and 3% respectively).

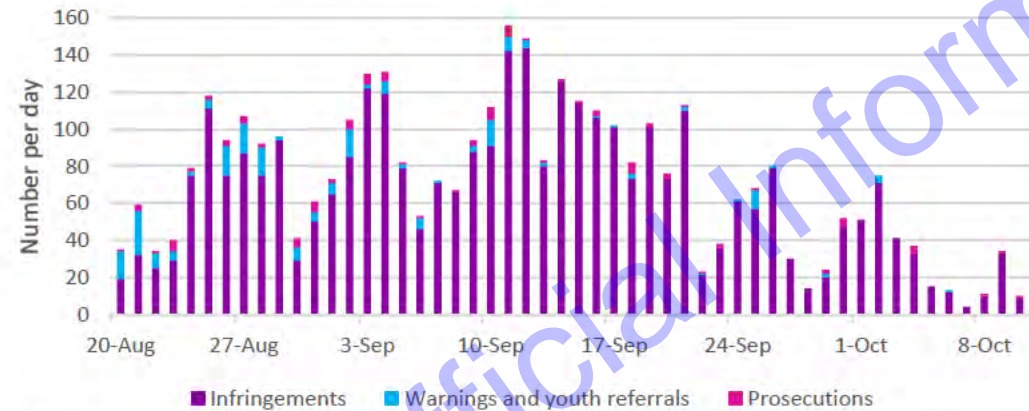

Active COVID-19 cases are expected to increase in the coming days with the R value approximately 1.34 (as of 15 October). There are currently 633 active COVID-19 cases, just 18 less than the peak observed on 3 September 2021.

Capacity to Treat Large Numbers of Severe COVID-19 Cases Constrained

Whilst ICU capacity can currently meet demand, ICU availability is limited in most regions and is likely to be an issue should a major outbreak occur. There is ICU capacity at all DHB's except for Wairarapa, Hutt Valley and South Canterbury where all ICU beds are taken by non-COVID-19 patients. The majority of ventilator capacity remains available nationwide. Current PPE usage remains at low pandemic usage, however, there have been increased orders from the primary care sector. There is currently eight weeks of PPE supply at high pandemic response use. There are supply challenges for particular items.

COVID-19 Vaccination Bookings Declining

The number of new bookings for COVID-19 vaccinations have been declining since the start of September. There are currently 487,123 future bookings, of which the vast majority (457,203) are for second doses. This fall in bookings in of itself does not imply vaccine hesitancy as bookings are expected to decline as people get vaccinated. Additionally, some people will opt for a "walk-in" vaccination without a booking, whilst others will have booked directly with vaccination sites and not through the central booking system.

The number of eligible people who are yet to be vaccinated or book is 596,315.

The combined number of people either getting vaccinated or booking to get vaccinated remained steady over the last couple of weeks. This may have been affected by the Vaxathon.

86% of the eligible population have had a COVID-19 vaccine or are booked to receive it. If all current bookings are fulfilled 78% of the population will be fully vaccinated, 8% will have had one dose and 16% will remain unvaccinated.

Vaccination levels amongst Māori and Pasifika communities are 67% and 81% respectively for the first dose, compared to 86% across the total population. However, this may be less a signal of vaccine hesitancy than demographic distribution, with the average ages of Māori(25) and Pasifika (24) well below Pakeha (41). It should also be noted that ethnicity data for those who receive "walk-in" vaccinations may not be collected.

- Next steps or mitigations if known: Communications are ongoing to increase vaccination rates. Recent events such as the Super Saturday Vaxathon have helped to increase vaccination rates. There have been calls for further events including smaller less centralised events focusing on particular communities.

MIQ Capacity Limited

MBIE are currently operating three quarantine facilities in Auckland. There were 210 quarantine rooms available out of 554 (38%) but with the trajectory of cases in Auckland (87 today) these will likely soon be full. MBIE intend to add approximately 100 additional rooms at one of these facilities tomorrow (mostly single rooms). There remain a small number of quarantine rooms available in Christchurch and Wellington maintained for usual MIQ border operations (13 and 42 rooms respectively). There are 93 MIQ quarantine rooms available of the 110 in the Waikato region.

The current surge in community cases, and their close contacts, and availability of quarantine rooms continues to be a challenge. The numbers of people required to go to MIQ continues to rise meaning the remaining rooms in Auckland are quickly running out. It has been observed that attendees are remaining longer than usual in MIQ with positive cases joining existing bubbles. MBIE also report a lack of visibility around planning across the rest of the country from entities other than MIQ for quarantine should there be outbreaks outside of Auckland. There has been an increase in complexities in managing 'higher needs' people within MIQ. This includes managing mental health, people with drug and alcohol addictions, people with gang affiliations and exhibiting violent and aggressive behaviour. This is placing strain on facilities and staff.

Staff Shortages

Some organisations have been unable to train staff during the high alert levels, and are now experiencing labour shortages. This has been raised by the Transport industry, with trainee bus drivers in Auckland unable to sit Class 2 licence tests due to the COVID-19 restrictions. This is compounded by a significant driver shortage and it is anticipated that normal services will not be able to resume when alert levels are lowered. In August, 1,754 bus services in Auckland were cancelled due to this issue and similar issues emerged in Wellington in June. Reduced services due to driver shortages are likely to create further issues such as overloading remaining capacity, imposing extended delays, preventing workers (including critical roles) from getting to work, increasing traffic congestion and raising general societal stress levels and frustrations.

Increasing Mental Health Needs

Call volumes to Healthline have increased to a consistent level of up to 4,500 calls per day with non-COVID-19 calls (primarily mental health and addiction) an increasingly unmet demand. Common themes in recent calls to Healthline were frustration and anger at isolation and ongoing lockdowns; reports of breaches due to protest activity in Auckland Domain; as well as people concerned about being exposed to the virus as a result of being at the Domain; confusion on what the current alert rules mean; alarm and distress at Air New Zealand cancelling flights into and out of Auckland; and vaccinations.

Lack of Understanding of COVID-19 Rule Changes

Some members of the public are expressing confusion about operating at, or transitioning to, a particular alert level, particularly regarding mixed travel requirements, and the staged reopening.

Alert Level Boundary Breaches

The media is reporting that it is easy to bypass alert level boundary checkpoints (with people hiding in car boots for example). Some individuals associated with these breaches, who have tested positive for COVID-19 have not been cooperative with authorities in disclosing the locations they have visited which has made tracing newer outbreaks more difficult. Additionally, the complexity of travel exemptions make enforcement difficult to apply consistently and has the potential to erode public confidence.

Concerns About the Move Away from a COVID-19 Elimination Strategy

The recent lowering of alert levels has raised concerns about Māori and Pasifika being left more susceptible to the virus due to lower vaccination rates and reduced health outcomes overall. These concerns have been voiced by both the respective communities and some health experts. This raises tensions between those with concerns about reducing restrictions and those wanting them reduced (often due to the social and economic pressures created by them).

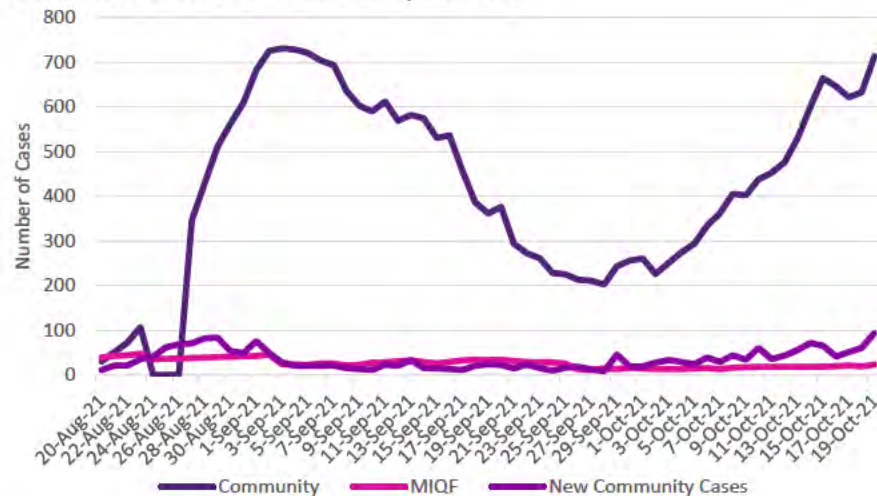

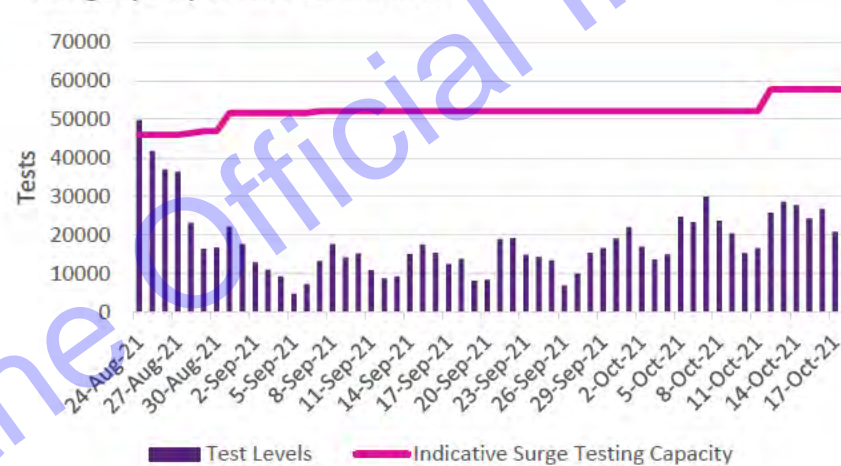

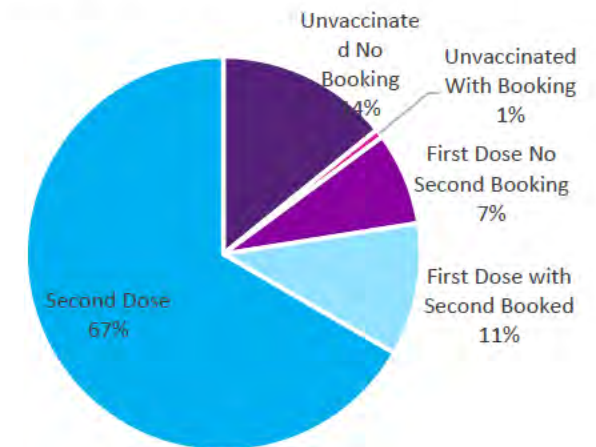

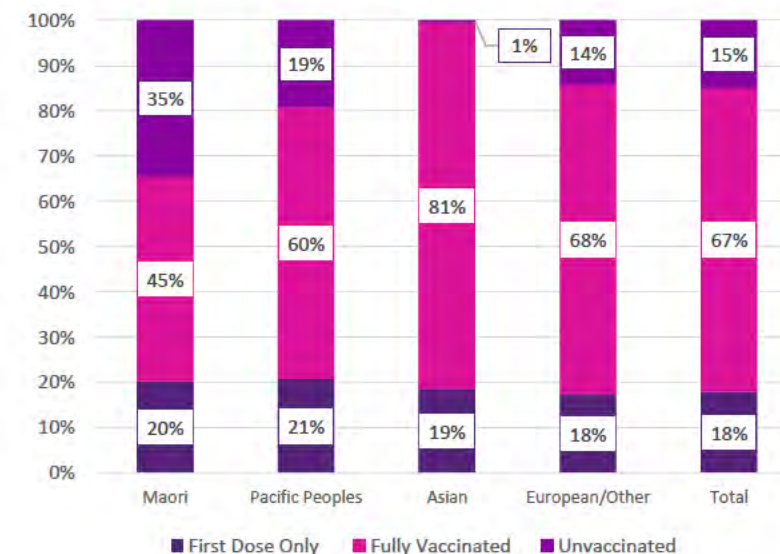

Public Sentiment

Analysis of the online public conversation regarding responses to the alert level review were diverse, with themes including those who want more freedoms and others who want to move back to level 4 in Auckland given the increased case numbers. It was also noted that some people are feeling judged by others living outside of Auckland. Others are finding it difficult to grapple with the logic behind the current alert level.

Over the 4 days to 13 October, the volume of conversations around the vaccine rollout increased by 6%, and discussion regarding how long the current alert level restrictions will last increased by 13%, compared to the 4 days prior. The volume of conversation around all other related topics fell over this period. Overall, sentiment around COVID-19 related issues remained stable over the past 4 days

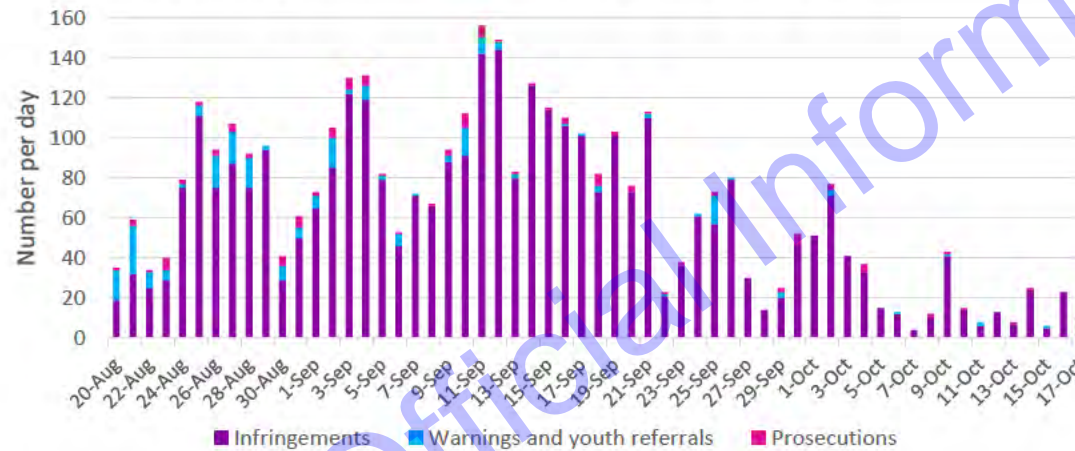

Anti-Vaccine Sentiment and Anti-Compliance Activism Evolving

There have been several recent protests and petitions. A demonstration was held outside the Wellington High Court on Thursday 21 October in support of the hearing challenging the legality of vaccine mandates for frontline workers. The group of around 60 protestors gathered on the footpath outside the High Court. The group contained members of Voices for Freedom and the Outdoors Party. A number of other protests against lockdowns and vaccine mandates have also been reported in recent weeks in different locations.

Increasing Mental Health Needs

The Ministry of Health's Mental Health and Addiction phone line is at full capacity resulting in unanswered calls. Should unanswered calls continue to climb there is an increasing clinical risk. The phone line has been at full capacity for around three weeks now.

Concerns Arising From Government's new COVID-19 Framework

There has been some concern raised by the organization representing the retail industry, Retail NZ, that there is no date announced for the move to the government's new COVID Protection Framework. They raised that this may make it difficult for businesses to plan and stay afloat. Restaurants Association NZ have also mentioned that there is concern amongst the hospitality sector on vaccine passports and that 30% of its members oppose a vaccine certificate system because they are concerned over how they can monitor customers entering the premises. Counterbalancing the desire from sectors of the business community to limit measures, there were concerns that new framework may leave some communities vulnerable to outbreaks. There was some concern that the vaccination threshold used to determine the easing of restrictions was based on population vaccine coverage and does not include a requirement for coverage amongst Māori and Pasifika communities.

- Next steps or mitigations if known: Communications are ongoing to explain the new framework and its relation to the 90% vaccination level, with the main overall focus on encouraging New Zealanders to get vaccinated.

Secondary School Students Return to School – Issues facilitating Reopening

The New Zealand Post Primary Teachers Association (PPTA) have expressed some concerns around school returns in the midst of higher COVID-19 case numbers particularly in Auckland, and because vaccination levels amongst 12 – 19-year-olds remain low compared to the rest of the population. It was also noted at one school in Auckland which has a particularly high Māori and Pasifika population that things appear inconsistent as others in their community are being asked to limit travel and stay at home whilst the children are going to school. Some Auckland schools will continue online learning for senior students despite upcoming NCEA exams. One school principal announced that it would not be practical to open on 26 October and that the announcement contained some ambiguous messages. There has also been an increase in calls to Healthline relating to schools reopening.

- Next steps or mitigations if known: Children, young people and staff at higher risk should stay at home unless vaccinated, face coverings are mandatory for staff and learners in years 9 to 13 as well as on school transport and records are kept for the purposes of contact tracing.

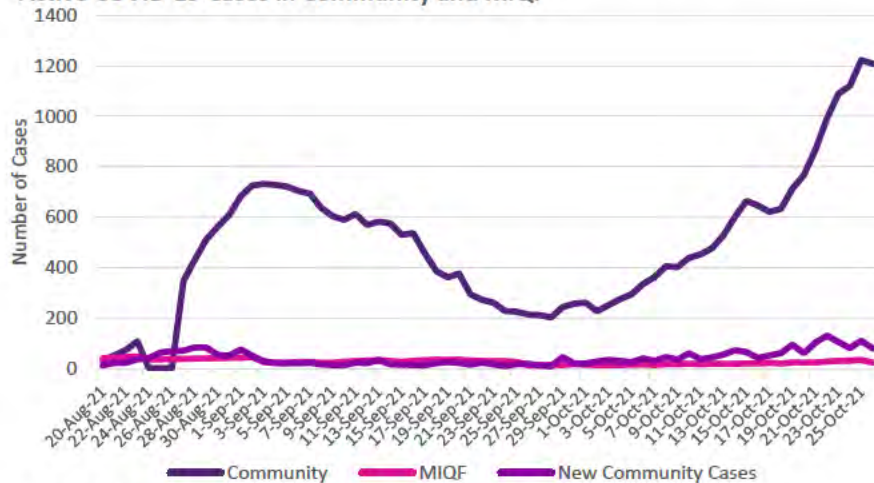
Health

Active COVID-19 Cases Increasing

The number of active COVID-19 community cases has increased to 1,209 on 26 October 2021, with a peak of 1,223 on 25 October 2021. The rolling 7-day average is 94 cases per day compared to 62 per day on average in the previous week (13 October – 19 October). The peak 7-day case fatality rate during this outbreak has been 0.92% compared an overall maximum during the pandemic of 9.10% recorded in February.

August Community Cluster

54% of the August Community Cluster cases were unvaccinated, with a further 20% ineligible for vaccination as they are under 12 years of age. 79% of those hospitalised were either unvaccinated or ineligible, and 19% had received just one dose of the vaccine. Only 1% of those hospitalised were fully vaccinated at least 14 days prior to the case being reported

Health System

There has been an average of 45 hospitalised cases a day based on the last week (up from 33 the week before), 5 cases in ICU (the same as the previous week), and 2 on ventilation (the same as the previous week). All those currently in ICU are in the Auckland area.

ICU Beds and Ventilators

There is ventilator and ICU capacity available at all DHBs (no data available for Northland). Available capacity at Auckland DHB is approximately 20 ICU beds and 60 ventilators.

Waikato DHB has less than 10 ICU beds and just over 20 ventilators available.

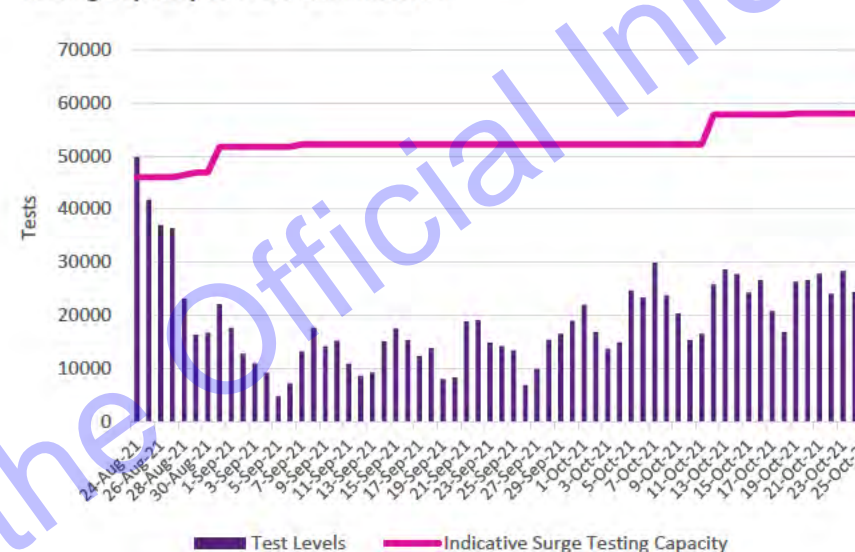

Testing Levels Rising

After testing levels peaked at 49,745 on 24 August 2021, they declined reaching a low of 4,750 on 5 September 2021. Testing levels were at 14,430 for 25 October with a 7-day rolling average of 24,579 compared to 24,413 for the previous week.

Themes of Calls to Healthline and '1737 Need to Talk?'

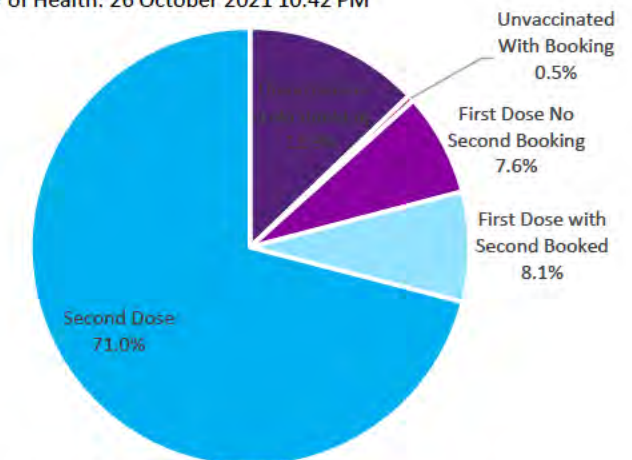
On average there were 4,159 calls to Healthline each day in the last week, up from 4,214 over the previous week. On average 16% were sent for testing. 24% were sent for testing on Sunday with a general increase in the numbers of people reporting cold/flu like symptoms. There has also been an increase in calls from Police to confirm testing for people arrested/in custody. There has also been an increase in calls from people who have tested positive, or are living with positive cases, regarding MIQ. Business owners have been making calls seeking advice after being identifies as exposure events. Abuse towards Healthline staff also rose over the weekend, indicating growing public frustration. Mental health and addiction contacts rose over the weekend with a number of contacts going unanswered.

Vaccinations and Bookings

There have been 3,646,869 first doses of vaccine administered and 2,987,389 people have now been fully vaccinated. There are 361,270 future bookings, with 20,010 for first dose and 341,260 for second. This means approximately 87% of the eligible population have had a vaccination or made a booking to be vaccinated. Approximately 13% of the eligible population have not received a first dose and do not have a booking. However, it should be noted that booking data does not account for those who receive walk-in vaccines.

Public Sentiment

Analysis of the online public conversation during October 16-20 revealed a shift in emphasis away from the vaccine rollout, the impact of restrictions on businesses and consumers, and the virus itself, toward the COVID-19 response and the timeframe of public health restrictions. These two topics registered the largest increases in attention, up by 6% and 33% respectively. By contrast, online conversation dealing with the vaccine rollout fell by 20%, while focus on the virus reduced by 5%.

This reflects widespread public anticipation of the COVID-19 Protection Framework, launched on Friday. The overall volume of conversation increased by 2% throughout this period compared with previously, and there was a general tilt toward negative and neutral sentiment.

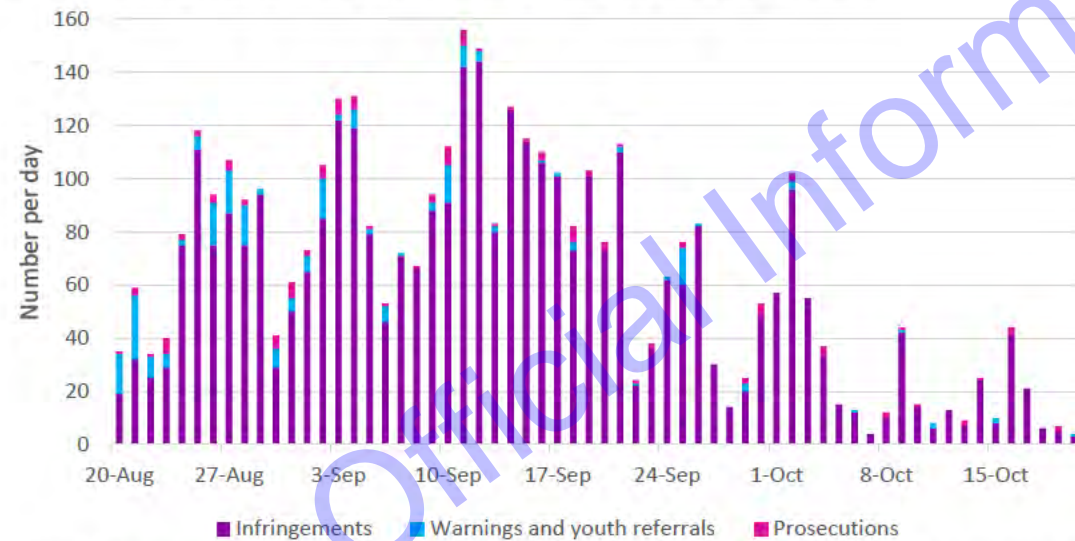
Infringements, Prosecutions, and Warnings – Low and Falling

The number of infringements continues to drop since Auckland shifted from AL4 to AL3, with last week seeing the lowest number infringements since the outbreak began. Infringements over the 7 days to 22 October 2021 totaled 92, compared to 116 in the 7 days prior. Prosecutions, and warnings and youth referrals also remained low at 5 and 3 respectively.

A petition against mandatory vaccinations in New Zealand has been posted on change.org, and had garnered 62,402 signatures as of 21 October. A similar petition submitted to Parliament, requesting that the House of Representatives pass legislation to ban any vaccine passport system in New Zealand, had received 55,675 signatures by the same date.
