Officer Notes:

[REDACTED] was the driver of a stolen vehicle, [REDACTED]. He was travelling at speed east on Lake Domain towards the intersection of Ruakiwi Road. Police were in pursuit, signalling for [REDACTED] [REDACTED] to pull over.

[REDACTED] [REDACTED] entered the right hand turning lane and drove straight out into the intersection without making any attempt to stop at the stop sign. [REDACTED] [REDACTED] collided with [REDACTED] who was travelling north on Ruakiwi Road in [REDACTED].

At the time of the collision [REDACTED] was travelling around 30km and [REDACTED] was travelling around 50km per hour.

Vehicle [REDACTED] had been involved in a previous vehicle crash causing significant damage to the vehicle therefore making it less drivable.

Patrica was unaware of the offending vehicle being involved in a Police pursuit at the time not noticing the Pursing Police vehicle or lights & siren.

Patrica was seen by attending Ambulance and taken to Waikato Hospital status 4 for precaution and due to being a DHB employee.

Force was required to extract [REDACTED] [REDACTED] from the vehicle which will be detailed in a TOR & circumstances leading up to the crash will be detailed in a pursuit notification both by the pursuing member Delta Constable GOODHEW.
Significant damage to both vehicles.

[REDACTED] - driver has no current licence being on current active driving charges and was wanted to arrest for failing to appear therefore avoiding Police apprehension by fleeing. The driver failed to stop at the intersection causing the collision with another vehicle.

[REDACTED] - damage to the vehicle prior to this collision by previously purposefully ramming another Police vehicle and the manner of driving and running over roundabouts and curbs throughout the pursuit.
