BUILDING OF HUT ON PIGEON ISLAND

Further to our letter of 25 January 1996, I write to advise the Department of Conservation, who oversee the administration of reserve land via the Reserves Act 1977, have advised that the ownership of a private hut on Pigeon Island (scenic reserve) would be illegal.

There is provisions, however, for the Council to erect a hut with the prior approval of the Minister of Conservation on a scenic reserve in order to encourage the public to appreciate and enjoy the benefits of the outdoors.

We will therefore be applying to the Ministry of Conservation for the Council to gain consent to rebuild your hut on the basis of plans provided to us by yourself. Mr M Robertson and yourself could then undertake to build the hut (on behalf of the Council) and the Council could therefore grant you occupancy rights on the basis that previously existed.

We seek your consent to approach the Minister of Conservation on this basis. It would be a proviso that the public have access to the hut.

If you wish to discuss this matter please do not hesitate to contact the writer, otherwise we will look forward to seeking the Ministry of Conservation's consent in the immediate future.
