Request for information

Thank you for your Official Information Act 1982 (OIA) request of 15 April 2022 in which you asked for a list of all forms used by Police, and for subsequently refining your request on 20 April 2022 to Victims and Witness forms.

Please find attached a list of active Police forms hosted on the MS Word platform, of which there is a total of 597.

There are also a range of forms published on Police's website, which are accessible here: <https://www.police.govt.nz/search-results/form>.

There is a variety of forms platforms used by Police, however at present there is no centralised database capturing all forms. There is a project underway to deliver enhancements to the current forms platform, including reporting capability, with an aim to create a centralised register of all Police forms. This project is on track for delivery mid-2023.

At present, however, it follows that a centralised register does not yet exist – meaning that sourcing additional information would require substantial collation. On that basis, your request is refused in part under section 18(f) of the OIA.

More positively, I trust the information we have been able to provide addresses your main areas of interest. You have the right to ask the Ombudsman to review my decision if you are not satisfied with the response to your request.
