Dear TheMagicRoast.com,

Thank you for your email of 12 September 2014, requesting under the Official Information Act, the following information:

*'I am requesting, under the OIA, 1) a breakdown of the amount spent on coffee for staff consumption for the 2012/2013 and 2013/2014 years 2) the supplier of the coffee for staff consumption 3) the type of coffee supplied 4) engagement results for 2012/2013 and 2013/2014 years.'*

The Ministry is refusing part 1) of your request in reliance on section 18(f) of the Official Information Act 1982 because the information requested cannot be made available without substantial collation or research. In response to part 2) and part 3) of your request, the Ministry can confirm that the coffee supplier nationally is OfficeMax, which supplies the Ministry with a range of types of coffee, as per the table below.
