Thank you for your request made under the Official Information Act 1982 (the Act), which was transferred under section 14 of the Act from the Office of the Minister of Immigration and the Office of the Minister of Tourism to the Ministry of Business, Innovation and Employment (MBIE) on 12 October 2022 for the following information:

Please provide the following information as at Monday 10 October:

1. All information relating to the granting of exemptions to the border rules for ski industry workers (including ski and snowboard instructors, ski patrol and safety specialists, snow grooming and snowmaking machinery operators, and ski lift and snow sport technician) for the winter 2022 season.

Our Ministerial Services team emailed you on 26 October 2022 asking you to clarify your request and on 31 October 2022 you replied and agreed to refine the scope of your request as outlined to

All Briefings to the Minister's Office(s) relating to the granting of critical purpose visas and subsequent granting of work rights for ski industry workers (including ski and snowboard instructors, ski patrol and safety specialists, snow grooming and snowmaking machinery operators, and ski lift and snow sport technician) for the winter 2022 season that contain information regarding: a. any conditions agreed to regarding rates of pay for those granted an exemption b. any conditions agreed to surrounding guaranteed hours of work for those granted an exemption c. any other conditions agreed to in order for the exemptions to be granted.

We contacted you on 27 October 2022 to inform you that the due date for a response was extended under section 15A(1)(a) and section 15A(1)(b) of the Act until 8 December 2022.

Although the scope of your request was narrowed to the Briefings to the Minister's Office(s), we have identified a few readily retrievable emails that we are also releasing to you as this may help to explain the development of the policy. Please note some information has been withheld as out of scope and under the following sections of the Act:

- 9(2)(a), to protect the privacy of natural persons, including that of deceased natural persons;
- 9(2)(g)(i), to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty.

In terms of section 9(1) of the Act, I am satisfied that, in this circumstance, the withholding of any information is not outweighed by other considerations that render it desirable to make the information available in the public interest.

I am refusing the part of your request for 2122-3185 Border Exception Proposals – transition to the Accredited Employer Work Visa under section 18(d) of the Act because the Briefing you have requested is publicly available.
