Dear Scott

I am following up on the response to your Official Information Act (OIA) request which was released to you on 13 January 2023. You sought review of this response with the Office of the Ombudsman. After discussion with the Ombudsman, we have given further consideration to your request.

Your original request was for:

Copies of all aides-memoire, memoranda, briefings, and reports held by the minister in his role as Minister for Police on the topics of the joint IPCA/OP [OPC] investigation into Police photographing members of the public; Police's internal review of matters raised by the investigation; and Police's responses to the investigation and the review

You received a response on 12 January 2023. One briefing paper was released, with some information withheld under section 9(2)(a) of the OIA. A second briefing paper was withheld in full pursuant to section 9(2)(f)(iv) of the OIA.

In the complaint to the Ombudsman, you complained about the decision to withhold information under section 9(2)(f)(iv) of the OIA. Following inquiries from the Office of the Ombudsman, I made a new decision on your request, releasing the briefing paper with redactions under sections 9(2)(g)(i) and 9(2)(h) of the OIA.

You have now complained that my decision to withhold information under sections 9(2)(g)(i) and 9(2)(h) of the OIA was not justified.

Please now find enclosed a revised version of the briefing #103CH Next Steps for the Police response to the OPC and IPCA Report, which now releases information to you that was previously withheld under s 9(2)(g)(i) of the OIA at paragraphs 2, 4 (first sentence), and 24. I maintain my earlier decision, to continue to withhold some information under s9(2)(h) and s9(2)(g)(i) of the OIA.

You have the right to seek an investigation and review by the Ombudsman of this decision.

Purpose

- 1. The purpose of this paper is to provide an update on the response to issues arising from the *Joint inquiry by the Independent Police Conduct Authority and the Privacy Commissioner into Police conduct when photographing members of the public* (the OPC and IPCA report).
- 2. This paper outlines Police's next steps for providing further advice about whether legislative change may be necessary.

Executive Summary

Photographs are often the best method of capturing who is at a scene or location at a relevant time and may be the only opportunity for capturing detail that, while not immediately consequential, may later become crucial evidential information or intelligence.

There is a programme of work to address the other recommendations

- 22. s 9(2)(h) Police is currently working to respond to the wide-ranging concerns and required actions to improve Police's collection practice. Significant improvements will be required to training, process and procedure, policy and communications.
- 23. Police had already started addressing some of these concerns in response to the Compliance Notice issued in December 2021. Additional work is now underway to respond to the recommendations in the report. For example, Police is currently developing privacy training for frontline officers about the Privacy Act 2020, including exceptions to the principles and their requirements. This is expected to be available for staff in the form of interim guidance by 20 October 2022, with formal learning products being rolled out across Police until December 2023 \$9(2)(h)

Next steps

- 24. Police will provide further advice about whether legislative change is required by mid-December.
- 25. Police will keep you updated on the programme of work to respond to and address the remaining recommendations in the OPC and IPCA report.
