Dear Chintaka

We refer to the proposed investment in Eyedentify Limited (Company) by certain investors (Investors), including NZVIF Investments Limited (NZVIF).

Under the Subscription and Shareholders' Agreement to be entered into by the Investors, the Company and certain other parties, NZVIF and the other Investors have certain rights as shareholders of the Company. While we will retain our ability to exercise such rights, we do not intend to exercise them directly in the majority of cases. Instead, we wish to appoint you as our agent to exercise NZVIF's rights, and to actively manage, monitor and assist in exiting the investment on our behalf.

It is proposed that the terms of the appointment referred to above will be as follows:

- 1. You will be appointed as NZVIF's agent from the date NZVIF is registered as a shareholder of the Company to exercise all of NZVIF's rights attaching to its shares in the Company (including signature of any resolutions which need to be signed by NZVIF and the other Investors and shareholders) in the same manner as Sparkbox on each occasion, unless:
 - a. you are conflicted in any way in relation to the relevant decision;
 - b. the relevant action is inconsistent in any respect with any principles or objectives of NZVIF relating to the Seed Co-Investment Fund Programme (SCIF) as specified in the Management and Co-investment Agreement pursuant to which NZVIF coinvests with Sparkbox, or in the notified guidelines for that programme (such as any action which might result in the Company engaging in a business which is not eligible for investment by NZVIF, or which might prejudice the reputation of NZVIF or SCIF);
 - c. such decision will bind NZVIF to transfer, encumber or otherwise deal with its shares in the Company or bind NZVIF to any financial or other obligations (other than its obligations pursuant to the Agreement or the Company's constitution);
 - d. the decision relates to any of the following matters, unless NZVIF has been provided with all relevant material information and documents in sufficient time to



consider that information before the decision is made (at NZVIF board level if required):

- i. a material transaction between the Company and any holder of securities in the Company, any director, officer or employee of the Company or any person associated with any of them;
- ii. a material change in the nature of the Company's business;
- iii. any major transaction (as defined in the Companies Act 1993) or transaction involving disposal of a significant proportion of the Company's assets which are integral to the operation of the Company's business;
- iv. any significant change in the nature of the Company's business (whether by acquisition or otherwise);
- v. any borrowing or substantial change in the capital structure of the Company;
- vi. any changes to the constitution of the Company or the Agreement; or
- e. otherwise directed by NZVIF (in respect of a particular proposed vote or action, or more generally).
- 2. You will provide NZVIF with all material information in relation to the Company received through board representation, and keep NZVIF informed of any material changes to the Company's position, in accordance with any protocols specified by NZVIF from time to time.
- You will not be liable to NZVIF for any loss or damage whatsoever that NZVIF may sustain or suffer in connection with actions properly taken by you as NZVIF's agent pursuant to these terms.
- 4. This appointment may be terminated by you or NZVIF at any time by written notice.

We anticipate that, as a passive shareholder, we will not be involved in the day to day commercial operations of the business of the Company. Furthermore, we do not see ourselves playing an active governance role. These roles are to be undertaken by you, your Board colleagues and the management of the Company. As such, you will:

1. ensure that Sparkbox will receive a quarterly report in the form that has been agreed to by the Investors and NZVIF;



- 2. make yourself available to NZVIF to discuss the progress of the investment on a 6 monthly basis;
