Official Information Act request for projects funded under the Disinformation Monitoring initiative

Thank you for your Official Information Act 1982 (the Act) request received on 31 October 2022. You requested:

*“I would like to make a request for information relating to projects funded by the Vote Prime Minister and Cabinet policy initiative “COVID-19 Response - Epidemiological Modelling, Disinformation Monitoring and Risk Assessment.”
For the avoidance of doubt, I am referring to projects funded under this initiative in both the 2021/22 and 2022/23 periods.
