#### Request for information

Thank you for your Official Information Act 1982 (OIA) request of 7 March 2023, in which you asked for further information regarding your previous OIA request IR-01-23-449 relating to Medicinal Cannabis. On this occasion you asked:

"Please provide details or copies of any "Panui" content or any other Police bulletin, Police instruction, email, newsletter, training, or other internal communication which references medicinal cannabis.

I find it very hard to believe a major law change involving controlled drugs has apparently had no communication or instruction given to frontline staff to ensure it is managed appropriately."

#### Misuse of Drugs (Medicinal Cannabis) Amendment Bill announced

The Misuse of Drugs (Medicinal Cannabis)
Amendment Bill (the Bill) has been
tabled in Parliament. The Bill aims to
improve access to medicinal cannabis for
terminally ill people and those in chronic
pain.

The proposed Bill would amend the Misuse of Drugs Act 1975 to:

- introduce an exception and statutory defence for terminally ill people to possess and use illicit cannabis;
- provide a regulation-making power to enable the setting of standards that products manufactured, imported and supplied under licence must meet; and
- deschedule cannabidiol as a controlled drug.

Any changes are not expected to come into effect until 2019, after the Bill has gone through the Parliamentary process. An advisory committee will be established and consultation will be undertaken.

Police will work with the Ministry of Health on the details of any resulting legislation, to support the implementation of a workable, safe and regulated regime for therapeutic purposes.

Police staff should continue to use appropriate discretion, taking into account all of the circumstances, in determining whether to proceed with arrest or prosecution, including the circumstances of the defendant.





Part 14 – Medicinal cannabis is a new part added to the <u>Drugs</u> chapter. The 'part' provides legislative and good practice guidance relating to the <u>Misuse of Drugs</u> (Medicinal Cannabis) Amendment Act 2018 that came into force on 18
December 2018 with:

- · using discretion
- · applying:
  - fairness
  - quality and safety
  - o compassion.

The key elements and implications include:

- Definitions of terms applicable to the amendments arising from the Misuse of Drugs (Medicinal Cannabis) Amendment Act.
- Legislative amendments to the Misuse of Drugs Act 1975.
- Policy and practice for dealing with palliation patients who use cannabis, in particular:

- procedure to be applied for people claiming to be palliation patients who possess/use cannabis
- palliation patients smoking cannabis in smoke-free work places and public areas
- operating a vehicle under the influence of cannabis.
- What remains illegal after the medicinal cannabis amendment?
- Frequently asked questions.

This chapter applies to all constables and Police employees involved with drug enforcement in Districts and PNHQ.




