Thank you for your request of 13 December 2022 to the Reserve Bank of New Zealand – Te Pūtea Matua made under the Official Information Act 1982 (OIA), as follows:

Copies and transcripts of all contact and correspondence between the RBNZ and Klaus Schwab or WEF representatives.

I request copies of any correspondence whether it be in the form of gifts, letters, notes, cards, faxes, emails, and/or transcriptions of any conversations that have occurred.

Response

One email chain dated 10 - 28 September 2022 was identified as being in scope of your request. This email chain is being released to you with some information withheld under section 9(2)(a) of the OIA, to protect the privacy of natural persons, including that of deceased natural persons. The document is enclosed with this letter. Some information is also withheld as out of the scope of your request.

In terms of section 9(1) of the OIA, we are satisfied that the withholding of the redacted information is not outweighed by other considerations that render it desirable to make the information available in the public interest.

You have the right to seek an investigation and review of this response by the Ombudsman, in accordance with section 28(3) of the OIA. The relevant details can be found on the Ombudsman's website at www.ombudsman.parliament.nz.
