Official Information Act request: Private prosecutions

Thank you for your email of 19 January 2023 to the Ministry of Justice (the Ministry) in which you requested, under the Official Information Act 1982 (the Act), information about private prosecutions. Specifically, you sought:

Tables containing the following information please:

- 1. List of individuals/organisations that have filed a private prosecution, and the sum total claimed of the private prosecutions filed for each of these individuals/ organisations Since John Banks was taken to court, including the file of John Banks Auckland Mayor for the year he was convicted at the court.
- 2. To be more precise along with the table of information, I am also requesting the file of John Bank Auckland Mayor.
- 3. A list of offences that private prosecutions have been filed for, along with the sum total of private prosecutions filed for each offense, grouped by calendar year since John Banks, Auckland Mayor court case was filed and to the current computer validated date. For the purposes of this request, the time period should be interpreted as and when John Bank's court case was filed to the current date or (the current date where the computer assesses as current).

For ease of responding to your request, the sections have been numbered.

In response to the first part of your request, I must advise that the Ministry is unable to provide the names of individuals or organisations that have filed a private prosecution, as information regarding the details of individual cases is court information. As the courts are independent of the executive branch of government (Ministers, government agencies and their officials), the Act does not apply to them under section 2(6)(a). Therefore, this part of your request is refused under section 18(g)(i) of the Act on the grounds that the information is not held by the Ministry.

Likewise, in response to the second part of your request, the Ministry does not hold files of specific court cases. These are held by the court and are not subject to the Act for the reasons outlined above. If you want to access court information, you need to apply to the court under the appropriate court rules. A decision on your request will be made by a registrar or judge. A fee may be charged. Tier 1 statistics are published twice a year in March (for calendar year data) and September (for financial year data), which means data is currently available to June 2022. 
