## **RESPONSE TO AN OFFICIAL INFORMATION ACT REQUEST**

On 13 February 2023, you contacted the Ministry for Pacific Peoples (the Ministry) requesting under the Official Information Act 1982 (OIA), information relating to nominations received by the Ministry and the Minister for Pacific Peoples. On 28 February 2023, you submitted a subsequent request regarding the Ministry's regional networks and senior leadership team. I have outlined your specific requests and my responses to each below.

- May I ask during the past 3 years (2022,2021,2020), how many nominations during the "Call for nominations" stage you have received, please separate the data by different issued occasion, e.g. New Year and King's Birthday.
- When you submitted to the Minister's office, how many nominations the Minister has agreed to support and how many Minister declined.

The table below outlines the number of nominations the Ministry received during the "call for nominations" stage, the number of nominations agreed to by the Minister and the number of nominations declined. For nominations that are declined by the Minister, the Ministry may instead look to nominate them for a future round.
