Manatū Hauora advertises vacant roles publicly on both NZ Government Jobs (https://jobs.govt.nz/), and the Manatū Hauora Careers websites (https://careers.health.govt.nz/jobtools/JnCustomLogin.Login?in organid=18370).

Also, how many applications you have received from the public and how many you have received from other government nominating agencies such as TPK or Ministry of women etc.
