Yes, that's a good idea, thanks Hayden.

What I was going to discuss with you was that we talk with WorkSafe first to see if they are aware of any other such instances that have come up with the Hazardous Substances Regulations at least?

At the moment, they are still pursuing this with Archives. But I suggest that we contact them and rather than stopping that process, which will tell us if there is actually a reference, we ask them to provide it, and if not to let us know, and of any other such instances they are aware of where we may be in breach of the 2012 Legislation Act. if not the 2019 Act.

I could do that through Rebecca and send her an email suggesting we follow through on those lines was an informal request.

Mr Smith is curious. The request was in the name B Smith, through a sort of anonymous website, but then the reply is from Anthony Smith, and addressed to me as the postman, rather than you as the writer of the letter.
