The statement below can be attributed to General Manager Richard Owen

I can confirm that Immigration New Zealand (INZ) has now finished reviewing the case involving Kellie-Jay Keen-Minshull.

After reviewing all publicly known information about Ms Keen-Minshull and seeking advice from other agencies we have concluded that there is no reason to believe that she is, or is likely to be, a threat or risk to the public order or public interest.

As a result we have determined that Ms Keen-Minshull does not meet the high threshold to be considered an excluded person under Section 16 of the Immigration Act 2009. We note there is nothing specified in the Immigration Act or immigration instructions which could be used to prevent a person travelling to New Zealand on a temporary basis based on their previous expression of opinion and ideas. We appreciate that some people will not agree with this assessment, but it is critical that INZ applies the law in all such cases, regardless of the views the individual holds.

The assessment means that Ms Keen-Minshull can use her visa waiver status as a British citizen and travel to New Zealand on the basis of holding a New Zealand electronic Travel Authority (NZeTA).

Section 16 Immigration Act 2009 - Certain other persons not eligible for visa or entry permission

- 1) No visa or entry permission may be granted, and no visa waiver may apply, to any person who
 - (a) the Minister has reason to believe -
 - (i) is likely to commit an offence in New Zealand that is punishable by imprisonment; or
 - (ii) is, or is likely to be, a threat or risk to security; or
 - (iii) is, or is likely to be, a threat or risk to public order; or
 - (iv) is, or is likely to be, a threat or risk to the public interest; or
 - (b) is a member of a terrorist entity designated under the Terrorism Suppression Act 2002.
- (2) This section is subject to section 17.

Please see the below allegation that has been reviewed by our NPP team.

<u>NZP:</u> This is being sent to you as previous events in KEEN's "Let Woman Speak Tour" have required a police presence to contain the resulting public disorder.

<u>NZSIS:</u> This is being sent to you as KEEN's rhetoric has been identified as transphobic, and at times, Islamophobic. Statements by KEEN have encouraged armed response to deter the transgender community from using public spaces. As well as this situation being likely to generate media interest, from the circumstances of KEENs entry, all the way to any resulting public disorder during the speaking engagements.

ALLEGATION:

- Kellie Jay KEEN is a far-right political activist who is currently touring Australia on her "Let Woman Speak Tour". Two events are scheduled for New Zealand in Auckland and Christchurch.
- KEEN is speaking in Auckland on the 25/03/2023 and in Christchurch on the 26/03/2023. It appears that the exact times and locations are yet to be confirmed.
- The theme of the tour is to "discuss bad transgender laws and policy".
- KEEN travelled through the United Kingdom and the United States as part of the "Let Woman Speak Tour", some of the events led to protests, counter-protests, and police involvement.
- In November 2022, the New York event required a large amount of NYPD officers to contain an incident of public disorder. Violent outbreaks and police response resulted in

9 arrests.

- KEEN has advocated for armed men to patrol women's bathrooms to "protect woman against the perceived threat of transgendered women".
- KEEN actively promotes her agenda and speaking engagements. She has featured on television, billboards, and social media throughout the United Kingdom, the United States and Australia.
- In addition to transphobic rhetoric, KEEN has also been known to make Islamophobic statements in public.
- KEEN self-reports that she has been investigated and interviewed by British Police on multiple occasions. KEEN's criminal background is unknown; however, she has declared no criminal convictions on her Visa Waiver declaration Section 9(2)(a).
- It is "highly likely" that submissions have been made by members of the New Zealand transgender community to both Hon. Michael WOOD and INZ Compliance's investigations inbox. The purposes of this will be to raise community concerns regarding KEEN and the threat she poses to New Zealand's LGBTQI+ community.
- The "Let Woman Speak Tour" could potentially have a negative impact "on safety and public order". It is possible NZP resources will be required to manage and contain a situation should it develop.
- It is "possible" the "Let Woman Speak Tour" will result in media attention. This may generate public interest in INZ and the circumstances of KEEN's entry into New Zealand.
- It is noted that Australian Green Party MP Stephen BATES publicly wrote Andrew GILES calling for KEEN's visa to be revoked. GILES is currently the Minister for Immigration, Citizenship and Multicultural Affairs of Australia.
- It has been noted KEEN was questioned at length at the Australian border but was ultimately granted entry.
- It has been noted that "It is unlikely that bona fide/ gain or reward provisions will be appliable to this individual and/or be a basis to refuse entry. BVO commented that there are many people that enter to do talks, book signings etc who are allowed to enter on visitor visas. This is unlikely to meet threshold to refuse entry under s16 Public order"
- It has been noted that previous cases of similar public interest have set precedent such as Chelsie MANNING and Lauren SOUTHERN.

Commented on similar cases of public interest that we can use to guide decisions on the Keen case (Chelsie Manning, Lauren Southern), he's been tasked with fish these out and pass on to BVO. On the matter of RAT's role in this space given the individual is visa free and hasn't applied for a visa (speaking the lack framework for RAT to be in this space), 9(2)(g)(ii) agreed and so, unless specifically tasked, I think RAT can step back from this case, but be prepared to respond if need be. I follow a transgender Facebook page and saw a post two days ago that bought something to my attention. Multiple people on the page have written to Micheal Wood and INZ Compliance investigation inbox so I thought I would bring it to your attention.

Posie Parker is a pseudo/stage name for Kellie-Jay Keen-Minshull who is a British far right 'women's rights' activist. She is planning a visit to New Zealand and has two events under her "Australian Let Women Speak Tour" booked in Auckland and Christchurch on 25/26 March 2023. https://www.binary.org.au/australian_let_women_speak_tour

She has been involved in a number of protests around the world, including New Zealand (https://www.alamy.com/posie-parker-protest-at-new-zealands-embassy-the-protest-against-hubbard-taking-the-place-of-a-woman-in-the-olympics-weightlifting-on-27th-june-2021-london-uk-image433678364.html). Many of them have involved Police, pepper stray and general disorder.

She has come to British Police's attention a couple times, and been investigated however I'm sure if charges have been laid.

She is also publicly made Islamophobic statements and worked in connection to white supremacist groups.

Her tour in New Zealand is under the guise of women's rights, but is actively anti-trans. Kellie-Jay opposes transgender people legal choice to change their name, access to bathrooms, access to medical care, trans people in sport, and pretty much all rights trans people have worked hard to get. Her tour is an event to "discuss bad transgender laws and policy".

This strongly opposes the views of MBIE and of New Zealand government as a whole.

Though I accept that people can hold differing views on all subjects, I do believe she poses a risk to New Zealand. Her intention to visit New Zealand is to protest our laws and legislation regarding trans right and is very likely to be met by counter protesters as well. Her racial views are another point of concern.

I assume she will be able to enter visa free as the UK is a visa waiver country, however there are character and potential bona fide concerns that boarder may be able to address on entry.

Anyway, just bringing this to your attention. It seems like something that is potentially very JIDIER TIFIE AC political and may need to be raised.


