#### Request for information

Thank you for your Official Information Act 1982 (OIA) request of 29 March 2023. You asked for information regarding the Posie Parker event.

My response to your request can be found below.

- 1. All internal communications on preparations the police made to ensure the Posie Parker event in Albert Park was peaceful
- 2. All instructions and rules of engagement given to the police personnel who were on site at the event
- 3. Transcripts of all communications between police personal at the Posie Parker event in Albert Park and police HQ
- 4. All communications, reports, memos, etc from and to the Commissioner of Police regarding the Posie Parker event in Albert Park.

Please refer to the attached Appendices. Please note, some information has been withheld under the following sections of the OIA:

- 6(c) the making available of the information would be likely to prejudice the maintenance of the law, including the prevention, investigation, and detection of offences and the right to a fair trial.
- 9(2)(a) to protect privacy of natural person
- 9(2)(b)(ii)- to protect information where the making available of the information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information
- 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and
  frank expression of opinions by or between or to Ministers of the Crown or
  members of an organisation or officers and employees of any department or
  organisation in the course of their duty
- 9(2)(g)(ii) the protection of such Ministers, members of organisations, officers, and employees from improper pressure or harassment
- 9(2)(h) Legal professional privilege
- 18(c)(ii) Constitute contempt of court

Please also note that some information has been withheld as out of scope due to two separate events (the Posie Parker rally at Albert Park and the Vision NZ (Hannah Tamaki) event at Aotea Square) occurring on the same day.

Police considers the interests requiring protection by withholding the information are not outweighed by any public interest in release of the information.



Please note that as part of its commitment to openness and transparency, Police proactively releases some information and documents that may be of interest to the public. An anonymised version of this response may be publicly released on the New Zealand Police website.



## Operation S6(C) Operation Order summary

#### Overview

This report provides a summarised overview on the content of an Operation Order. #### Let Women Speak Rally

#### Time 11:00 am. Date: Saturday 25th March 2023. Place: Albert Park Auckland City

This rally was organised internally with the guest speaker Kellie-Jay Keen Minshull aka Posie Parker. The theme of the rally was (on Facebook) "Women want to be heard! We won't be erased, we won't be appropriated, we won't be silenced".

#### **Stand With Us**

#### Time: 11:00. Date: 25<sup>th</sup> March 2023 Place: Aotea Square Auckland CBD

This rally was organised by Vision New Zealand Political party founded by Hannah Tamaki. The rally is promoted as "The fight isn't over! Let's continue to stand together ad against government to stop the sexualisation of our children in schools. Power belongs to parents not the state"

#### **Threat Assessment**

With all operations we utilise intelligence information/learning in identifying and or mitigating crowded places events. This also looks at general and specific (if any) threats, other factors that may impact or affect the event i.e., persons of interest, location, interested parties, opportunities.

#### Response

The order provided guidelines on our responses, from deployment, what to be cognisance of, what is our intent, how we deploy and the level of reporting. All deployment will have a layered response protocol, this will include timing, staff numbers, and including utilising tactical assets as circumstance dictates. A critical aspect of how the police response is encompassed in the Police mission for this event which was, 'to keep the peace by policing the Let Women Speak and Vision New Zealand events that enables all people to be safe and feel safe.'

#### **Administration and Logistics**

This covers Police resources tasked to and deployed to a specific event, including contingency and escalation protocol and when they can be deployed/executed. This talks to reporting line, timing, and reinforces Standard operating Procedures (SoP).





### **Background**


- 1. British anti-transgender activist, Kellie-Jay Keen-Minshull (hereinafter referred to as KEEN), is expected to travel to New Zealand later this week.<sup>1</sup>
- 2. KEEN, also known by the pseudonym Posie Parker, has shows scheduled in Wellington and Auckland this weekend as part of her 'Let Women Speak' tour.
- KEEN holds an NZeTA. INZ's border officers are responsible for assessing if travellers meet the immigration requirements to be granted entry permission and a visa to enter New Zealand.

#### Process for cases like this

- 4. All visa waiver individuals are subject to NZeTA checks and balances and are required to declare certain adverse information (e.g. convictions).
- 5. Should INZ become aware that an individual like KEEN intends to travel to New Zealand an assessment will take place prior to the expected travel if time allows.
- This can involve:
  - a review of all publicly known information
  - engagement and advice from NZ Police
  - · engagement and advice from MBIE Intelligence
  - engagement and advice from MBIE Legal.
- 7. Following this assessment, INZ will weigh and balance and decide whether there is reason to believe that KEEN is likely to be, or is, a threat or risk, to the public order and that the threshold to consider her to be an excluded person is met under Section 16 of the Immigration Act 2009 (attached at Annex One for reference).
- 8. If they are found to be subject to s16, then they are not visa waiver travellers and will be prevented from boarding any flight to New Zealand. Each case is considered based on the individual circumstances and is determined on its own merit (or lack thereof).



#### **New Zealand Police view**



16. On 20 March 2023, NZ Police were asked if their views had changed following the events in Melbourne over the weekend. They advised they do not intend to produce an updated intel note as they consider the developments over the weekend fit within the landscape they anticipated in the original product.

#### Similar cases

- 17. Lauren Southern and Stefan Molyneux (Canadian nationals) hold similar arguably views to KEEN. Both were approved visas<sup>3</sup> in 2018 and they both travelled to New Zealand.
- 18. Jordan Peterson is a Canadian psychologist, author and media commentator. He travelled to New Zealand visa waiver in 2019 and 2022.
- 19. Tyler Gregory Okonma (aka Tyler the Creator) is an American musician. Media reported he caused a riot at a concert he was performing in 2014, so there was assessment against the 'public order' requirement. While he was initially refused boarding, he was later allowed to travel. He was approved visas in 2014, 2019 and 2022. He travelled to New Zealand in 2012, 2020, and 2022.
- 20. David Irving is a UK national who is a holocaust denier. He was prevented from travelling to New Zealand because he was subject to s15 as he had been deported from Germany (so s16 was not utilised).

## Options for INZ

- A risk assessment has been carried out, MBIE Legal have provided advice and information from NZ Police has also been received.
- 22. If INZ concludes, based on the information to hand, that there is **no** reason to believe that KEEN is likely to be, or is, a threat or risk, to the public order and that the threshold to consider her to be an excluded person under s16 is not met, then KEEN will be allowed to travel to New Zealand as a visa waiver traveller.

23. Alternatively, if the risk assessment gives INZ reason to believe that KEEN is likely to be, or is, a threat or risk, to the public order then the threshold to consider her to be an excluded person under s16 would be met. A border alert would be placed on KEEN, and she would be prevented from boarding any flight to New Zealand. She would be advised of this decision.

#### If the Minister wishes to intervene

- 24. If INZ determines KEEN is not an excluded person and can therefore travel to New Zealand visa waiver, the Minister's office will be advised.
- 25. If the Minister has reason to believe that KEEN does present a threat or risk to the public order, he can decide she is an excluded person under s16 of the Act and not entitled to travel to New Zealand visa waiver and may not be granted a visa or entry permission.
- 26. To support his consideration, INZ could provide further publicly available information regarding KEENs background.
- 27. The Minister could direct officials that he has reason to believe that she does present a threat or risk to the public order. Officials would then provide documentation for the Minister's formal decision to be recorded.
- 28. A border alert will be placed on her, and she would be prevented from boarding any flight to New Zealand. Officials would send her notification of the Minister's decision.

#### 16 Certain other persons not eligible for visa or entry permission

- 1) No visa or entry permission may be granted, and no visa waiver may apply, to any person who—
  - (a) the Minister has reason to believe -
    - (i) is likely to commit an offence in New Zealand that is punishable by imprisonment; or
    - (ii) is, or is likely to be, a threat or risk to security; or
    - (iii) is, or is likely to be, a threat or risk to public order; or
    - (iv) is, or is likely to be, a threat or risk to the public interest; or
  - (b) is a member of a terrorist entity designated under the Terrorism Suppression Act 2002.
- (2) This section is subject to section 17.

# Ways to keep yourself and others safe during the day:

- Hide identifying features (tattoos, piercings, etc). Wear masks. Wear clothes that blend in with others. Pack a change of clothes for after the protest if you can.
- Bring food and water, make sure you are hydrated, well fed and energised.
- Use sun protection! Hats, sunglasses, and lots of sunscreen!
- We expect the protest to be very noisy. If you have sensory issues or are easily overstimulated then please bring earplugs and practice self care. Talk to one of our safety team if you need a quiet spot to recover.
- Do not publish photos or videos of our side that would allow someone else to identify the people involved without explicit consent. Ask for consent before taking pictures of peoples' signs. Do not post images of your fellow community members online this is to protect the safety of our community. Point any cameras towards the other side, transphobes, cops, etc. Be aware that choosing to photograph or film protesters carries risks to yourself and others. Recording/distributing photos and videos of protesters increases the possibility that they will be harassed, stalked, and/or doxxed.

### Zones:

During this protest we will be utilising different zones around Albert Park to keep people as safe as possible.

We have organised our protest into three different zones. Continue reading for more information on this:

### Red zone:

Spaces immediately in front of Posie's group. This is the riskiest zone to be in. We encourage cis allies to come to the red zone if they feel comfortable doing so as a means of using their privilege. More cis people at the front means that trans people get more freedom to choose where to be in this protest.

### Orange zone:

Spaces in between red and green, and bordered by the metal "D" sculpture and the row of trees closest to Princes Street. Covers roughly areas between the rotunda and the fountain. Carries moderate risk in relation to the other two zones.

### Green zone:

Covers the surrounding open area near the fountain. Think of this as a "home base". This is where you can go if you're less confident protesting where things will be the loudest. This zone is not risk free but we will do our best to make it as safe as possible for protestors.

Do note that if you need to travel to another part of the park and would like someone to accompany you then you are welcome to ask one of our safety crew who will be in hi viz. We also have a space offsite which we can offer as a respite space for people feeling overwhelmed or triggered. This can also be arranged via the safety crew.

The operation although finished with no arrests or serious issues, there were some challenges that we had to manage but we got there in the end.

Summary

Albert Park.

Relatively low numbers turned up in support of Let Women Speak rally. The main and only speaker Kellie Jay Keen MINSHULL a.k.a Posie Parker turned up around 9.45-10am Around 200+ were there in reception (could have been more). This was at the Rotunda on the park. Across from them were a number of Rainbow Community groups/supporters set up camp by the park fountain. They started off slowly but by 10am or just after, their numbers swelled to over 2-3k at least. By 1030 this group moved over to the Rotunda and this is where it all came to a head. They became vocal and started to move on the rotunda where the speaker was set up. There were threats and intimidation occurred, Posie Parker felt threatened and asked to leave the area. We established an evac team, took her to our vehicles and got her back to the Hub.

Large crowd remained at the park but mainly causing no issues. Part of this group and mainly Rainbow Community members transition to Aotea Centre. Out of scope



We're working on the fencing plans and will follow your advice exactly: We'll have two layers of fencing in place - with at least two exit/entrance points to meet Council requirements as laid out in your email and in case of any emergency situations requiring evacuation. We have discussed this plan with our police contact and it meets his approval.

You raise a valid point regarding the movements of attendees to and from toilet facilities. Marshalls and guards are advised to accompany anyone with an urge that can't be delayed. We have two backup marshalls that will be able to freely move around, thus more able to assist attendees. Prioritising will be done on a case-by-case basis. If no guards or marshalls are available, attendees will be advised to go in groups.

The Let Women Speak organisers - as you are aware - have obtained a permit and will accommodate every requirement placed on them by Council and Police. Since we are concerned for the safety of attendees and speakers we have hired private security, which is not a requirement by law as far as we know. Please advise. After speaking with the security company, we have increased the number to 6 security guards as I have already advised. There is the ability for the company to call in other staff if required. We also have 10 marshalls monitoring the perimeter.

Let Women Speak is entirely focussed on a peaceful event, so there will be absolutely no danger coming from the Let Women Speak attendees and speakers. Most of the attendees will be women over the age of 40 years. We have messaged the attendees that we have access to, that they are not to engage with any protesters. To this end, the marshalls have been trained in de-escalation techniques, and they have been advised to be focused on the attendees movements rather than people outside the fenced area.

Could you please advise if Let Women Speak are the only permit holders in Albert Park on this day? If any other permits have been issued it would be a matter of public safety to inform Let Women Speak of the fact. If no other permits were issued, any danger would come from the wider public, which is a matter of policing. We have noted your advice, however, that the Police's role onsite is to keep the peace and ensure public safety. Since Let Women Speak are holding an announced and permitted event and are accommodating every possible requirement, the public you mention in your email will be outside of the fenced area, the safety of which the organisers cannot be responsible for.
