Official Information Act Request

Thank you for your request of 18 April 2023, under the Official Information Act 1982. This request was transferred to NZQA from the Ministry of Education:

- 1) The overall attainment rate of NCEA Level 1 amongst Year 11 students from 2007 to 2022.
- 2) The overall attainment rate of NCEA Level 2 amongst Year 12 students from 2007 to 2022.
- 3) The overall attainment rate of NCEA Level 3 amongst Year 13 students from 2007 to 2022.
- 4) The overall attainment rate of University Entrance amongst Year 13 students from 2007 to 2022.

Response

The information you have requested for the years 2009 to 2021 is published on NZQA's website in the section 'Secondary Statistics Consolidated Files': https://www.nzqa.govt.nz/qualifications-standards/understanding-nzqf/secondary-school-and-ncea/secondary-school-statistics/. For ease, find the data for 2009 – 2021 below (Appendix 1 refers).

The enrolment-based measure, used in these statistics, utilises NCEA and University Entrance (UE) attainment rates for students as they progress through school. NZQA uses 'school year level' to report how many students are attaining the typical year level NCEA qualifications and UE Award. This includes:

- Year 11 Level 1
- Year 12 Level 2
- Year 13 Level 3
- Year 13 UE

All students enrolled at a school or kura for one day or more, according to Ministry of Education enrolment records, are included in the measure.

When NZQA moved to using the enrolment-based measure in 2018, we recast historical data and republished it back to 2009. We did a further update to all historical files on 26 March 2020 – a note to this effect appears on our website, where relevant.

2008 data was not published and was solely used for testing purposes to develop the measures for 2009 onwards. However, as the 2008 data did include overall attainment rates for NCEA Year Levels 11 to 13 and UE, this has been provided (Appendix 2 refers).

NZQA cannot provide 2007 data as we did not recast historical enrolment-based measure data further back than 2008. Accordingly, we are refusing this part of your request under section 18(e) of the Official Information Act 1982 as the data requested does not exist.

As part of the commitment to open and transparent government, NZQA is proactively releasing responses to Official Information Act requests that are of public interest. NZQA intends to publish its response to this request on its website as part of its next quarterly release of documents. Your name and contact details will be removed before publication.
