Companies on Live Deals Platform

The full list of Live Deals is withheld under the following sections of the Official Information Act:

• 9(2)(b)(ii) would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information.

Access to the platform is restricted to qualified investors and investment opportunities are registered through the NZTE Investment Team.

As referred to on the Live Deals FAQ page on NZTE's website <u>Live Deals FAQs | Invest New</u> <u>Zealand (nzte.govt.nz)</u>, NZTE takes reasonable efforts to protect personal information we hold from loss, misuse, and unauthorised access, disclosure, alteration, and destruction. We do this by:

- Requiring investors to undergo an authentication process to access Live Deals.
- Partnering with industry-leading security services to secure our platforms.
- Storing user information in securely hosted cloud databases.
- Ensuring multiple privacy and security compliance frameworks and certifications are met, like GDPR, HIPAA and HITECH.
