RESPONSE TO AN OFFICIAL INFORMATION ACT REQUEST

On 28 April 2023, you contacted the Ministry for Pacific Peoples (the Ministry) requesting under the Official Information Act 1982 (OIA), information relating to supplier spend. I have outlined your specific requests and my responses to each below.

I would like an extract of the annual amount spent with all suppliers for the 2021/2022 financial year.

I would like this data in an open format, csv or json formats would be suitable.

I would like the following details provided:

- Supplier Name
- Suppliers NZBN number (if available)
- Total Amount Spent

On 9 May 2023, you contacted us to clarify that you wanted the GST exclusive amounts. Please note that under section 15(1AA) of the OIA, if a request is amended or clarified after the date on which it is received, the department or organisation that receives the request may treat the amended or clarified request as a new request that, for the purposes of subsection (1), replaces the original request.

A copy of the information requested is appended to this letter (refer **Appendix 1**). The amounts provided are GST exclusive. Please note the Ministry does not record suppliers' NZBN numbers so this information is not included. Some information has been withheld under the following section (9)(2)(a) of the OIA to protect the privacy of natural persons. I am satisfied that there are no other public interest considerations that render it desirable to make the information withheld under section 9 of the OIA available.

In line with standard OIA practice, the Ministry proactively publishes some of its responses to OIA requests. As such, this letter may be published on the Ministry for Pacific Peoples' website. Your personal details will be removed, and the Ministry will not publish any information that would identify you or your organisation.
