Agreement on Establishment of Sister-Region Relationship

Between

Marlborough Region of New Zealand

Ningxia Hui Autonomous Region of the P. R. China

In accordance with general principles on strengthening pragmatic cooperation and exchange reached by governments of both New Zealand and China, and general terms of the sister-region MOU signed between the two regions, and also for the purpose of consolidating the existed friendship, enhancing multi-field collaboration between the local governments of the two regions, both Marlborough Region, New Zealand, and Ningxia Hui Autonomous Region, China, agree to establish sister-region relationship between the two regions. And for this purpose, the two sides sign this Agreement, with the terms as follows for two sides' abiding by:

Article 1 Both Marlborough Region and Ningxia Hui Autonomous Region agree to strengthen mutual collaboration in fields of economy and trade, agriculture (grape wine industry), education, culture, etc., and to exchange administrative experience for the purpose of supporting bilateral development.

Article 2 Leaders and related departments of both sides will keep close touch with each other so as to provide more opportunities to negotiate or discuss matters on exchange and cooperation of common concern.

Article 3 Signed on September 7th, 2017 in Yinchuan, the capital, Ningxia Hui Autonomous Region, P.R.C., this Agreement will take effect upon being signed, and it will continue to remain valid unless one party proposes to terminate it by giving to the other party a prior written notification.

Article 4 Written both in English and Chinese, this Agreement is done in duplicated form, and the both texts are equally authentic.
