The Council's role includes reviewing proposed changes to rules, hearing appeals from decisions of the Registration Authority in relation to registration and complaints and reviewing and reporting to the Minister on the performance of the Registration Authority.

Applications close on Friday, 5 May 2023

There are two vacancies on the Council as two members are departing. MBIE is therefore refusing this part of your request under section 18(e) of the Act, as the document alleged to contain the information requested does not exist or, despite reasonable efforts to locate it, cannot be found.
