Dear Krista,

I refer to your email dated 19 May 2023, requesting the following under the Official Information Act 1982 (the Act):

"Any information relating to decisions made at the Cabinet level regarding the Accessible Streets package that was consulted on in 2020, and that was going to cabinet in 2022 with a rule change proposed.

In particular I would like to see any minutes of a cabinet meeting that discussed the proposal.

If these are not available, I would like to see any correspondence between the minister and officials relating to the Accessible Streets programme between July 2021 and today. In particular, I am interested in any correspondence that would show why this programme has not been progressed."

Thirteen documents fall within the scope of your request and are detailed in the document schedule attached as Annex 1. The schedule outlines how the documents you requested have been treated under the Act.

Certain information is withheld under the following sections of the Act:

9(2)(a) to protect the privacy of natural persons

9(2)(f)(iv) to maintain the constitutional conventions for the time being which

protect the confidentiality of advice tendered by Ministers of the Crown

and officials

9(2)(g)(i) to maintain the effective conduct of public affairs through the free and

frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty

With regard to the information that has been withheld under section 9 of the Act, I am satisfied that the reasons for withholding the information at this time are not outweighed by public interest considerations that would make it desirable to make the information available.
