This name was bestowed to our Ministry by our Ministry's Kaumātua Tā John Clarke.

Tāhū: is the ridge pole that is the main support structure of a wharenui or house

Ture: is the law.

Our name touches on the connection between the ridge pole that supports a house and the role our Ministry plays in supporting democracy and the rule of law in Aotearoa New Zealand.

Te Tāhū o te Ture as a name was developed after Tā John Clarke talked with a number of Kaumātua. It was adopted by the Ministry of Justice in 2003, following the merger of the old Ministry and Department of Courts. Today, Tā John continues to play a role in Ministry events and earlier this year gave the Whaikorero at the Pōwhiri to welcome our Chief Executive Andrew Kibblewhite.

At present, there are no plans to change the Ministry's branding or the way it uses advertising channels.

In 2021/22 financial year, as part of the Joint Venture Business Unit's transition to an interdepartmental executive board, new branding was developed for the 1 July 2022 launch Antony "Do we of Te Puna Aonui. The cost of this work was \$72,525.00 (excluding GST). No other rebranding occurred during the past five financial years.

Commented [LS2]: I'm wondering whether we need to add some context like this – the various comms and websites do use te reo Māori names, but they've already been introduced without fuss. It explains why we're refusing this under s18(e) – there are no plans for a mass renaming or rebranding that I'm aware of.

Commented [LS3]: You'd need to check with someone like Tony Fisher, but I think they are currently just translations of the English names, rather that a Te Reo Māori that has been bestowed on the court.

Commented [LS4]: Please confirm this with Carl Crafar, Andrea King and Richard Willaims – I'm not aware of anything, but that doesn't mean it hasn't been raised.

I am aware of a proposal to add the Supreme Court's te reo Māori name to the front of it's building on Lambton Quay and the courtroom inside. There has been correspondence between the Ministry and the CJ and internal correspondence about that. However I don't think that comes within the scope of this request – it's about adding signage with the existing te reo name, rather than renaming the Supreme Court.

I've copied and pasted the relevant part of the OIA response below:

"Te Koti a Rohe o Aotearoa" is a direct translation of "The District Court of New Zealand"

(another example of translation vs Maori name is "te Tahu o te Ture" which means " the ridge pole of the law" (not "The Ministry of Justice")

2. Note that "Rangatahi Court" is slang. The correct name is "te Koti Rangatahi"

I've copied and pasted the relevant part of the OIA response below:

"Many New Zealand courts already have and use te reo Māori translations of their names (eg, Te Kōti Mana Nui for the Supreme Court) on, for example, their websites. Some specialist courts and jurisdictions also have te reo Māori words in their names, such as the Rangatahi Court and Waitangi Tribunal. There are no current plans to rename any courts and tribunals. This part of your request is therefore likewise refused under section 18(e) of the Act, as the information does not exist."

1. My advice is not to use the words "...and use te reo Maori translations of their names....; and simply say "and use te reo Maori names....." The reason for this is that some of the names are translations and others are not e.g.

"Te Koti Mana Nui" does not translate to "Supreme Court". It means "The court with great/the most mana" Whereas

"Te Koti a Rohe o Aotearoa" is a direct translation of "The District Court of New Zealand"

(another example of translation vs Maori name is "te Tahu o te Ture" which means " the ridge pole of the law" (not "The Ministry of Justice")

2. Note that "Rangatahi Court" is slang. The correct name is "te Koti Rangatahi"

I've copied and pasted the relevant part of the OIA response below:

"Many New Zealand courts already have and use te reo Māori translations of their names (eg, Te Kōti Mana Nui for the Supreme Court) on, for example, their websites. Some specialist courts and jurisdictions also have te reo Māori words in their names, such as the Rangatahi Court and Waitangi Tribunal. There are no current plans to rename any courts and tribunals. This part of your request is therefore likewise refused under section 18(e) of the Act, as the information does not exist."

1. My advice is not to use the words "...and use te reo Maori translations of their names....; and simply say "and use te reo Maori names....." The reason for this is that some of the names are translations and others are not e.g.

"Te Koti Mana Nui" does not translate to "Supreme Court". It means "The court with great/the most mana" Whereas

"Te Koti a Rohe o Aotearoa" is a direct translation of "The District Court of New Zealand"

(another example of translation vs Maori name is "te Tahu o te Ture" which means " the ridge pole of the law" (not "The Ministry of Justice")

2. Note that "Rangatahi Court" is slang. The correct name is "te Koti Rangatahi"
