

Here is an updated version of the Rural Connectivity Study Terms of Reference, following feedback from Division last week.

As agreed at Division, we will work with Tristan to finalise this document before publishing it on (or just after) 17 May.

Please let me know if you are happy with the changes, or if there is any other feedback you'd like us to consider when finalising it. It would be great if you could do this by **COB Thursday** so that we can lock down the TOR and the corresponding media release before the end of the week.

Key changes we made (tracked in the doc):

- Made the link to our routine monitoring (specifically the Annual Monitoring Report) stronger.
- Softened the link to the 69AH copper review we have done this by putting it at the bottom of the list of things it will inform, and made it clearer that review is a separate process.
- Included capital investment in rural services in the scope of the study.
