## **Standard timeframes**

Standard timeframes for customers to respond to requests from Immigration New Zealand are set out below.

These timeframes should be used unless there are valid reasons why a client requires more time to respond to the correspondence. Such reasons should be judged on a case-by-case basis. Extensions may be granted if they are reasonable and are justified by circumstances.

Note some application categories have their own timeframes:

- Skilled Migrant Category see "setting due dates guidelines"
- Refugee Family Support Category see the end of this document.
- Entrepreneur, Residence from Work (Talent), and Investor categories (as outlined in the tables below)

# Assess Eligibility (SMC)

#### When to use

When assessing a Skilled Migrant Category (SMC) application.

#### Role

- Immigration Officer, or
- Senior Immigration Officer

#### Guidelines

- Use this SOP, the linked SOPs, and the SMC case summary to complete an assessment of the applicant's overall eligibility under this visa category
- If you have concerns about whether the applicant can be awarded points for a specific employability or capacity building factor (SM1.10), consider whether the applicant meets SMC points requirements through a combination of other factors before sending a PPI letter
- Follow the Setting due dates guidelines (on a case-by-case basis) to determine how long to allow a client to provide required information:
