## **Housing opportunities in Ohakune**



To help meet the urgent need for more homes for individuals and families in Ohakune, Ruapehu District Council has partnered with Kāinga Ora – Homes and Communities and Ngāti Rangi to enable the development of residentially zoned vacant land at Teitei Drive in Ohakune.

### The need for more homes

Ohakune and surrounding townships are not immune to New Zealand's housing crisis. Many factors have resulted in a constrained housing supply, including:

- A shortage of readily available land with infrastructure in place
- Regulatory challenges
- Construction industry capacity issues and rising costs
- General development feasibility challenges

Ohakune and surrounding townships have a high number of privately holiday homes that are often vacant and unavailable for long-term rental. Most of these properties are too expensive to buy for many local whānau. In addition, the majority of these homes are older homes that do not meet current build standards.

Vacant properties accentuate the issues of homelessness, overcrowding and unaffordability through to a housing shortage for essential workers and others that are not fully captured in official statistics.

Teitei Drive's development aligns with Ruapehu District Council's strategy to tackle Ohakune's housing challenges by collaborating with the Government and others to increase the availability of warm, dry, affordable homes for both rental and purchase in the next few years. It is about planning for the future needs of a vibrant, thriving community.

# About the proposed development

### What's happening?

Kāinga Ora is the government's Urban Development Agency, as well as a public housing landlord which is what many people know we do. In our Urban Development role, we enable build ready land for different types of housing through best practice urban planning and design. This ensures the neighbourhoods those homes are in have the infrastructure and amenities to make them a great place to live.

Because of our experience in urban development, we coordinate a joint approach for the development of Teitei Drive to enable more homes to be built by other landowners and developers in the future – not just on this site of the proposed development but also additional sites.

### The 44 proposed homes include:

### 15 public homes

For the public homes, Kāinga Ora's specialist placement team matches new homes to whānau on the Ministry of Social Development's Housing Register with the highest priority for a home of that size and in that location. In Ruapehu District, there are around 72 whānau on the Housing Register who have a serious housing need. Whānau or individuals may need a public home for a number of reasons, such as the place they were renting being sold, or they can no longer stay with family.

Research by Council and anecdotal experience from Ngāti Rangi highlights that official Government statistics only capture the 'tip of the iceberg'. Issues of homelessness, overcrowding and rental unaffordability preventing whānau from forging a path out of poverty and gaining more financial freedom, independence, stability, and security are a lot larger than the official numbers suggest. Too many whānau are living in substandard housing which has a direct correlation with poor respiratory health leading to hospitalisation or absenteeism from education and employment.

### 14 affordable homes

Affordable homes provide first home buyers with more opportunities to achieve the security of home ownership and have a place to call their own.

A shortage of suitable and affordable housing to buy restricts labour mobility, wealth creation and lifestyle options for our workforce, entrepreneurs, and others within our economy. The availability of suitable, quality housing is a critical factor in retaining and attracting people who choose to make their life in Ohakune and who in turn stimulate economic and community growth. Concerns around housing supply also limit the opportunity for employers to recruit; creating challenges in capacity and capability of our local workforces.

### 15 long-term worker-rental homes

Long-term worker-rental housing provides accommodation to people who are doing seasonal or casual work in the area.

# @Clive/Paul: could you please expand on the need for long-term worker-rental homes here?

Long-term rental housing is urgently needed for key workers such as trades, Police, teachers, hospitality, and tourism workers as well as people doing seasonal or casual work. With a large proportion of houses taken up for tourist accommodation there are fewer options for housing the people working in industries that support the tourist market or provide essential services. It is also difficult to attract iwi members home if there is inadequate housing to meet their needs. In some cases, larger employers provide housing to secure enough staff, but this does not cover the need. Smaller employers or entrepreneurs starting businesses are severely handicapped in being able to attract and retain staff due to the shortage of quality long-term rentals.

Access to decent and affordable housing is fundamental to the underlying wellbeing of people and communities. If we are unable to meet our housing demands it will act as a handbrake on our economic, community, cultural and social development aspirations.

### What will the new homes look like?

Planning for the design of the homes has not started yet and will form part of the resource consent application for new homes, expected to be lodged in early 2024. We are committed to deliver warm, dry and fit-for-purpose homes. Our design standards will ensure that new homes meet the needs of the community and the climate by ensuring new homes are delivered to Homes Star 6 standards or higher.

### Who are Kāinga Ora?

### FAQ

### What is the process around lodging Resource Consent?

The resource consent process is run by Ruapehu District Council. It takes into account factors such as whether there is enough infrastructure and services to support the proposed new development and how it aligns with the District Plan.

It is the Council that decides whether there is a need for the public to be notified of the consent application.

Where Council require a resource consent for a development to be notified, neighbours will be consulted on the plans for the site as part of this process.

How is development at Teitei Drive funded?

This programme of work at Teitei Drive has been made possible through the successful application by Ruapehu District Council for Infrastructure Reference Group Funding from the Government. This funding enables the planning and development of key infrastructure to provide capacity for new homes and amenities.

What protections are being put in place to not affect the value of neighbouring properties? Any appropriate covenants will be considered as part of the resource consent application for new homes, expected to be lodged early 2024.

### What input does the community have?

For new proposed developments, Kāinga Ora aims to engage open and transparent with the local community to understand what works for the community, what doesn't, and what can be improved. We want to ensure we are not only building homes, but supporting sustainable, thriving and inclusive communities. This engagement is important and allows us to collect a wide range of feedback, including through in-person and online drop-in sessions, emails, and calls.

# What is being done to ensure there are adequate services, such as doctors, nurses, teachers in the area?

As part of our community engagement, Kāinga Ora will work with other agencies and key stakeholders in the community to ensure local services, such as schools and medical services, are prepared for population growth.

To help meet the urgent need for more homes for individuals and families in Ohakune, Ruapehu District Council has partnered with Kāinga Ora – Homes and Communities and Ngāti Rangi to enable the development of residentially zoned vacant land at Teitei Drive in Ohakune.

These new homes will get more whanau out of unsuitable living situations and into a healthy, warm, dry and safe place to call home.

In Ruapehu District, there are around 72 whānau on the Housing Register who have a serious housing need. We also know that there is a growth opportunity for Ohakune and other types of housing will be required to support the community.

### About the proposed development / What are we proposing?

#### What's happening?

In the first stage of the project, Kāinga Ora is carrying out infrastructure work to make the land ready for future housing to be built. This work includes upgrading and creating improved water services, transport connections around and within the site, and shared green spaces.

Resource consent for a subdivision of 44 lots and infrastructure has been lodged on 5 July 2023 and work on the site to make the land build-ready will likely begin late 2023. Resource consent for the new homes will be lodged early 2024.

Stage 2 of the project is yet to be planned.

#### Who will live in the new homes?

Plans for the number and type of homes on the site are still being developed but are a mix of affordable, public and workers housing.

For the public homes, Kāinga Ora's specialist placement team matches new homes to whanau on the Ministry of Social Development's Housing Register with the highest priority for a home of that size and in that location. Whanau or individuals may need a public home for a number of reasons, such as the place they were renting being sold, or they can no longer stay with family.

Affordable homes provide first home buyers with more opportunities to achieve the security of home ownership and have a place to call their own. Long-term worker-rental housing provides accommodation to people who are doing seasonal or casual workin the area.

### What will the new homes look like?

Planning for the design of the homes has not started yet and will form part of the resource consent application for new homes, expected to be lodged in early 2024. We are committed to deliver warm, dry and fit-for-purpose homes. Our design standards will ensure that new homes meet the needs of the community and the climate by ensuring new homes are delivered to Homes Star 6 standards or higher.
