#### Request for information

Thank you for your Official Information Act 1982 (OIA) request of 16 August 2023, in which you requested the following information:

I kindly request any communications with FIFA and/or Gianni Infantino (and his staff) with NZ Police with regards to police assistance or escort during the FIFA Women's World Cup period.

In addition to this, I request any information or communication regarding the decision by NZ Police to decline the escort request by FIFA/Gianni Infantino.

It is important to note that this matter was handled primarily by way of verbal communication. Police had regular conversations with FIFA assessing risk. Ultimately it was decided the level of risk did not meet a threshold that justified the facilitation of a Police escort.

Please find attached email correspondence in scope of your request. You will find that some information in this document has been withheld under the following sections of the OIA:

- 6(b), where making available the information would be likely to prejudice the entrusting of information to the Government of New Zealand on a basis of confidence
- 9(2)(a), where withholding is necessary to protect the privacy of natural persons.

Police considers the interests requiring protection by withholding the information are not outweighed by any public interest in release of the information.

You have the right to ask the Ombudsman to review my decision if you are not satisfied with the response to your request. Information about how to make a complaint is available at: <a href="https://www.ombudsman.parliament.nz">www.ombudsman.parliament.nz</a>.

5. Below is from the training manual on motorcades so you have it at your fingertips.

#### Powers to conduct Facilitated Motorcades

Officers undertaking facilitated movements act under the following legislative provisions and policy to enable the safe and effective movement of Internationally Protected Persons and/or qualifying VIP's:

#### **Urgent Duty Driving**

- (i) Operating a Police vehicle, especially when engaged in urgent duty driving, including when driving above the speed limit or above the speed of the natural flow of traffic and at intersections, can increase the exposure to risk of injury to Police employees and the public.
- (ii) Urgent duty driving must be able to be justified in response to the threat, and wherever possible, lights and sirens are continually used unless a tactical response is undertaken.
- (iii) Ensuring a continuous threat assessment (<u>TENR</u> Threat Exposure Necessity Response) while operating a Police vehicle, will assist in minimising risks to all.
- (iv) Urgent duty driving is when an enforcement officer on duty is driving above the speed limit or above the speed of the natural flow of traffic, and may not be complying with certain traffic rules and is: EITHER
  - responding to a <u>critical incident</u>
  - gathering evidence of an alleged offence
  - apprehending an offender for an alleged traffic or criminal offence
