Kia ora Clive

I'm writing with a proposal to amend our existing CSO with Daniel Tulloch and MfE until the end of 2022. Let me know if you have any questions or feedback, and if ok with you, I'll prepare the paperwork.

The contract variation would include:

A change to the instructions and Output of Services (Section A2/A7, and C1)

We would like to add the following deliverable:

- The provider will be required to draft the market governance budget bid

A change to the Outputs of the services (Section A7, and C1)

We would like to add the following output of the service:

- Complete a MfE budget bid template for the NZ ETS market governance project

Change to indicative budget (Section A6, and D1)

- In discussions with Daniel, we expect he could dedicate 15 hours a week for these deliverables (starting the week of 14 November 2022 until 16 December 2022), at an hourly rate of ^{s 9(2)}_{(ba)(ii)} + GST an hour. This will increase the indicative budget by ^{s 9(2)(ba)}_(iii) + GST.
- Therefore, the indicative budget (Section D1) will be amended to:
 - A total sum of \$184,485 (exclusive of GST), being the total maximum amount.

A change to the timeframes (Section A5, and C1)

- The contract end date would be extended from 16 December 2022 until 23 December 2022.
- This is because of the Minister's direction to accept written submissions during the targeted engagement phase until Christmas Eve. We would not anticipate any budgetary

implications from this extended timeframe as Daniel will manage his remaining hours in the current CSO within the extended period of his contract

Please could you let me know whether these changes sound ok to you or whether you want to discuss?
