Request for information

Thank you for your Official Information Act 1982 (OIA) request of 28 August 2023, for information to the policing of events on the "Stop Co Governance tour".

You requested the following.

 Deployment of Police Officers: I would like to know the total number of Police officers deployed to each of Julian Batchelors' "Stop Co-Governance" meetings. To better understand the scale of these deployments, please provide a breakdown of the number of officers deployed for each meeting. Additionally, I am interested in the total cost incurred to cover all expenses and wages for these officers.

Police does not collate and maintain a centralised record of "Stop Co Governance" events and any associated policing response where such a response has occurred. It is rare for public order policing operations to be coordinated at a national level; rather they will typically be managed by the relevant Policing District as part of its day-to-day policing. These events have in some instances had no Police response, and in others were deployed to as part of normal policing duties.

There is a small amount of relevant information contained on the Police national deployment program, referred to as RIOD. I have included this information in the attached document, however please note that the information is incomplete and cannot be taken as a complete record of Police attendance at such events,

Please note that some information has been withheld under the following grounds:

- section 9(2)(a) of the OIA, to protect the privacy of natural persons
- section 9(2)(g)(i) of the OIA, to maintain the effective conduct of public affairs through
 the free and frank expression of opinions by or between or to Ministers of the Crown or
 members of an organisation or officers and employees of any public service agency or
 organisation in the course of their duty.

To provide any remaining information on Police attendance at such events would require compiling a list of "Stop Co Governance" events and cross-reference these with rosters, and manually consolidate this information. Therefore, this part of your request has been refused under section 18(f) of the OIA, as the information requested cannot be made available without substantial collation or research.

Regarding the associated cost, as noted above, Police has not collated a centralised record of the number of staff deployed to such events. In addition, Police staff are not routinely required

to produce time sheets that break down the time spent on the various events attended in the course of their duties, while the other costs associated with Police's day-to-day operations are not coded in a way that would enable Police to link them with attendance at events related to the "Stop co-governance" tour. It is therefore not possible to provide any exact monetary figures on the cost to Police of attending such events.

Your request is therefore refused under section 18(g) of the OIA, as the information is not held by Police.

2 Reports and Arrests: I am seeking information regarding any reports or arrests that have taken place in relation to Julian Batchelors' "Stop Co-Governance" meetings. Please provide a breakdown of each meeting, including the nature of the reports and/or arrests that occurred.

Similarly, to question 1, Police have not retained a specific list of arrests that relate to "Stop co Governance" meetings. Police arrests are coded to an offence type not specific to an event. Police do keep some records, albeit not overly comprehensive on our RIOD system. I have attached those records.

3 Deployment of Officers from other Areas: Could you kindly advise if there has been a necessity to bring Police officers from other areas in order to provide adequate coverage for these events?

I can advise that no Police staff were brought in from other Police Districts in order to provide coverage for these events.

Stop Co Governance meeting - Mahurangi East Community Centre Operation Overview

Sat 09 Sep 2023 14:00 1-1 Hamatana Rd, Snells Beach, 0920, NZL

- The operation went as planned and was sufficiently staffed and resourced
- A total of 13 staff were deployed into the area of the event. On the night there was a conscious effort to ensure Policing resourcing was largely held back as a contingency. Staff were deployed as required, the largest number we had at the venue would have been around seven at one time
- Good local partnerships and relationships with Iwi and individuals meant there were no major issues during the course of this event
- Around 100 people turned up to the event to listen to Batchelor
- About 12 protestors arrived. They stayed for the first 90 mins and then left and did not return.
- The event went for much longer than anticipated (4 hours)

Security at the Venue

- The local organiser informed Police that there would be security at the venue and that it would be people from Destiny Church who were part of the 'Man-Up' wing of the church
- No security ever arrived
- This became an issue when several protestors entered the hall and started yelling at Batchelor. This was dealt with by Police present in the area who asked the protestors to leave the hall (which they did with no issues).

s9(2)(g)(i)

- Of interest is the email trail from Batchelor which shows he sent an email on Friday night (08/09/23) In it Batchelor contacts staff in Auckland City to say he is running an event at Shooters Saloon in Kingsland at 1400hrs on Saturday 09.09.23
- Outside of this email there is nothing on the stop-co-governance website, facebook page or anywhere else I could find which confirmed this event in Kingsland
- As the day unfolded it was evident that Batchelor had been in the Mahurangi area the entire day
- The event in Kingsland never occurred as far as I can ascertain

- No explanation was sought from Batchelor on the day
- It is possible that Batchelor sought to misdirect Police resourcing, made an error with his dates or there was some other reason
