Caveats:

- The data was collated on Tuesday 10 October 2023 and is accurate as at this date.
- Counts of less than 5 have been masked with <5 to prevent identification of individuals. Totals have also not been provided as they could be used to determine the masked values.
- Country of birth is not confirmed until an application has been assessed by a Life and Identity Services Officer (LISO), therefore unassigned applications may not have the correct country. This is often the case with people mistakenly entering New Zealand as the country of birth.
- As the data is extracted from dynamic systems, there may be small variances when compared with prior or future dates.
