Purpose

- 1. This briefing provides Ministers with:
 - i) A summary of the iwi/hapū engagement hui that took place over 17-20 June in relation to the Ruapehu Alpine Lifts Limited (**RAL**) matter; and
 - ii) individual letters on Minister Allen's letterhead for your signature (attached as **Appendix A**) to each iwi and hapū group, recording Crown undertakings made to individual iwi or hapū, collective Crown proposals across the groupings, and noting that a record of the hui and other documents will be forwarded separately.

Background

- 1. Ruapehu Alpine Lifts Limited (RAL) operated the Whakapapa and Tūroa Ski Areas on Mt Ruapehu under concessions issued by the Minister of Conservation, and owns the assets of the two ski areas. RAL entered Voluntary Administration on 11 October 2022, owing credits an estimated \$45 million at the time; including \$15 million in loans from the Crown, approximately \$13 million to ANZ Bank, and \$14 million to various community trusts, iwi organisations and local government authorities (the Bondholders). Further, RAL have a contingent debt to the Crown to "make good" the mountain by removing all infrastructure if they stop operating this has been valued at between \$47 million and \$88 million.
- 2. The Crown is committed to collective negotiations with the iwi with interests in Tongariro National Park (including Ngāti Tūwharetoa, Ngāti Rangi, Ngāti Uenuku/Ngāti Tamahaki/Ngāti Tamakana, and Ngāti Hāua). On this basis, Te Arawhiti advised that the Crown should engage broadly with all iwi as it seeks a solution in respect of the ski-fields.
- 3. Iwi have the longest association and connection with the land comprising the national park, and the associated ski-fields, and consider the maunga their tupuna. Iwi therefore have rights and responsibilities towards, and interests in, the ongoing care and protection of the maunga above those of the general public.
- 4. On 22 May Cabinet considered the future of the RAL ski field assets and options for government support [CAB-23-MIN-0192 refers]. Cabinet agreed to a set of parameters for Kānoa Regional Development & Investment Unit in negotiating with parties who had expressed an interest in purchasing the assets.
- On 12 June, Cabinet agreed that Whakapapa Holdings and Pure Tūroa Holdings Limited would take over ski operations at Mt Ruapehu. Cabinet also agreed that Te Arawhiti, Kānoa and the Department of Conservation (**DOC**) would work closely with iwi and hapū to ensure their interests and relationships with Ruapehu are addressed and they are comfortable with the process and outcome.
- 6. On 13 June, the RAL Voluntary Administrators (**PWC**) called a Watershed meeting for 20 June, where creditors will be invited to vote on the future of RAL. In parallel, the DOC is also required to transfer RAL's concessions to operate on the mountain to the new entities. In order to transfer the concessions, the Minister of Conservation must make a statutory decision to do so.

- 7. Following a meeting between Minister Allan, officials from Te Arawhiti, DOC and Ministry of Business Innovation, and Employment (MBIE) and hapū/iwi on the evening of 12 June 2023, a series of engagement hui were scheduled between 17 and 20 June. The purpose of these hui is to hear and understand in more detail, the views of iwi/hāpu on both the new operators of the ski fields and the transfer of the existing DOC concessions from RAL to the new entities.
- 8. Crown officials led by the Chief Executive of The Office for Māori Crown Relations: Te Arawhiti and including the Chief Executive, MBIE including the Deputy Chief Executive, Director of Kanoa and Deputy Chief Executive of DOC and other senior officials from these agencies organised and attended the hui.

lwi/hapū expressed their deep distrust of the Crown and its processes, noting the current issue and insufficient time they have been given to engage as an example of why the lack of trust continues. Those with existing Treaty settlements noted that they have entered into these settlements in good faith and compromised much in doing so, and consider that the Crown has not upheld its obligations and Treaty promises. Finally, some questioned the Crown's commitments to entering into true partnerships with iwi/hapū, and again used the current issue of RAL as an example of how this is not occurring.





Out of scope Officials also agreed that a clause could be included in the concession alongside a commitment made to Ngāti Hikairo to review the concessions within one year of them being transferred to the new operators. This will enable Ngāti Hikairo to create the space for conversations about what they want to see from the concession operators and provide for the 'blank sheet of paper'. It was explained that the concession may still proceed as there was little time to make the comprehensive changes to the relationship with the operators that Ngāti Hikairo were seeking. However there would be time built into the concession and other relationship documents that would provide the space for Ngāti Hikairo, the proposed operators and the Crown to have a deeper conversation.


f. Government responses/commitments made: officials acknowledged and apologised for not engaging with Ngāti Rangi earlier in the process, particularly given the theme of their Treaty settlement was 'wherever Ngāti Rangi goes, the

Crown goes'. A commitment was made to provide a copy of the relevant Cabinet paper. MBIE officials advised both proposed operators had already indicated they would be willing to agree to remits 1 to 3. DOC officials committed to the removal of redundant infrastructure on the ski fields through Cabinets agreement around the 'make good' provisions, and to develop a plan with iwi to remove existing infrastructure as it becomes redundant. DOC officials discussed the changes proposed to the concessions in detail and committed to providing further detail about the proposed changes to the concessions for Ngati Rangi to consider. A commitment was made to provide a map of existing infrastructure by MBIE.

Purpose

- 1. This briefing provides you with:
 - i) A summary of the hui with Te Ariki Tā Tumu Te Heuheu (Tā Tumu) on 20 June regarding Ruapehu Alpine Lifts Limited matters; and
 - ii) a letter (attached as Appendix One) to Tā Tumu.

Background

- 1. Ruapehu Alpine Lifts Limited (RAL) operated the Whakapapa and Tūroa Ski Areas on Mt Ruapehu under concessions issued by the Minister of Conservation, and owns the assets of the two ski areas. RAL entered Voluntary Administration on 11 October 2022, owing creditors an estimated \$45 million at the time; including \$15 million in loans from the Crown, approximately \$13 million to ANZ Bank, and \$14 million to various community trusts, iwi organisations and local government authorities (the Bondholders). Further, RAL have a contingent debt to the Crown to "make good" the mountain by removing all infrastructure if they stop operating this has been valued at between \$47 million and \$88 million.
- 2. The Crown is committed to collective negotiations with the iwi with interests in Tongariro National Park (including Ngāti Tūwharetoa, Ngāti Rangi, Ngāti Uenuku/Ngāti Tamahaki/Ngāti Tamakana, and Ngāti Hāua). On this basis, Te Arawhiti advised that the Crown should engage broadly with all iwi as it seeks a solution in respect of the ski-fields.
- 3. Iwi have the longest association and connection with the land comprising the national park (and as a consequence, the associated ski-fields) and consider the maunga a tupuna. Iwi therefore have rights and responsibilities towards, and interests in, the ongoing care and protection of the maunga above those of the general public.
- 4. On 22 May Cabinet considered the future of the RAL ski field assets and options for government support [CAB-23-MIN-0192 refers]. Cabinet agreed to a set of parameters for Kānoa Regional Development & Investment Unit in negotiating with parties who had expressed an interest in purchasing the assets.
- 5. On 12 June, Cabinet agreed that Whakapapa Holdings and Pure Tūroa Holdings Limited would take over ski operations at Mt Ruapehu. Cabinet also agreed that Te Arawhiti, Kānoa and the Department of Conservation (**DOC**) would work closely with iwi and hapū to ensure their interests and relationships with Ruapehu are addressed and they are comfortable with the process and outcome.
- 6. On 13 June, the RAL Voluntary Administrators (**PWC**) called a Watershed meeting for 20 June, where creditors will be invited to vote on the future of RAL. In parallel, the DOC is also required to transfer RAL's concessions to operate on the mountain to the new entities. In order to transfer the concessions, the Minister of Conservation must make a statutory decision to do so.
- 7. Following a meeting between Minister Allan, officials from Te Arawhiti, DOC and Ministry of Business Innovation, and Employment (MBIE) and hapū/iwi on the

evening of 12 June, a series of engagement hui were scheduled between 17 and 19 June. The purpose of the hui was to hear and understand in more detail, the views of hapū/iwi on both the new operators of the ski fields and the transfer of the existing DOC concessions from RAL to the new entities. Senior Crown officials of the Office for Māori Crown Relations: Te Arawhiti, MBIE, DOC attended the hui.

- 8. On 19 June, you were briefed on the outcome of the engagement process referred above, and on 20 June letters were sent in advance of the Watershed meeting.



Background

- 1. RAL operated the Whakapapa and Tūroa Ski Areas on Mt Ruapehu under concessions issued by the Minister of Conservation and owns the assets of the two ski areas. RAL entered Voluntary Administration on 11 October 2022 and, due to a failure of creditors to reach agreement on next steps at the Watershed meeting on 20 June, was placed into liquidation on 21 June.
- You have been briefed on RAL matters over the past two weeks:
 - a. On 19 June, regarding:
 - 2.1.1. the outcome of the engagement process with relevant hapū/iwi between 17 and 19 June to understand their views on the proposed two operators and the transfer of the existing concessions from RAL to the new entities, and
 - 2.1.2. attaching follow up letters from Ministers Allan, Little and Prime to the relevant hapū/iwi sent in advance of the Watershed meeting;
 - b. On 20 June, you were briefed on the outcome of a hui with Te Ariki Tā Tumu Te Heuheu,
 - c. On 21 June, you were briefed on the options available following the vote at the Watershed meeting, including in relation to the proposal from Tā Tumu Te Heuheu that was formally tabled with Ministers following 20 June;

- 4. On 26 June, Cabinet agreed to provide up to an additional \$5 million loan to the liquidator of Ruapehu Alpine Lifts to enable the 2023 ski season to proceed.
- 5. Immediately following the public announcement, officials based themselves in Turangi and re-engaged with hapū/iwi from 27 to 29 June. This is because it was important that iwi did not feel like there was a void of engagement or lack of

information. The Crown team was led by the Chief Executive of The Office for Māori Crown Relations: Te Arawhiti; the Deputy Chief Executive of Ministry of Business, Innovation and Employment (MBIE) and Director of Kānoa; Deputy Chief Executive and the Deputy Director-General, National Operations and Regulatory Services: Department of Conservation (DOC); and senior officials from these agencies. The aim was to:

- a. provide reassurance and commit to a longer process of engagement;
- ensure that the groups' have all the information necessary to be fully informed, including in relation to the future concessions process;
- c. understand groups' initial views on the proposal from Tūwharetoa; and
- d. understand what other support the groups may require through the next stages.
- 6. At the hui Crown officials provided the following information:
 - a. Cabinet approved \$5 million for the liquidator to operate the ski field over the 2023 ski season;
 - b. that the Crown was unaware of the Tūwharetoa proposal when they last met with the groups from 17 to 19 June and only became aware of that proposal on the morning of the Watershed meeting on 20 June;
 - c. that a formal expression of interest from Tā Tumu Te Heuheu was received on 21 June, which Ministers decided in good faith to consider given the earlier November 2022 expression of interest, and that Tūwharetoa would need at least several weeks to complete their due diligence before submitting a fulsome proposal;
 - d. in addition to the Tūwharetoa proposal, the two previous proposals (from Whakapapa Holdings Limited and Pure Turoa) remained live for consideration;
 - e. Cabinet's decision has enabled more time for consideration of the transfer of RAL's concessions – because the liquidator can continue to trade under the existing concession, provided trade is conducted for the purpose of preparing RAL for sale; and





13. The Ngāti Rangi tribal rūnanga (Te Kāhui o Paerangi) responded to the meeting invitation, noting that they didn't feel a need to meet, seeking further written information, clarification on funding support and indicating they would talk directly with Tūwharetoa.



15. Te Rūnanganui o Ngāti Hikairo ki Tongariro requested to meet at a time when officials were no longer in Turangi. However, Te Kotahitanga delegates of Ngāti Hikairo attended the hui on 29 June.

Proposed next steps

- 16. We recommend that a letter from Ministers Allan, Little and Prime be sent to follow up the hui with each iwi. Although we did not meet with Ngāti Rangi, we recommend they are sent the same information as the other iwi to ensure they remain informed of the next steps.

APPENDIX 1 – DUE DILIGENCE OUTCOME TÜWHARETOA

Introduction

Ngati Tuwharetoa has significant concerns regarding the liquidation (and associated asset sale process) of Ruapehu Alpine Lifts Limited (RAL).

Our recent due diligence identified a number of serious matters, driven by a process that:

- Fails to honour our agreements in the Deed of Settlement 2018
- Prejudices our negotiations of the Tongariro National Park
- Prejudices the outcome of the terms and conditions of the concession
- Creates residual risk to Ngati Tuwharetoa following partial privatisation

The position of Ngati Tūwharetoa is that the Crown is expected to act in good faith in regards to the Deed of Settlement 2018, the imminent negotiations of the TNP and the terms and conditions of the concession. In our view these good faith concerns sit above and ahead of the liquidation and any associated process. In essence, the current ordering of the process significantly prejudices Ngati Tūwharetoa.

Therefore, this letter proposes an alternative pathway reflecting our analysis to date, conversations within Ngati Tuwharetoa and with other iwi surrounding TNP and discussions with the various other stakeholders involved in the initial administration, liquidation and asset sales process including, but not limited to, MBIE, Te Arawhiti, Department of Conservation, PWC and the other bidders.

I also note that our due diligence concluded that Ngati Tūwharetoa does not have the risk appetite to lead a commercial proposal. Our investigations highlighted that there are key unknowns which mean that exposing iwi capital to a ski field without the Crown as a partner Out of scope would be imprudent.

Terms and Conditions of any Concession

Among the material uncertainties that will impact future commercial operations and non-commercial activities in the TNP, are the terms and conditions of any concession. Ngati Tūwharetoa has previously expressed significant reservations about activities permitted under the Crown's stewardship.






- 23. No applications for new ski field concessions have been lodged at this point in time, however, the Minister of Conservation or her delegate are obliged to consider any that are received.



- 32. Ngāti Tūwharetoa have outlined their concerns with the commercial process the Crown has run in relation to the future of ski field operations on Mt Ruapehu a number of times. These concerns have now been raised in emails, in meetings and in letters to Ministers and in part relate to commitments made through the 2018 Deed of Settlement between the Crown and Ngāti Tūwharetoa.
- 33. The profound significance of the maunga is formally acknowledged by the Crown in the 2018 Settlement and is the Crown's commitment to entering into negotiations over the Tongariro National Park. Specifically, the Crown has acknowledged that when the peaks of the maunga were offered to the Crown, Ngāti Tūwharetoa sought to create a shared responsibility with the Crown to protect and preserve the mountains for Ngāti Tūwharetoa, for other iwi, and for all New Zealanders.
- 34. In offering the peeks of the maunga to the Crown, the intention of Ngāti Tūwharetoa was to enter into a partnership with the Queen, and not to make an unconditional gift however legal ownership of the mountains was vested solely in the Crown and it has not always honoured its reciprocal obligations.

You will also understand the government needs to consider at this uncertain juncture a range of factors in relation to RAL and the ski fields, given RAL is now in liquidation. These include Ngāti Tūwharetoa's profound interests and the concerns you have expressed, the significance of the Mt Ruapehu ski fields for employment and economic development in the

broader Ruapehu region, and also the responsible use of public funds. This, as you will appreciate, raises complex issues which need to continue to be worked through. Decisions have not yet been made as we describe below. The previous Minister for Regional Development asked the Ministry of Business, Innovation and Employment (MBIE) to engage with Ngāti Tūwharetoa and the other bidders to determine the best outcome for the Mount Ruapehu ski fields that is commercially sustainable.

In terms of the current process, the liquidators of RAL have received four proposals for the purchase of RAL's assets. All four bidders have also made proposals to MBIE for Crown financial support. MBIE is considering the options and developing advice to Ministers for their consideration. All proposals are being considered in relation to the Government support being requested and any Government support is subject to Cabinet approval. The timeframes we expect for Cabinet consideration is 18 September.

We would like to clarify that the Department of Conservation Te Papa Atawhai (DOC) has no role in assessing the proposals for Crown financial support, nor the bids to buy RAL's business. The concession process would only be activated once DOC receives an application from a proposed new operator. At this stage no applications for concessions have been presented for consideration.

In a concessions process, DOC will of course continue to work with iwi in the region to understand their values and interests and how they might better be reflected in any future concessions process. Consulting with and giving due consideration to the views of Ngāti Tūwharetoa would be an integral part of the concessions process, should an application be made.

We have copied in the Chief Executives of Te Arawhiti, MBIE and the Director-General of DOC. We understand that the Chief Executive of Te Kotahitanga o Ngāti Tūwharetoa, Nigel Chee also wrote letters to each of them, raising your concerns. This letter also responds to the correspondence he has written to officials, and we have asked our officials to work closely with Mr Chee.

Finally, we want to reiterate the importance of our relationship with Ngāti Tūwharetoa and look forward to our hui on 11 September.


Background

- 3. In June, Te Arawhiti supported the Ministry of Business, Innovation and Employment (MBIE) and the Department of Conservation (DOC) at a number of targeted engagement hui with iwi and hapū with interests in Mt Ruapehu, following a breakdown in Māori-Crown relationships over the Mt Ruapehu ski fields.
- 4. Following these hui, the Ministers for Treaty of Waitangi Negotiations, Conservation and Regional Development wrote to iwi reiterating the commitment to work closely with them (through their respective agencies) through the remaining stages of the process. The letters also recognised the significant pressure that the RAL processes have placed iwi under.
- 5. MBIE has continued to progress work on the future of RAL and the Mt Ruapehu ski fields. This has included conversations with iwi.

- 14. In summary, the Cabinet paper recommends two options:
 - i. Option 1: Provide financial support to allow RAL to continue operating the ski fields on Mount Ruapehu until March 2024, and move RAL out of liquidation and into receivership. This option also includes an in principle agreement to provide support to Pure Tūroa Limited to run the Tūroa ski field subject to being granted a concession and final Cabinet approval. This option also recommends that MBIE officials provide advice to the Minister for Regional Development before Christmas 2023, on options to continue to operate the Whakapapa ski field after March 2024, if required.
 - ii. **Option 2:** Don't provide RAL further funding, and instead provide DoC funding so it can continue to cover its immediate operational costs related to the ski fields, and to start removing redundant infrastructure.






Ski community call for halt to fire-sale of the Ruapehu skifields

Tēnā koutou Minister McAnulty,

I'm writing to you again on behalf of the Ruapehu Skifields Stakeholders Association. We represent a diverse membership of skiers, snowboarders, life pass holders, local residents, tourism businesses and the wider community with a love of Mt Ruapehu.

We are gravely concerned that recent objections voiced by multiple groups from across Ngā Iwi o te kāhui maunga regarding the insolvency process have been minimised and/or not given the gravity they deserve. The ski community sees ourselves as guest on Mt Ruapehu and the very existence of skiing in the Ruapehu region rests on continued positive relationships with the local community and local Iwi.

We are supportive of local lwi interests in the skifields at whatever level suits them and allows for long-term preservation of skiing for generations to come. In particular, we support the multi-lwi efforts of Ngā lwi o te kāhui maunga regarding a transitional arrangement that can act as a safe pair of hands until the conclusion of the Tongariro National Park treaty settlement process.

The imminent possibility of an asset sale being halted by an impasse in DOC concession discussions across both skifields means that no restructuring decisions should be completed without proper consultation (which has not yet happened). We have previously raised concerns regarding MBIE's continued efforts to use government money to seize control of a community-owned organisation and sell the assets to private interests.

A community-ownership model which re-invests the profits back into the region is the most sensible long-term operating model for skifields on Mt Ruapehu and a better fit for the complex environmental, social and cultural context than for-profit private commercial ownership.

We are urgently calling on Ministers to halt the sale of the Ruapehu skifields into private hands.



The hapū of Patūtokōtokō are unified with Ngā Iwi o te Kāhui Maunga in our belief that any proposed solution/s must, primarily:


- Uphold all our settlement agreements
- Not prejudice future settlement negotiations related to the Tongariro National Park
- Not prejudice the outcome of the terms and conditions of any concession license/s to be issued.


As previously communicated with the Crown, the position of Patūtokōtokō, as hapū at place, has always been that adequate consideration, time, resource and consultation should be afforded to all iwi and hapū ahead of the finalisation of any proposed transition plan/s.


Patūtokōtokō has repeatedly raised our concerns throughout this process and continued to experience a significant lack of information, time and engagement from the Crown. Despite being safeguarded through a number of te Tiriti o Waitangi settlement and numerous governmental acts, policies, management plans and laws, we as tangata whenua have been continually compelled to advocate for the protection of our rights and interests.

It is our position that owing to the ski fields of Whakapapa and Tūroa being situated entirely within the original tuku or "gift" area – rather than the arbitrarily defined Department of Conservation "Pristine Area" – Patūtokōtokō requests that no further decisions are made or endorsed, whether in principle or otherwise, until we have been granted the time, space and resource required to continue exploring the opportunity a Ngā Iwi o te Kāhui Maunga transition plan – a pan-iwi led solution to the ongoing operations of the ski fields with the Crown and associated agencies.










6. CONCLUSION

We refer to your letter of 25 September 2023, which outlines Ngāti Hāua's concerns with the liquidation and potential sale of Ruapehu Alpine Lifts Limited (RAL). Thank you for setting out your position. We have sought to record the concerns, explain the point we have reached in the process and the next steps, and reiterate the importance of the relationship between the Crown and Ngāti Hāua and other iwi with interests in the Tongariro National Park.

RAL's demise, and the question of what should now happen with the Mt Ruapehu ski fields, is a complex question raising a number of issues requiring careful consideration. These include Ngāti Hāua's interests and the concerns you have expressed, the interests of other iwi in Tongariro National

Park, the significance of the Mt Ruapehu ski fields for employment and economic development in the broader Ruapehu region, and the responsible use of public funds.

On 2 October 2023, Cabinet agreed in principle to provide financial support for the bid from Pure Tūroa Limited to acquire RAL's Tūroa assets and take over commercial operations of the Tūroa ski field, subject to Pure Tūroa Limited being granted a concession by the Department of Conservation (DOC) and final Cabinet approval. Cabinet has also made decisions that allow further time for officials, iwi and potential operators to continue discussions regarding the future of the Whakapapa ski field.

Your letter also raises concerns that the commercial bids being considered by the Crown are not viable and that there has been a lack of due diligence by the Crown in considering the various proposals that have been put forward, including both short-term and long-term impacts.

We acknowledge the concerns you have raised and the profound significance of the maunga to Ngāti Hāua, and therefore your desire to ensure the protection and teachings of your tūpuna. We also acknowledge the importance of the Crown engaging with you in good faith. The Crown values and respects its relationship with Ngāti Hāua and understands the importance of the Tongariro National Park to you.

As you know, Pure Tūroa Limited will only be able to operate a ski field on Tūroa if it is successful in obtaining a concession from the Minister of Conservation (or her delegate) under the Conservation Act 1987. DOC has had no role in assessing the proposals for Crown financial support, nor the bids to buy RAL's business. At this stage, no applications for concessions have been presented to DOC for consideration.

If an application is made for a concession, DOC will continue to work with iwi in the region to understand their values and interests, and to ensure that in administering the Conservation Act 1987, the Crown is giving effect to the principles of the Treaty of Waitangi. Consulting with and giving due consideration to the views of Ngāti Hāua would be an integral part of the concessions process, should an application be made.
