

Of the 493 Year 7-8 students living in the Melville Intermediate school TEZ, 231 (47%) are enrolled at Melville Intermediate School. The 98 students choosing a similar structure of education at year 7 & 8 may well result in this number diminishing if some changes were made.

Of the 1257 Year 9-13 students living in the Melville High school TEZ 426 (34%) are enrolled at Melville High School.

Over 400 students in the area choose secondary education elsewhere in the city without a special character consideration. While it is appreciated that the single sex options * will always attract a share, the number of students choosing to migrate could diminish

Capacity

- Year 1 6 will be managed in the short term by the existing network, in longer term by new development.
- Depending on Market share there will be a shortage of capacity in years 7 – 13. This shortage of capacity might hit as early as 2021 depending on the percentage of market share. At current market share rates there will be a capacity issue by 2026 at the latest.
- We must start to act now!

What are the options?

- Status quo
- Recapitation of the existing Primary Schools in the area
- Development of a Year 7 13 schooling option on the current adjoining sites.
- Development of a Junior High/Senior High option on the current site.
- Others?

If we believe an integrated model is appropriate we need to consider

- What would an 'integrated model' actually look like?
- What is the impact of role size on student learning?
- In what ways could/would it contribute to increased student learning?
- What are the personnel management implications?
- What physical resourcing would be required?
- What are the economic and financial implications?
- What institutional and management capacities would need to be further developed?
- What might the possible community impact be?

Where to from here?

Act 1982

- To review the current structure of schooling by;
- a. Consulting with the sector and the community to explore all options for future schooling., considering the questions in the text in our context
- b. From the options available prepare a shortlist for further considerations and consultation. From this feedback;
- Define a clear process for this refreshment. The process will include a clear timeframe for decision making, clear terms of reference for any changes, realistic budget projections and a clear communications plan.
- Appointment of a "Refreshment Board" with representation of the current boards and appropriate appointments to govern this project.
- To manage the consultation and development of this project, a project manager will likely need to be appointed. Initially this person will manage the consultation process and prepare a detailed strategic plan including all points above for presentation to the joint boards and the Ministry of Education.
- Once all consultation is completed, present a detailed strategic plan for Education in the South West Hamilton (Melville/Peacockes/Glenview) area that meets the community's needs, is fiscally viable and achieves the best outcome for student learning.
- Put the final, approved plan into action as per the timeframes agreed in said plan.
