- LINZ property management expertise, extensive demolition experience.

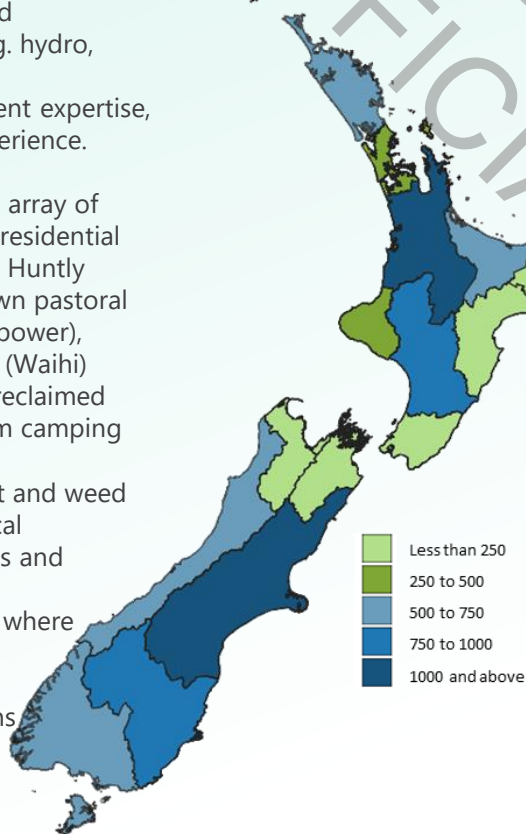
### Looks like?

- Public access is provided where practical.

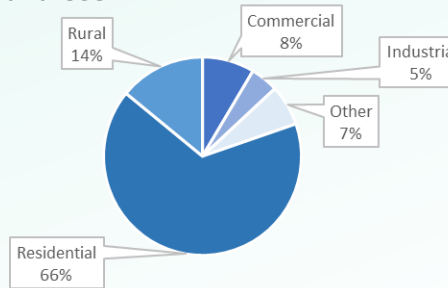

### Why us?

- Landbank assets for Treaty settlements
- Transferred from Ministry of Justice in 2016 as it is not part of their core business function to expand on LINZ property management expertise

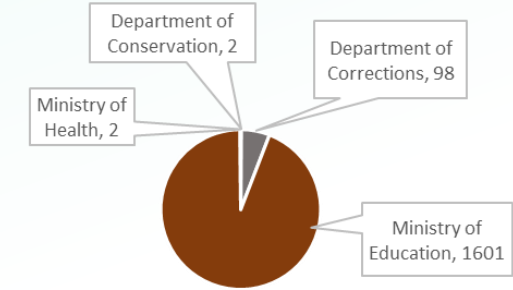
### Looks like?

- Crown assets no longer needed for core business requirements – for Treaty settlement or sold on open market.
- Residential and non-residential tenanted properties (closed hospitals, schools).
- Land including forests and farms.
- LINZ responsible for all property management and legislative compliance (Healthy homes standards, H&S).
- Budget 2022 Regional Housing Improvement Programme for urgent repairs and maintenance to residential housing.
- Deferred Selection Properties can be in the process for up to 7 years.

### Potential

- Can be transferred to other government agencies for future use e.g. housing, reserves.

### Why us?

- Reduces duplication across the public service and provides scalability for supplier contracts.
- LINZ existing property management expertise, including specialists in demolition, disposal, contamination.
- Client agency costs are fully recovered.

### Looks like?

Crown assets no longer part of core business – sold to market/treaty settlement/alternative government use. Including:

- Closed schools and associated housing
- Corrections housing village
- Closed prisons/hospitals

### Potential

LINZ is currently expanding this portfolio to provide services to other Crown agencies including Ministry of Housing and Urban Development.

Maximise Crown Assets by tenanting property, forestry, pastoral leases & various licences, collecting revenue of \$19 million per year which is returned to the Crown.

The book value of the estate is circa \$1 Billion with Property Sales \$25 million per year.

Infrastructure and expertise along with established contracts and relationships with key suppliers.
