Police respond to signalled firearms law changes

As a result of the initial and signalled law changes announced by the Government, Police has created a dedicated team to work on how Police implements the changes.

Deputy Commissioner Mike Clement is leading this work for Police and last week brought together an expert reference group of specialists from a number of the Australian Police jurisdictions.

"We discussed the processes implemented in Australia following their firearms law reforms and their processes around amnesty and buy-back.

"Australia has already been through this, so we wanted to know what their lessons were and what worked for them, ensuring our processes are as wellinformed as possible," says Deputy Commissioner Clement.

"Police's work is always evidence-based and our approach here will be no different.

"We have continued our engagement with the New Zealand firearms community.

"We know the majority of our firearms licence holders are good members of our communities and we are committed to working in partnership with them."

The Government has signalled that further changes will be made to firearms laws.

While the legislation is going through the process to become law, Police will be working through developing processes to address these changes.

Firearms licence holders who now find themselves in unlawful possession of a firearm following the Order in Council changes made already can notify Police of this by using the online form (https://forms.police.govt.nz/forms/firearms-hand-in), or by calling 0800 311 311.

There is currently an amnesty in place for firearms licence holders to notify Police and prepare to hand over affected firearms.

Police will contact people who have already notified us of their intent to hand over their firearms, as well as contacting all firearms licence holders.

"We assure the firearms community we are committed to working with you to ensure these changes are as easy to navigate as possible."

Since 3pm on Friday 15 March, 211 firearms have been handed in to Police.

Some people did this straight away as a result of the horrific terror attack in Christchurch before the Government announced any law changes. Since Police's dedicated 0800 number for information on changes to firearms (/) went live, 1477 calls have been received and there have been 982 forms completed online.

"It is good to see people using the immediate systems we've put in place to support them with information on the changes around firearms," says Deputy Commissioner Clement.

"This is just the beginning of our work to keep firearms licence holders informed of the law changes, and stronger stakeholder and communication strategies are being developed.

"Police is looking at creating reference groups so we can work through what these changes will look like for different groups in our communities.

"We also ask people to continue to let us know what specific queries they have so we can target our information to be as helpful as possible.

"We have already received a number of questions and we are working our way through them.

"This project is going to be an important task for Police over the coming months as further laws changes go through Parliament and more details are worked through."

Police to implement new firearms laws to keep communities safe

New firearms laws have been passed by Parliament which significantly reform New Zealand's Arms Act.

"On 15 March, our country was shocked by a horrific terrorist attack. This was unprecedented in New Zealand," says Police Deputy Commissioner Michael Clement.

"The Government acted quickly to change New Zealand's firearms laws and Police is now responsible for implementing and enforcing these new laws."

The main change is the prohibiting of a large number of semi-automatic firearms, parts, and large-capacity magazines.

There will be very few exceptions to this - only collectors, dealers, and people who undertake wild animal pest control will be able to apply for exemptions. Other key changes include new offences, which Police will be responsible for enforcing.

Details on the changes and what they mean for people can be found on the Police website at: https://www.police.govt.nz/advice/firearms-andsafety/changes-firearms (https://www.police.govt.nz/advice/firearms-andsafety/changes-firearms). This includes tables of affected and not affected firearms, and a video demonstrating the same.

"For people who find themselves now in possession of a prohibited firearm, we ask you to please notify us online at the Police website.

"The collection of firearms will occur at a later stage. For now, there is an amnesty in place and we ask people to please notify us. If you have already done so, you do not need to do so again.

"Police will advise people of the process for handing over their firearms once we have developed processes for larger scale collection in communities.

"Once details of the buyback are worked through and finalised, Police will announce the details of that also, we know people are very interested in that part of the process. Only the newly prohibited items will be eligible for buyback.

"I want to thank those members of the public and firearms community who have already registered their intent to "hand-in their firearms.

"This is about keeping our communities safe from potential harm and working through these changes together.

Notes to the editor:

Changing firearms laws amend the Arms Act by:

 Banning most semi-automatic firearms and some pump action shotguns; and also certain large capacity magazines. There are limited exemptions.

• Placing controls around who may possess parts of prohibited firearms.

There will no longer be a category of firearm known as a military style semi-automatic firearm (or MSSA) and the old "E" endorsement will be obsolete.

The newly banned items will be called prohibited firearms, prohibited magazines, and prohibited parts. New offences involving prohibited items carry tougher penalties.

Transitional provisions allow for an amnesty until 6 months after the buyback is announced so that those in possession of prohibited items have time to notify Police and can hand over their firearm/s to Police at a later stage when we advise of that process.

Prohibited firearms are:

• All semi-automatic firearms (including semi-automatic

shotguns), but:

o excluding rimfire rifles .22 calibre or less as long as they have a magazine (whether detachable or not) that holds 10 rounds or less; and

o excluding semi-automatic shotguns that have a nondetachable, tubular magazine that holds five rounds or less.

• Pump action shotguns that:

o Are capable of being used with a detachable magazine; or o Have a non-detachable tubular magazine capable of holding more than 5 cartridges.

Only a person who meets one of the exemption categories and who has applied for and obtained a new endorsement and permit to possess may lawfully possess a prohibited firearm.

Prohibited magazines are:

- Shotgun magazines (whether detachable or not) capable of holding more than 5 rounds.
- Magazines for other firearms (excluding pistols) that are:

• Detachable magazines capable of holding more than 10 rounds and that are capable of holding 0.22 calibre or lower rimfire cartridges

• Detachable magazines capable of holding more than 10 rounds and that are capable of being used with a semiautomatic or fully automatic firearm

• Other magazines, detachable or not, that are capable of holding more than 10 rounds.

Only a person who meets one of the exemption categories and who has applied for and obtained a new endorsement and permit to possess may lawfully possess a prohibited magazine.

Prohibited parts are:

• Parts of prohibited firearms; and

• Components that can be used to make a firearm fire with (or near to) semi-automatic or automatic action.

Only a person who has an endorsement permitting them to possess a prohibited firearm may lawfully possess a prohibited part.

Collection events open soon for banned firearms

Police want people with prohibited firearms to hand them in during the amnesty and buy-back period at collection events as part of new legislation amending firearms laws.

The first firearms collection event will be held at Addington Raceway in Christchurch on Saturday 13 July.

"We appreciate people have been patient as Regulations have been developed and Police worked through the details of managing such a large-scale collection and buy-back process," says Deputy Commissioner, Mike Clement.

"Police want to support our firearm owners to transition to the new laws and we want to ensure these changes are easy to navigate.

"Ultimately we hope to never again see the kind of attack we saw on 15 March in Christchurch." Over the next six months, a number of collection events will be held across (/) New Zealand until the amnesty period ceases on 20 December 2019. A list of these events - with dates and locations - will be available on Police's website from Monday 24 June.

"It is Police's preference that firearm owners attend these events to hand-in firearms. However, there are other options available, including bulk pick-ups by Police for those with more than 10 firearms, exception-based pick-ups by Police if there are security concerns or transport constraints, and hand-ins at selected firearms retailers or dealers, and Police stations.

"The Police website will be regularly updated and it is important people check it often for updates. It also contains information on what to do before coming to a collection event, what to bring and what to expect. The independently developed price list is also available on the website.

"Safety is crucial, so before coming to an event, owners must clear firearm/s of all ammunition and put them and any parts in a safe carry bag," says Deputy Commissioner, Mike Clement.

"To speed up the process at events, owners should also complete the online form on the Police website."

Please also bring the following with you to collection events:

- Your firearms licence (if applicable)
- Photo identification (drivers licence or passport)
- Your bank account number
- Your online notification reference number
- All your prohibited parts, cleared of all ammunition

• Any other non-prohibited firearm/s or parts you wish to hand-in to Police.

A list of collection events for the firearms amnesty and buy-back period is now available on the Police website.

192 events will be held within the first three months across the country - in cities, towns and rural communities - in a variety of venues.

The list on the Police website is for collection events for the next three months, with more dates to be added soon right up until the amnesty stops on 20 December.

"We've ensured that the collection events are held at a range of venues within Police districts, across as many weekends as possible. We want to make it as easy as we can for people to do the right thing and hand in their firearms. "As Police prepare for these collections events, we can assure the public that (/) these events are well planned with strong safety measures in place that will allow people to hand in their firearms in an efficient manner.

"The Police website will be regularly updated and it is important people check it often for updates. It also has all the information people need to prepare to attend a collection event. Most importantly, remember to complete the online notification form.

"It's Police's preference that firearm owners hand-in firearms at these collection events. However, we also want to make it as easy as possible for people to hand-in a firearm if they can't make it to a collection event. Please check the Police website for other options."

A list of retailer and dealers – who will be able to collect firearms on Police's behalf – will be announced in the coming weeks.

UPDATE: Amendment allows extra time for specific firearm processes

Regulations that take effect tomorrow will ensure firearms owners who have already started a specific exemptions based process for their prohibited items will continue to be legally protected after 20 December 2019.

"The new regulations recognises those law abiding firearms owners that have done the right thing and started an exemption process during the amnesty and buy-back. Some of these processes - endorsement licences, modification - take time and careful consideration to complete and it's important that these people are protected after the buy-back finishes," says Deputy Commissioner Mike Clement.

"This is *not* an extension of the general firearms buy-back process. Firearms owners have had plenty of time to hand in their firearms.

"The Arms (Prohibited Firearms, Magazines, and Parts) Amendment Regulations (No 2) 2019 extends the amnesty period to allow applicants to possess prohibited items while their applications are being processed. This applies only to applications for firearm modification, endorsements, dealer compensation, compensation for manufactured items and compensation for unique prohibited items.

"We have seen thousands of applications to modify prohibited firearms for example, many being heirlooms people wish to keep in the family. Approved gunsmiths need to be able to carry out the work requested by firearms owners into the New Year," says Mike Clement.

The new provisions only apply to items which have been notified and are progressing through the buy-back system by the close of 20 December 2019.

"The new regulations reflect the original intent of the law which is to protect law-abiding firearms owners. I do need to emphasise that if you have a prohibited firearm that you aren't claiming an exemption for you must hand it in by 20 December 2019. It will not be good enough to have registered on-line or told someone in Police you have it - it must be physically handed in. If you don't, you are committing a criminal offence punishable by up to five years imprisonment which will almost inevitably result in the revocation of your firearms licence," says Mike Clement.

Further information about how to hand in and details about collection events can be seen here (https://www.police.govt.nz/advice-services/firearms-andsafety/firearm-law-changes-prohibited-firearms/collection-events).

The amendment also clarifies that:

- Centrefire compatible lower receivers are eligible for compensation, as are corresponding upper receivers when handed in at the same time.
- Police may request proof of ownership or purchase before providing compensation.

- Specifications now apply to compensation for manufacturers who manufactured prohibited magazines and prohibited parts prior to 12 April 2019.
 - Compensation for large quantities of prohibited parts and magazines will take into account what portion is considered more than is appropriate for personal use.

An Arms (Prohibited Magazine) Order 2019 also declares drum magazines that can be attached to pistols, including currently advertised 50 round drum magazines, to be prohibited magazines. They will be eligible for buy-back before 20 December 2019.

How police plan to implement new firearms laws

Police have asked for patience while they make plans on how to deal with the large number of firearms expected to be handed to them, after the Arms (Prohibited Firearms, Magazines and Parts) Amendment Bill passed its final reading in Parliament yesterday

Deputy Commissioner Michael Clement told media in Wellington that the government acted quickly to change New Zealand's firearms laws and police are now responsible for implementing and enforcing the new laws.

"We know we have a big job ahead of us, we also know we are up for the challenge," he said.

Asked whether police had the capacity to deal with the number of guns that would be handed in, Mr Clement replied, "we didn't yesterday".

"But we're quickly developing processes to make sure that we can meet that expectation.

"That's why I'd urge gun owners to register online, be patient, keep the firearms secured so that by the time the New Zealand police is ready to receive those firearms, we can do so safely."

He said he did not know how many guns would be handed into police, saying it "could be 10,000, it could be more".

The Defence Force might be involved with the collection of firearms, Mr Clement said.

Buyback scheme details were still being ironed out, including compensation levels, and and more information was expected in the next few days and into next week.

Amnesty to last six months

Mr Clement said an amnesty to hand in soon-to-be-illegal guns would last six months.

He said the grace period was to give people time to tell police of their intention to hand in firearms, and to get the process started.

Police had been having "frank" discussions with the community, but the public had also demonstrated an "understanding and a commitment to work together", Mr Mr Clement said.

"These are law-abiding members of our community."

He said he wanted to emphasise that the amnesty provisions in the new laws protected licence holders who had good intent.

"Let me be clear though those people who threaten or actually harm others with firearms can expect police to act swiftly."

Mr Clement said people who now find themselves in possession of a prohibited firearm should notify the police online at the Police website (https://www.police.govt.nz/advice/firearms-and-safety/changes-firearms).

He said police would provide updates as its plans progress.

"Police will advise people of the process for handing over their firearms once we have developed processes for larger scale collection in communities.

Prohibited magazines are:

Shotgun magazines (whether detachable or not) capable of holding more than five rounds.

Magazines for other firearms (excluding pistols) that are: Detachable magazines capable of holding more than 10 rounds and that are capable of holding 0.22 calibre or lower rimfire cartridges; Detachable magazines capable of holding more than 10 rounds and that are capable of being used with a semi-automatic or fully automatic firearm; Other magazines, detachable or not, that are capable of holding more than 10 rounds.

Prohibited parts are:

Parts of prohibited firearms; and components that can be used to make a firearm fire with (or near to) semi-automatic or automatic action.

Only a person who meets one of the exemption categories and who has applied for and obtained a new endorsement and permit to possess may lawfully possess a prohibited firearm, magazine or part.

Only Governor-General signoff before laws come into effect

The law change had near unanimous support, with ACT the only party to oppose it.

The bill now only needs to be signed off by the Governor-General before becoming law.

The amendment bans a large number of semi-automatic firearms, parts, and large-capacity magazines.

Mr Clement said there would be very few exceptions to this - only collectors, dealers, and people who undertake wild animal pest control will be able to apply for exemptions.

More information about a gun buyback scheme

Owners will be able to claim compensation based on make, model and their condition, with amounts to be set by independent advisors and an expert panel. The change to the gun laws was prompted by the massacre of 50 people in two Christchurch mosques on 15 March (https://www.radionz.co.nz/news/chch-terror) using semi-automatic weapons and high-capacity magazines.

Police are working through what impact these changes may have on you. The most significant change is prohibiting most semi-automatic firearms, parts, and large-capacity magazines.

Amnesty period

There is now an amnesty in place for at least six months. The purpose of the amnesty is to provide you with reasonable time to notify Police that you possess prohibited items.

This period of time is also to enable some people to apply for an exemption to possess prohibited items (e.g. Dealers, Collectors and people involved in wild animal and animal pest control). The online notification form enables people to show an intent to apply for an exemption.

Please note, the amnesty period is not to allow for the continued use of these prohibited firearms.

During the amnesty period you should:

- Continue to maintain the safe and secure storage of your firearms DO NOT bring them into a police station (unless you have specifically made prior arrangements with Police to do so).
- Visit <u>this page on the Police website</u> (www.police.govt.nz/advice/firearms-andsafety/changes-firearms-law-prohibited-firearms). Once there, scroll down to locate and complete the online notification form.
- Be aware that the collection of firearms will occur at a later stage and you will be advised in due course of the process for this.
- Keep an eye on the Police website where information will be kept updated.

Noting the above, a number of licence and/or endorsement holders may now find they are in possession of prohibited firearms, parts, or large-capacity magazines. The table below outlines what you need to note or do now:

As a current or former holder of a New Zealand firearms licence you should be aware of new legislation amending our firearms laws, including a buy-back process which came into effect on 20 June 2019.

New Zealand Police want to do all we can to make sure you are properly informed of the various changes to the law. Together with our communities, we are committed to making New Zealand the safest country. Your support in removing newly prohibited firearms from circulation is one of the ways we can achieve this.

The most significant change is the prohibition of most semi-automatic firearms and some pump action shotguns, parts of these firearms, and large-capacity magazines. If you are unsure whether the legislation impacts you, please do read the information below to find out more about the amnesty and buy-back process.

Amnesty period

There is now an amnesty in place providing conditional protection from prosecution for offences of possessing prohibited items until 20 December 2019. This will allow you time to notify Police that you possess prohibited items and to take part in the buy-back process (if you are eligible). If you have not already notified Police, visit this page on the Police website: www.police.govt.nz

Please check the Police website which has comprehensive information on newly prohibited firearms, parts, accessories and ammunition.

You cannot use prohibited firearms during the temporary amnesty period. The amnesty does allow you to hand in prohibited firearms even if you no longer hold a valid licence. You may also hand in a non-prohibited firearm if you no longer wish to have it in your possession.

Exemptions

People wanting to apply for an endorsement to possess prohibited items need to take the opportunity to do that during the amnesty period, for example e.g. a person to whom the item has special significance as an heirloom, dealers, collectors, museum curators, theatrical members/broadcasters, and people involved in wild animal and animal pest control. The Police online notification form enables people to show an intent to apply for such an exemption.

The buy-back process

The buy-back process applies to newly prohibited firearms held by people with a valid firearms licence. No firearms licence is required to apply for compensation for prohibited parts and magazines that are handed in. The buy-back offer is available until 20 Dec 2019.

A base price list has been developed in consultation with firearms and industry specialists which reflects a value for firearms in the New Zealand market just prior to the events of March 2019. A three-tier grading system - based on the condition of the firearm - will be applied to compensate owners of prohibited firearms fairly.

A person with a prohibited firearm that is:

- In new or near-new condition, will receive 95% of the base price.
- In Used condition, will receive 70% of the base price.
- In poor condition, will receive 25% of the base price.

There are two tiers that will be used for the compensation of prohibited magazines and parts:

- Those in new or used condition will receive 70% of the base price.
- Those in poor condition will receive 25% of the base price.

The full list of firearms and parts available for buy-back are listed here: <u>https://www.police.govt.nz/advice/firearms-and-safety/changes-firearms-law-prohibited-firearms</u>

If your firearm is not listed on this price list, please note that we will be reviewing the list and updating where appropriate.

You are encouraged to check the price list for the value of your item/s and then <u>notify Police online</u> of your intention to participate in the buy-back process, if you have not already registered your intention to do so. Registering online will speed up the process when handing in your firearm/s at a community collection event or other hand in option.

Modifications

Modification is voluntary. Some prohibited firearms with non-detachable tubular magazines may be able to be safely and permanently modified to reduce the magazine capacity. Those who elect to have their firearm modified will be able to apply for the cost of the modification, up to a maximum of \$300 within the six-month buy-back period. If you are unsure if your firearm can be modified, we encourage you to seek advice from an approved gunsmith or dealer. A list of approved gunsmiths will be in the Police website soon. Then you should notify Police online of your intention to modify the firearm.

Community collection events

Community collection events will be held around New Zealand, starting from 13 July 2019. This is an opportunity for you to hand in your firearm/s, magazines or parts, for buy-back or amnesty. If you have small arms ammunition which is now prohibited we can safely dispose of this, however, please do not bring any high explosive ammunition to the collection point. If you have high explosive ammunition which you need to dispose of, please call 105.

A full list of community collection events in your area and further information about the process will continue to be updated on the <u>Police website</u>.

Things to bring with you when attending a community collection event:

- Your reference number from the Police online notification form
- Your firearms licence
- Your bank account number
- Photo identification (drivers licence or passport)
- · All your prohibited firearms, magazines, and parts, cleared of all ammunition
- Any other firearm/s or parts you wish to hand-in to Police for destruction.

Other options for hand in

If you are unable to attend a community collection event, you may hand in your firearm/s to an approved retailer or dealer from August. Additionally, Police can arrange for bulk pick-ups if you have more than 10 items. If no other option is available to you, please contact your local Police station.

If you do not have internet access and wish to be sent information about the buy-back process and collection events, please call 0800 311 311.

It has been three months since the Prohibited Firearms Amnesty and Buy back scheme came into effect on 20 June 2019. If you have taken part in the Buy-back, thank you for your support in removing newly prohibited firearms from circulation and making New Zealand safer.

New Zealand Police want to do all we can to make sure you are properly informed of the various changes to the law. As a firearms licence holder, if you are still unsure whether the legislation impacts you, please do read the latest information below to find out more.

The Buy-Back and Amnesty

Changes to firearm laws mean many semi-automatic firearms, some pump-action shotguns, and some parts and magazines are now prohibited. You are required to notify Police of any prohibited items you have in your possession on the form <u>here</u> if you have not already done so.

The buy-back process applies to newly prohibited firearms held by people with a valid firearms licence. No firearms licence is required to apply for compensation for prohibited parts and magazines that are handed in. The buy-back offer and amnesty is available until **20 Dec 2019**, there will be no extension. Possessing a prohibited firearm after this time will be an offence.

The full list of firearms and parts available for buy-back are on the latest price list.

Please remember that you cannot use prohibited firearms during the temporary amnesty period. The amnesty does allow you to hand in prohibited firearms even if you do not hold a valid licence. You may also hand in a non-prohibited firearm if you no longer wish to have it in your possession.

Ammunition

If you have prohibited ammunition you must <u>notify</u> Police by **30 September**, as required under legislation. You can do this by calling 0800 311 311. Police can safely dispose of most types of ammunition at local collection events so please bring in before 20 December. If you have large quantities of ammunition (more than 25kgs), please contact Police to arrange collection at your premise.

Please note you cannot bring any high explosive or incendiary ammunition to a collection point. If you have this type of ammunition which you need to dispose of, please call Police on '105'.

Further information on which ammunition is prohibited is available here

Approved Licensed Dealers

Approved Licensed Dealers around New Zealand are now able to accept prohibited firearms and parts on behalf of NZ Police as part of the amnesty and buy-back, until mid November.

Dealers are in nearly 40 locations from Kaitaia to Invercargill and include some Hunting & Fishing retail outlets, Gun City branches and independent firearms dealers. You may hand in up to 3 firearms and up to 5 parts at a participating dealer. Contact your local dealer to make a booking before you go. <u>Dealers list</u>

Local collection events

We have now held more than 200 local collection events around New Zealand and it's been great to see so many of you attend these events. If you still have prohibited firearm/s, magazines or parts for buy-back or amnesty, now is the time to hand them in before it's too late.

Further collection events are being scheduled around the country up to 20 December 2019 but these will be in limited locations. A full list of collection events in your region will continue to be updated on the <u>Police website</u>, or you can call 0800 311 311.

Things to bring with you when attending a community collection event:

- Your reference number from the Police online notification form
- Your firearms licence
- Your bank account number
- Photo identification (drivers licence or passport)
- All your prohibited firearms, magazines, and parts, cleared of all ammunition
- Any other firearm/s, parts or ammunition you wish to hand in to Police for destruction.

Other options for firearm hand in

If you are unable to attend a local collection event or an approved licensed dealer, Police can arrange for exception based pick ups if you have more than 10 firearms and/or 50 parts. If no other option is available to you, please contact your local Police station.

Unique Prohibited Items

Firearm owners can now apply for compensation if they own a unique prohibited firearm, part or accessory. If the prohibited item is rare, unique and/or has been modified in a way that the value of the item has significantly increased, then you may apply for compensation if the item meets the criteria set in the regulations. Information on the criteria, cost and how to apply is now available on the Police website

Please submit your application as soon as you can as the entire process including valuation and final decision needs to be completed by 20 December 2019 when the amnesty and buy back ends.

Modifications

Modification is voluntary. Some prohibited firearms with non-detachable tubular magazines can be permanently modified to reduce the magazine capacity. Should you elect to have your firearm modified by an approved gunsmith, the cost of the modification will be paid to the gunsmith up to a maximum of \$300. If you are unsure if your firearm can be modified, we encourage you to seek advice from an approved gunsmith or dealer. Please notify Police online of your intention to modify the firearm.

A list of approved gunsmiths will be available on the Police website week commencing 23 September.

Exemptions

People wanting to apply for an endorsement to possess prohibited items need to take the opportunity to do that during the amnesty period, for example e.g. a person to whom the item has special significance as an heirloom, dealers, collectors, museum curators, theatrical members/broadcasters, and people involved in wild animal and animal pest control. Prohibited Firearms Buy-Back Price List

The Arms (Prohibited Firearms, Magazines and Parts) Amendment Regulations 2019 come into effect 20 June 2019. The new regulations allow for the buy-back of newly prohibited firearms and parts from owners within a six month amnesty period (20 December 2019).

To receive compensation for prohibited firearms you are required to have a valid firearms licence. If you are handing in parts and accessories included in the prohibited list, you do not need a firearms licence to receive compensation.

Before you take part in the buy-back process, there are certain steps you need to take if you have a prohibited firearm in your possession:

- Notify the Police by registering your firearm/s online immediately at police.govt.nz
- Find out where you can take part in the buy-back process at a location close to you. There are various options such as firearms collection events – see Police website. If you do not have internet access, you may call 0800 311 311.
- · When handing in your firearms and parts in you will need to provide:
 - o Firearms and/or parts, with ammunition removed
 - o Your reference number from the Police online notification
 - Your firearms licence (not necessary for parts)
 - o Your bank account number.

Understanding how the buy-back works for firearms

The buy-back price for prohibited firearms in this list reflects:

- Brand and make/model
- <u>Base price</u> the value of the particular brand and model is dependent on whether it is a 'Current model', a 'Superseded model' (i.e. newer model now on the market) or 'Discontinued model'. The value is as advised by New Zealand firearms experts before the law change (i.e. just prior to March 2019).
- <u>Condition of the firearm</u> this is about the condition of the firearm that you are handing in for buy-back: is it new or near-new; used; or in poor condition? The condition of the firearm is important as it reflects what percentage of the value you may receive as part of the buy-back process. Please see details in the table below.

PARTS AND ACCESSORIES

Accessories that are now prohibited, such as magazines and suppressors, must also be handed in during the amnesty. It is not necessary that you have a valid firearms licence if you are just handing in parts and accessories as part of the buy-back process.

Understanding how the buy-back works for parts and accessories:

As with the prohibited firearms, the buy-back price list for parts and accessories reflects:

- Base price the value just prior to March 2019
- <u>Condition of the part or accessory</u> this is about the condition of the part of accessory: is it new or used; or is it in poor condition?

Condition of part/accessory	Explanation	Percentage of value
New or Used condition	A part is classified as being 'New or used" if it is in a condition that means that it enables the safe and effective operation of the firearm. This means that there is no structural damage to the part, no significant corrosion and all aspects of the part are functional. The part may show signs of some wear and non- structural damage (e.g. nicks or scratches).	70%
Poor Condition	A part is classified as being 'Poor' if it is in a condition that does not enable the safe and effective operation of the firearm. This can be indicated by structural damage to the body of the part, significant corrosion or aspects of the part failing to function as intended. The part will likely demonstrate significant external wear.	25 %
Key things to look for - new or used or poor:	 Condition of mounting system - The part should smoothly engage into and bind/lock with the firearm, a loose bond or 'jiggling' can indicate "Poor" condition of part. Corrosion around any moving components of the part - If corrosion is present in the joints of the part it could be a sign of "Poor" condition. Ability to function as intended - If a part fails to function as it is intended to or take undue effort of behalf of the operator then it is an indication of the part being in 'poor' condition. Battery housing (if present) - There should be no corrosion of the battery housing. If corrosion is present then it will interfere with the effective operation of the part. Damage to working surfaces - Deep or significant damage on the working surfaces of a part will impede the safe and comfortable operation of the fire and are strong indicators of the part being in "poor condition"



Good afternoon,

I have received a number of enquires in relation to firearm modifications through the buy-back scheme.

Police are currently designing the process for engaging gunsmiths approved to undertake this work, in accordance with the new firearm regulations.

As it stands, Police have not **approved gunsmiths** under this scheme. Once the appropriate process has been finalised, Police will release the details for gunsmiths to apply to be approved for the purposes of this scheme.

Please tell your customers/networks to continue to store their firearms safely as we work through this process. I have spoken to several gunsmiths who are receiving firearms for modifications, even though they are not currently approved, which is causing issues for them. There is no guarantee that firearm owners will be reimbursed for modifications that have been completed before the details of this process have been announced.

We are well aware of the impacts of this and we are working to address this issue as quickly as possible. You will appreciate how important it is that we get this process right. Police would like to thank the firearms community for their patience as we work to get this process in place.



Prohibited magazines

A guide to serialising

Under the new legislation any now prohibited magazine that remains after the amnesty ends must be held as a registered and accountable item against a licence with an endorsement to possess a prohibited (P) magazine and may thereafter only be transferred by permit in the same way as a prohibited or restricted firearm.

It is therefore necessary for owners of these magazines that are seeking the appropriate P endorsement in the category that applies to their intended purpose, to physically apply a serial number to each magazine they wish to retain.

While the Arms Act does not specify any particular format serial numbers must meet minimum requirements.

Minimum requirements

- 1. Serial numbers must be applied in a way that is **permanent**
- 2. Serial numbers must be legible in normal light
- 3. Serial numbers must be a **minimum of 2mm in height**
- 4. Serial number must be on the **body or base plate** of the magazine, not the follower

You must make sure whatever you choose as your numbering system is exactly what you record in your application for the P endorsement as on approval you will be accountable for each magazine and must be able to produce the matching magazines for inspection when required. Applicants are required to complete the serialisation of magazines before applying for the P endorsement.

Practical matters

The serial number is a practical matter for compliance not a matter of art. We are aware that size, location and neatness will be of greater concern to collectors than perhaps pest control endorsement holders.


It is therefore up to holders of magazines that are applying for a P endorsement to decide on format, placement and process of application of serial numbers. Therefore applicants may adopt what suits their purpose best and to a level of perfection as you are content with provided the result is legible and permanent.

Steel or Aluminium magazines

The neatest and cleanest result is laser engraving which uses a computer controlled laser making perfect and consistent results. A laser engraver is a specialist tool and relatively expensive to contract the work to but it does provide the best result.

It is important to make sure it is an engraver not a laser marker which is used to make less durable temporary marks that do not meet the minimum requirements for serialising magazines.

Here are examples of laser engraving (parts of the serial number have been obscured for security reasons)



Alternately you may wish to have a professional mechanical engraver such as diamond tipped rotary engravers or vibrating carbide tip engravers. These are more common and accessible and if you feel competent and the result will comply you can do the work yourself - legible does not require machine perfection.

There is also the option of using engineers stamps. There is a considerable risk of damaging the magazine with this process however it does leave a neat and permanent result. It is advisable to use a steel mandrel of suitable size and shape to hold the area to be stamped against to reduce the chance of the magazine being deformed by the impacts.

Examples of these methods are shown below (parts of the serial number have been obscured for security reasons).



Vibrating tip

Diamond tip rotary

Stamped

Photo etching is not recommended as it cannot be relied on to produce a durable enough result and is in any event cost and time prohibitive as a process. No example is provided but it is mentioned for the sake of completeness.

Plastic + Polymer and Bakelite magazines

These materials are unsuitable for laser processes and are either too brittle or too elastic to respond to stamping and so by default some form of mechanical erosion method either vibrating or rotary diamond tip is needed.

Once again your need for perfection or just readability will dictate what kind of machine you employ between a professional computer guided engraver or a hand held tool. Some polymers including many soviet ones are notoriously hard to scratch let alone engrave so you may need to change tool if you find what you had success with on steel is not working. Examples of these are below (parts of the serial number have been obscured for security reasons).



Vibrating tip

Rotary tip

General points

Placement is a matter of practicality and the need to not confuse any historical or factory numbers. It is recommended that you be consistent in your application and placement of serial numbers so that you know where to look for the number when required. Ideally it should be on the body of the magazine but it need not be visible when inserted into its firearm which goes some way toward preserving the display integrity for collector items.

As described in the P endorsement application form it may suit to use your initials followed by a number series to make it easier to know it is one of your magazines. However, you may wish to incorporate some or all of an associated firearms serial number to pair the magazines to it while others may choose a more generic alpha numeric sequence with no particular meaning. What matters is that your magazines match on any later inspection what you have registered as the prohibited magazines you wish to retain on your application form.

Good Afternoon

Police would like to thank you for your patience as we operationalise the changes to the Arms Act 1983.

We are contacting you because our records show that you currently hold a Firearm Dealer's Licence. Please contact our 0800 311 311 to advise is this information is incorrect.

The purpose of the email is to provide you with an update on applications for dealer compensation and likely timeframes; and to let you know how you will be able to hand in your personal items under the buyback scheme.

Local Collection Points

Due to the likely numbers of items held by dealers and the need to be able to clearly account for both prohibited stock you hold as a dealer and prohibited items you hold on your personal licence, both of those types of compensation applications will be dealt with at the same time. Dealer's Licence holders should not attend the Local Collection Points (LCP).

We trust you understand that, due to the volumes of people at our local collection events, and the time needed to process prohibited personal items and your business stock, it is preferable that we conduct this process with you separately. This will ensure that you avoid any wait times at our LCPs.

Dealer stock compensation

Police has received a number of questions from dealers, relating to their dealer compensation and their personal holdings. It is acknowledged and understood that as a business, this aspect has financial implications for you. We are working to establish the required forms and processes as quickly as we can.

The Arms Regulations 1992 that govern the compensation for prohibited firearms, parts and magazines will help guide you through compensation eligibility criteria. You can find the regulations <u>here</u>. Regulations 28Q to 28T and 28V regarding dealers will be of particular interest.

You will see that the compensation for dealer stock is different to individual holdings and it is important that the two are separated.

Dealer licence holders who hold dealer stock of prohibited items can begin assembling relevant documentation, including:

- Business records/dealer book
- Details of inventory held/stock lists
- Document showing amounts paid
- Records of eligible direct external costs

• Evidence of returned/attempted to return dealer stock (for example email communications and contractual terms).

We will be in touch to confirm further detail on how to apply; what is required; when and where to send in your business records; and how we intend to conduct collections. An online system is under development and testing and will be ready for dealers to upload information early **September. We will send you the worksheets needed to complete this process next week to enable you to start on this.**

Key points to note:

- 1. Your dealer stock of prohibited items will be processed at the same time as your personal prohibited items, but they are two separate applications and different criteria apply to each of those applications.
- 2. Prohibited dealer stock and personal items are treated separately in the regulations and Police will be reconciling dealer books against dealer held stock.
- 3. Please **do not** attend local collection events to hand in either your **dealer prohibited stock or your personal prohibited items**. Police will arrange a time with you to collect these items. (Please ignore any previous messaging advising this was an option).
- 4. You can start preparing the documentation required for your stock compensation application. **Keep Dealer and Personal prohibited stock separate** in documentation.

Thank you for your patience as we work through this process.

<u>I am a "C" endorsement holder (General Collector, Museum, Heirloom/Memento, or</u> <u>Theatrical/Broadcasting) who now possesses prohibited item(s). What do I need to do to get a</u> <u>further endorsement to keep these items in that capacity?</u>

An existing "C" endorsement doesn't entitle you to continue to possess prohibited items. If you want to retain those prohibited items, you will need to get a new endorsement ("P") in a specified capacity as an "exempt person". You will need an endorsement (and permit to possess) for each prohibited firearm and magazine; and you can only lawfully possess prohibited parts if you have one of those endorsements.

Some of the criteria for obtaining a "P" endorsement (in order to possess prohibited items) as an "exempt person" are the same as for "C"-endorsement holder categories (which govern possession of pistols and restricted weapons under section 29 of the Arms Act).

Section 4A of the Act allows the following categories of "exempt persons" to **apply for an endorsement** to possess prohibited items in their capacity as a –

- a bona fide collector of firearms
- a person to whom the prohibited item has special significance as an heirloom or a memento
- a director or curator of a bona fide museum
- an approved employee or approved member of a bona fide theatre company or society or cinematic or television film production company or video recording production company, or a broadcaster within the meaning of the Broadcasting Act 1989

Use the accompanying flow chart and images on Appendix 1 (at the end of this document) to determine if any of your items are prohibited and what your options are.

I do not have a "C" endorsement on my licence, but I currently possess a prohibited item. What do I need to do to keep these items as a collector, museum director/curator, broadcaster/theatrical employee or member, or to hold as an heirloom or memento?

If you do not have a "C" endorsement and currently hold prohibited firearms and / or prohibited magazines which you wish to retain, you will need to get a prohibited firearm endorsement ("P") in a specified capacity as an "exempt person". You will need an endorsement (and permit to possess) for each prohibited firearm and magazine; and you can only lawfully possess prohibited parts if you have one of those endorsements.

Section 4A of the Act allows the following categories of "exempt persons" to **apply for an endorsement** to possess prohibited items in their capacity as a –

- a bona fide collector of firearms
- a person to whom the prohibited item has special significance as an heirloom or a memento
- a director or curator of a bona fide museum
- an approved employee or approved member of a bona fide theatre company or society or cinematic or television film production company or video recording production company, or a broadcaster within the meaning of the Broadcasting Act 1989

Use the accompanying flow chart and images on Appendix 1 (at the end of this document) to determine if any of your items are prohibited.

If you intend to apply for a prohibited firearm and/or prohibited magazine endorsement in your capacity as a **Collector (General)** you <u>must</u> demonstrate an identifiable theme and a genuine interest in collecting. Simply possessing a few, or many, random prohibited items does not constitute a collection.

If you intend to apply for a prohibited firearm and/or prohibited magazine endorsement to hold a prohibited item as an **Heirloom/Memento** you <u>must</u> demonstrate that the prohibited item(s) is of sentimental value to you, by reason of family or military service history, or something similar.

If you intend to apply for a prohibited firearm and/or prohibited magazine endorsement in your capacity as a **Museum Director/Curator or Theatrical/Broadcasting/Film** employee/member, it is advised that you e-mail <u>ProhibitedFirearmEndorsement@police.govt.nz</u> to discuss these options further.

Applications are considered on a case-by-case basis.

What are prohibited items?

Туре	Description
Prohibited	1. A semi-automatic firearm (except a pistol), other than—
firearm	 (A) a semi-automatic firearm that is capable of firing only 0.22 calibre or lower rimfire cartridges and that has a magazine, whether or not detachable or otherwise externally fed, that is capable of holding no more than 10 cartridges commensurate with that firearm's chamber size. (B) a semi-automatic shotgun with a non-detachable tubular magazine or magazines that are capable of holding no more than 5 cartridges commensurate with that firearm's chamber size.

	 is not a prohibited firearm, its magazine is a tubular magazine that is prohibited (because it is capable of holding more than 10 cartridges), you will need to apply for an endorsement to continue to possess that too. Note: many semi-automatic and pump action firearms that were once standard (A-Category) and military style semi-automatic firearms (MSSA, E-Category) are now prohibited firearms (see Appendix 1)
Prohibited magazine	1. In relation to a shotgun, means a magazine, whether or not detachable, that is capable of holding more than 5 cartridges commensurate with that shotgun's chamber size.
	2. In relation to any other firearm (except a pistol), means any detachable magazine;
	(A) that is capable of holding 0.22 calibre or lower rimfire cartridges and that is capable of holding more than 10 of those cartridges.
	(B) that is capable of holding more than 10 cartridges and being used with a semi-automatic or fully automatic firearm.
	3. Means any other magazine, whether or not detachable, that is capable of holding more than 10 cartridges.
	Note: this includes any magazine(s) (detachable, drum etc.) that are for a restricted weapon (see Appendix 1)
Prohibited part	1. A part of a prohibited firearm
	2. A component that can be applied to enable, or take significant steps towards enabling, a firearm to be fired with, or near to, a semi-automatic or automatic action.

• How do I apply for a prohibited endorsement?

Complete the appropriate application form(s) send it, and any supporting documents, to -

Note: holding a "C" endorsement does not automatically guarantee that a "P" endorsement will be granted. As part of the prohibited endorsement application process you <u>must</u> demonstrate that the prohibited item(s):

a) fit with and enhance your current collection, interests and themes and that you have a genuine interest in collecting firearms (General Collector), or

b) have special significance to your as an heirloom or memento (Heirloom/Memento), or c) are necessary for your work (Museum/Theatrical) and that the chief executive officer of the organisation that you are employed by or are a member of has approved you in writing for this purpose (for theatrical/film/broadcasting) or you are a curator/director of the museum (museum). An heirloom is an item that has been in the family for successive generations and that has special significance to the applicant.

A memento is a firearm that is kept in memory of a person or event.

• What are the storage requirements for prohibited firearms and magazines?

While we recognise you might already have a "C" endorsement, have appropriate security in place, and understand the conditions relating to your pistols and/or restricted weapons, the Act now has specific provisions for the storage of prohibited firearms and prohibited magazines. It is important to note the further conditions outlined in S.33A of the Arms Act 1983 and Regulation 28AAA of the Arms Regulations 1992 that

apply to prohibited firearm magazine endorsements for collectors, museums, theatrical, and heirloom/mementos.-

a. The endorsement holder must not use live ammunition in the prohibited firearm in their possession.
b. The endorsement holder must ensure that the prohibited firearm is rendered inoperable by removal of a vital part and maintained, by reason of the removal of the vital part, in an inoperable condition.
c. The holder of the firearms licence must ensure that the removed vital part is kept at a separate address (approved by Police) from the prohibited firearm.

Note: The firearms licence holder storing the removed vital part must hold a "P" endorsement since the item they are storing is part of a prohibited firearm. Police are aware that there are very few licence holders who have a "P" endorsement at the moment. Therefore, for the purpose of applying for your "P" endorsement, on the application form you can nominate any licence holder to store the vital part(s), on the basis that the person has applied for a P endorsement and is expecting to obtain a "P" endorsement. If the nominated person is unsuccessful in obtaining a "P" endorsement, you will need to make alternative storage arrangements and obtain approval from Police for that alternative.

• I want to store the removed vital prohibited part with someone who has the same prohibited firearm that it came from, is that okay?

This is highly undesirable, but may be permitted if no alternative is able to be identified. The separate address must be approved by Police.

• Does the transfer of the vital part of my prohibited firearm to the nominated licence holder need to be done through 'permit to possess' process?

No. You need approval from Police for the storage address, but a permit to possess is not required (they apply only to prohibited magazines and prohibited firearms). You will be asked to nominate the endorsement holder at the proposed storage address, describe the storage conditions, and to mark the vital part with a unique identifying number and for that number to be provided to Police as part of the approval process. The detail of this process will be described in regulations made under Section 74(1)(ha) of the Arms Act. These Regulations are in development. We are advising of the intent in advance to assist you to make your decisions.

• Are "belt drums", ammunition containers and ammunition feeders/belt links considered magazines? Containers designed for belt linked ammunition are not in themselves magazines. Belt drums are not considered magazines as they are a device designed to carry an ammunition belt and have no mechanical actuation.

The Hotchkiss style "Feed strip" (ammunition feeder/belt link) is **not** a prohibited magazine. This design is an early version of belt link for a crew-served automatic weapon system and cannot fit anything else. It is therefore a part of a restricted weapon, rather than a prohibited magazine or a part of a prohibited firearm.

• Do I need to place a unique identifying mark on my prohibited magazines?

Yes. It is necessary for owners of prohibited magazines to physically apply a unique identifying mark to each magazine they wish to retain. The following PDF provides guidance on how to do this -

• Do I need to place a unique identifying mark on my exceptionally rare or valuable magazine?

Yes. The policy intent is for there to be no exception to this requirement. The detail of this process will be described in regulations made under Section 74(I) of the Arms Act. The required Regulation is in development. We are advising of the intent to apply the similar marking provisions that are currently required under Regulation 12 of the Arms Regulations 1992 in advance to assist you to make your decisions. Refer to the above link for more detail on marking a magazine.

• Do I need to place a unique identifying mark on prohibited parts?

The Arms Act does not currently provide for the marking of prohibited parts. This aspect will be given further consideration in the second Bill and some prohibited parts in addition to the 'vital' part may be required to be marked. We are advising you of this possibility in advance to assist you to make your decisions.

• Do I need to record every single part that might be prohibited when applying for a prohibited endorsement? No. At present it is not necessary to record all prohibited parts. However, this aspect will be given further consideration in the second Bill and it may be that the details of certain specified parts will be required to be recorded.






Capable of being used with a detachable magazine



Note for Order in Council changes:

Additional firearms, magazines or parts can be declared to be prohibited by an Order in Council under section 74A.

Example:

A shotgun with a 5 shot tubular magazine is not a prohibited firearm. A 2 shot extender by itself is not a prohibited magazine or part.

IF you possess a shotgun with a 5 shot tubular magazine AND an extender for it then:

- the shotgun becomes a prohibited firearm, since the extender will allow the shotgun to hold more than 5 rounds, AND
- the 2 shot extender is a prohibited part, since it is designed and intended to be used with a
- prohibited firearm.

Communications

Phone script

Scripts are already in place and the team are well versed with the approach to take when talking to E-Cat licence holders that have notified, or not. The team make sure that they have NIA and SAP up so they can use that as a reference when talking with the people and can view real time SAP entry with them.

Extra points:

Once the caller has confirmed who they are speaking to, we recommend going straight into the following:

- The Amnesty and Buy-back finishes in just **XX** days' time. Do you have a few minutes for me to go through the process you need to complete before the 20th December?
- When do you plan to hand in your firearm? I can provide you with information on hand in options nearby. [We are trying to be as helpful as possible to make the process easy].
- OR: You have indicated you want to apply for a P endorsement? Your application must be in before 20 December 2019. This is really important that you are in the system as you will be protected under amnesty while awaiting processing. If not, despite your intention to apply, you will be illegally in possession of a prohibited firearm. Can I help you with this process?

Email 1 - has handed in an E Cat (but think they have another)

Hello,

As a current or former holder of a New Zealand firearms licence you should be aware of new legislation amending our firearms laws which came into effect on 12 April 2019.

New Zealand Police want to do all they can to make sure you are properly informed of the various changes to the law. Together with our communities, we are committed to making New Zealand the safest country. Your support in removing newly prohibited firearms from circulation is one of the ways we can achieve this.

The most significant change is the prohibition of most semi-automatic firearms, some parts, and largecapacity magazines. If you are unsure whether the legislation impacts you, please do read the information below to find out more about the amnesty and buy-back process.

Amnesty period

There is now an amnesty in place for six months until 20 December 2019. The purpose of the amnesty is to provide you with reasonable time to notify Police that you possess prohibited items and to take part in the buy-back process (if you are eligible). If you have not already done so, visit this page on the Police website: www.police.govt.nz/advice/firearms-and-safety/changes-firearms-law-prohibited-firearms/completingupdating-firearms

Please check the Police website which has comprehensive information on newly prohibited firearms, parts, accessories and ammunition.

The amnesty period does not allow you to use prohibited firearms. It does allow time for you to hand in prohibited firearms even if you no longer hold a valid licence. You may also hand in a non-prohibited firearm if you no longer wish to have it in your possession.

This period of time is also to enable some people to apply for an exemption to possess prohibited items (e.g. Dealers, Collectors and people involved in wild animal and animal pest control). There is also an opportunity for some firearms to be listed as heirloom or unique. The online notification form enables people to show an intent to apply for such an exemption.

The buy-back process

The buy-back process applies to newly prohibited firearms held by people with a valid firearms licence. You may also hand in parts and accessories for buy-back without holding a firearms licence.

The buy-back offer is available until 20 Dec 2019.

A base price list has been developed which reflects a value for firearms in the New Zealand market just prior to March 2019, i.e. what you might spend to replace a firearm of any type. A three-tier grading system - based on the condition of the firearm - will be applied to compensate owners of prohibited firearms fairly. The grading criteria is:

- New or near-new condition, with little to no use. 95% of base price list.
- Used condition, has seen superficial wear and tear that does not impact the firearm's safe and comfortable operation. Well maintained. 70% of base price list.
- Poor condition, inoperable or unsafe working condition, work would be needed to restore the firearm to a safe level of operation. 25% of base price list.

A buy-back price list has been independently developed in consultation with firearms and industry specialists. The full list of firearms and parts available for buy-back are listed here {link to price book}. If your firearm is not listed on this price list, please note that we will be reviewing the list and updating where appropriate.

You are encouraged to review the price list for the value of your item/s and then <u>notify Police online</u> of your intention to participate in the buy-back process, if you have not already registered your intention to do so. Registering online will speed up the process when handing in your firearm/s at a community collection event or other hand in option.

Modifications

Modification is voluntary. Some prohibited firearms may be modified to comply with the new law. Examples are some non-detachable tubular magazines that may be modified down to the newly accepted maximum capacity of 5 cartridges. If you are unsure if your firearm can be modified, we encourage you to seek advice from an approved gunsmith or dealer. Then notify Police online of your intention to modify the firearm. Modification with a legitimate gunsmith is required during the sixmonth buy-back period.

Community collection events

Community collection events will be held around New Zealand, starting from 12 July 2019. This is an opportunity for you to hand in your firearm/s or parts for buy-back or amnesty. If you have small arms ammunition which is now prohibited we can safely dispose of this, however, please do not bring any high explosive ammunition to the collection point. If you have high explosive ammunition which you need to dispose of, please call 105.

A full list of community collection events in your area and further information about the process will continue to be updated on the <u>Police website</u>.

Things to bring with you when attending a community collection event:

- Your reference number from the Police online notification form
- Your firearms licence
- Your bank account number
- Photo identification (drivers licence or passport)
- All your prohibited firearms and parts, cleared of all ammunition
- Any other firearm/s or parts you wish to hand-in to Police for destruction.

Other options for hand in

If you are unable to attend a community collection event, you may hand in your firearm/s to an approved retailer or dealer from August. Additionally, Police can arrange for bulk pick-ups if you have more than 10 items. If no other option is available to you or you may be able to hand in at a Police station if they have storage facilities.

If these changes are causing anxiety or stress for you, think about getting support by calling or texting 1737 anytime, 24 hours a day, 7 days a week to talk it through with a trained counsellor <u>1737.org.nz</u>
