Please find attached the requested data. This information has been identified from a search of the companies register and the New Zealand Business Number (NZBN) Register on 2 February 2024 using the above BIC codes.

The caveats and limitations of the information are set out below.

1. Only the companies, partnerships and sole traders which have provided their BIC code are included in the list. Where an entity elects to provide a BIC code, they select the code that best describes the entity's business.
2. Entities which have provided their BIC code but have elected to make their BIC code private are excluded from the list.
3. Entities with more than one BIC code appear more than once on the spreadsheet.
4. Only information which is publicly available on the companies register and NZBN register is included in the files.

Some information has been withheld under section 9(2)(a) of the Act to protect the privacy of natural persons. I do not consider that the withholding of this information is outweighed by public interest considerations in making the information available.
