Thank you for your email on 19 February 2024, asking Health New Zealand | Te Whatu Ora for the following under the Official Information Act 1982 (the Act):

"Can you please provide me with the cost associated with the rebranding of Health New Zealand (Te Whatu Ora) from Te Whatu Ora (Health New Zealand).

I would like a total cost, and then a breakdown of costs by item (labour, design, stationary) if possible."

Response

The change we made was to align with the Government's expectation for agencies to have their primary name in English. We are now formally known as Health New Zealand | Te Whatu Ora, or Health NZ in subsequent references. The formal name honours our gifted Māori name, and its important mauri and symbolism of weaving people, knowledge and organisations together to deliver better health outcomes for New Zealanders.

Electronic templates, websites and social media channels are being updated. To avoid significant cost, most other parts of our visual identity will be considered as they naturally come up for replacement or renewal.

The following document has been identified within the scope of your request "Health NZ Name Change" and a copy of the document is attached. Some information has been withheld under section 9(2)(a) of the Act to protect the privacy of an individual and section 9(2)(b)(ii) due to commercial sensitivity. I have considered the countervailing public interest in release in making this decision and consider that it does not outweigh the need to withhold at this time.
