I am writing with reference to your request to the CAA under the Official Information Act for the following information. (CAA Reference number **24/OIR/255**)

I would like to request any and all information, including civilian and military reports, reports to any and all government ministers, and any and all information shared between other government agencies and the CAA, including correspondence, relating to unidentified aircraft in Hawkes bay New Zealand airspace since June 29, 2019.

## CAA Response

Please find enclosed with this letter the reports CAA has of unidentified aircraft in the Hawkes Bay area. The location in the report was determined by searching for reports where the nearest reporting point (NRP) was Napier Airport or Hastings Airfield. There is no other information within scope of your request.

Please note that reports of unidentified RPAS (drones) have not been included in the scope of your request.
