## **Request for information 2024-091**

I refer to your request for information dated 10 April 2024, which was received by Greater Wellington Regional Council (Greater Wellington) on 29 April 2024 via Hutt City Council. You have requested the following:

"Please provide all information relating to the pest control operation described on Facebook as follows: Awareness Post for those who frequently use these areas. If not aware or didn't see sign posted regarding Hunting Cull Operation Happening Now 20/03/24 -12/04/24 Location: Wainuiomata Area across ECNZ Road & Firebreaks Waiu Park &Trail & MTB Park & Surrounding Areas It is near completion but still wanted to let the community and frequent users know. Map is approximate area coverage. If you need more info contact HCC 04 5706666 Please ensure that you provide all geographic information relating to the operation. Please provide all publicity relating to the operation and all communications with affected or neighbouring landowners."
