Answer:

The first phase of RUS provided a broadband internet service to an area by extending existing networks. Those still without coverage after this phase, could apply to receive a one-off grant of up to \$2,000 towards set up and installation costs of a suitable broadband solution if eligible.

Applications for the one-off grant were as follows:

CIP partnered with 3 Wireless Internet Service Providers (WISPs) to extend their terrestrial coverage and supply connectivity to 168 households.
