OIA: 1328103 - Spend on gifted and talented education

Thank you for your email of 6 May 2024 to the Ministry of Education (the Ministry) requesting the following information:

Can you please tell me how much was spent on gifted and talented education in New Zealand last year and how much are you spending this year?

Your request has been considered under the Official Information Act 1982 (the Act).

As advised in our letter to you on 4 June 2024, **part one** of your request has been refused under section 18(d) of the Act, as the 2022-2023 spend was published in an Official Information Response on the Ministry's website on 12 December 2023 and is therefore publicly available. The response is titled "Information in relation to Priority Five, Learning Support Action Plan".
